Headline Data – August 2024

Child Protection & Welfare

- **6,879 referrals** in August 2024, 415 (6%) fewer than July 2024 (7,294) and 204 (3%) fewer than August 2023 (7,083). This brings to **61,981 the number of referrals for the first eight months of 2024**, 800 (1%) more than the same period in 2023 (61,181).
- **20,111 cases open to social work** at the end of August 2024, 584 (3%) fewer than July 2024 (20,695) and 1,427 (7%) fewer than August 2023 (21,538). *Open cases include child protection and welfare cases including children in care.*
- 78% (15,692) of cases open to social work at the end of August 2024 had an allocated worker, no change from July 2024. (Ref note on Page 4).
- **4,419 cases awaiting allocation** at the end of August 2024, 203 (4%) fewer than July 2024 (4,622). Third consecutive monthly decrease. Cases awaiting allocation are down 668 (13%) from August 2023 (5,087).
- Six areas account for 66% (2,908) of cases awaiting allocation: Dublin South Central (1,070), Dublin South West/Kildare/West Wicklow (431), Louth/Meath (413), Cork (375), Midwest (318) and Dublin South East/Wicklow (301).
- **12% (514) of cases awaiting allocation at the end of August 2024 were categorised as high priority**, 23 (5%) more than July 2024 (491) and 114 (29%) more than August 2023 (400).

Children in Care

- **5**,7**59 children (0-17 years) in care at the end of August 2024**, **44** (<**1%) fewer than July 2024 (5,803).** Figure includes 115 children under the Service for Separated Children Seeking International Protection (SCSIP).
- 87.5% (5,040)* of all children in care (17 Areas and SCSIP) are in foster care (3,584 general foster care, and 1,456 relative foster), 8.7% (500) are in residential care (486 general residential care and 14 special care) and 3.8% (219) are in "other" care placements.
- Across Tusla's 17 areas 89% (5,016/5,644) of children in care are in foster care.
- **963 (17%) children in care at the end of August 2024 were in placements with private providers,** 8 (<1%) fewer than July 2024 (971) and the first decrease after four consecutive monthly increases.
- **82% (4,750)** of children in care at the end of August 2024 had **an allocated worker** with three areas reporting 100%. A total of 1,009 children were awaiting allocation, 84 (8%) fewer than July 2024 (1,093).
- 85% (4,921) of children in care at the end of August 2024 had an up-to-date care plan. A total of 838 children were awaiting an up-to-date care plan, 43 (5%) fewer than July 2024 (881).

*Decrease from previous months in the overall percentage of children in care in foster care is due to the inclusion of SCSIP as the majority of these children are placed in residential care.

Child Protection Notification System (CPNS)

- **1,060 children listed as "active"** on the Child Protection Notification System (CPNS) at the end of August 2024, 21 (2%) fewer than July 2024 (1,081).
- There were 133 (14%) more children "active" at the end of August 2024 than at the end of August 2023 (927).
- All children listed as "active" at the end of August 2024 had an **allocated social** worker.

Children's Services Regulation

- **4,028 early years services on the register at the end of August 2024**, 20 (<1%) more than July 2024 (4,008) and 5 (<1%) fewer than August 2023 (4,033).
- **144 inspections** of early years services in August 2024. This brings to 1,470 the number of inspections for the first eight months of 2024, 89 (6%) fewer than the same period in 2023 (1,559).
- 2,180 children on the register for home education at the end of August 2024.
- **852 children on a waiting list for assessment** at the end of August 2024, 7 (<1%) more than July 2024 (845) and 484 (36%) fewer than August 2023 (1,336).

Tusla Education Support Services

- **188 referrals screened** by senior educational welfare services in August 2024. This brings to 8,042 the number of referrals for the academic year 2023-2024, 658 (9%) more than the same period in 2022-2023 (7,384).
- **3,509 referrals on a waiting list** for educational welfare services at the end of August 2024, 161 (4%) fewer than July 2024 (3,670).
- 25 (<1%) more referrals on a waiting list at the end of August 2024 (3,509) than at the end of August 2023 (3,484).
- **175 new individual children worked** with in August 2024. This brings to 3,924 the number of new individual children worked with for the academic year 2023-2024, 523 (15%) more than the same period in 2022-2023 (3,401).

Child Protection and Welfare

Referrals¹

- **6,879 referrals** in August 2024, 415 (6%) fewer than July 2024 (7,294) and 204 (3%) fewer than August 2023 (7,083).
- This brings to 61,981 the number of referrals for the first eight months of 2024, 800 (1%) more than the same period in 2023 (61,181).

It should be noted that the data presented for the first three months of 2024 has been updated to reflect final validated figures for this period. Data for Apr-Aug 2024 is based on referrals logged on the Tusla Case Management (TCM) system at the time the data was extracted for reporting. Referrals logged after the date the data was extracted are not included, nor are figures updated until quarterly validation is complete.

Open Cases

• **20,111 cases open to social work** at the end of August 2024, 584 (3%) fewer than July 2024 (20,695) and 1,427 (7%) fewer than August 2023 (21,538). *Open cases from September 2023 include cases awaiting categorisation. See note below.*




- From September 2023, open cases (allocated/unallocated) include cases "awaiting categorisation" at month end. This is in addition to cases categorised as high, medium and low. The category "awaiting categorisation" was introduced this year to reflect better questions being asked at screening and awaiting information for slightly longer.
- 2) Open cases include, all cases held on duty, allocated and unallocated child protection and welfare cases including children in care.
- 3) The data presented on cases is based on the status of cases on the TCM at month end.


Allocated Cases

- **15,692 open cases were allocated** at the end of August 2024, 381 (2%) fewer than July 2024 (16,073) and 759 (5%) fewer than August 2023 (16,451).
- Allocated cases account for 78% of open cases, no change from July 2024.

These numbers of allocated cases reflect a changing environment in Tusla where allocation of cases to a social worker has become more difficult with reduced availability of social workers nationally. Many cases are now allocated to other professionals also reflecting the changing nature of social work teams. In many instances where cases are unallocated to a social worker there is a social care worker or leader allocated to the case.








¹Referrals include referrals meeting the eligibility criteria for child protection and welfare services, multiple reports of the same concern and referrals not meeting the eligibility criteria for child protection and welfare services. Referrals not meeting the eligibility criteria for child protection and welfare include: a request for diversion to another agency; a report in which there are no reasonable grounds for concern or no harm identified to a child indicated; a report that does not warrant a Tusla child protection and welfare led intervention (these could be children who need additional supports to stop problems or difficulties worsening but social work led intervention is not required and diversion to Prevention Partnership and Family Support is considered).




Cases Awaiting Allocation

Cases awaiting allocation include cases held on duty, unallocated child protection and welfare cases including children in care

- **4,419 cases awaiting allocation** at the end of August 2024, 203 (4%) fewer than July 2024 (4,622). Third consecutive monthly decrease.
- Cases awaiting allocation are down 668 (13%) from August 2023 (5,087).
- Cases awaiting allocation account for 22% of open cases (20,111), no change from July 2024,
- **36% (1,591) of cases awaiting allocation at the end of August 2024 were "active on duty".** This means that actions were undertaken by dedicated duty teams or rotating social workers on a duty roster to progress the protection and welfare of the cases. Examples of actions undertaken include telephone calls relating to the concern, visits to see children, completing initial assessments and child in care reviews or care plans.
- Highest number of cases awaiting allocation reported by Dublin South Central (1,070) followed by Dublin South West/Kildare/West Wicklow (431), Louth/Meath (413), Cork (375), Midwest (318) and Dublin South East/Wicklow (301). These six areas account for 66% (2,908) of all cases awaiting allocation.
- **514 cases awaiting allocation at the end of August 2024 were categorised as high priority**, 23 (5%) more than July 2024 (491) and 114 (29%) more than August 2023 (400).
- High priority cases account for 12% of cases awaiting allocation.
- 58% (2,546) of cases awaiting allocation were categorised at medium priority, 29% (1,296) were low priority while the remaining 1% (63) were awaiting categorisation.
- Highest number of high priority cases reported by Midwest (97), Carlow/Kilkenny/South Tipperary (75), Dublin South Central (64), Midlands (54), Louth/Meath (53) and Donegal (47). These six areas account for 76% (390) of all high priority cases awaiting.

Cases Awaiting Allocation

- 13/17 areas reported a decrease in cases awaiting allocation from July 2024.
- Largest decreases reported by Dublin North City (down 45), Dublin North (down 43) and Cork (down 41).
- 4/17 areas reported an increase in cases awaiting allocation from July 2024. Largest increases reported by Louth/Meath (up 14) and Waterford/Wexford (up 12).
- Nationally 22% of open cases were awaiting allocation at the end of August 2024. Seven areas reported a percentage equal to or higher than the national average of 22%. Highest percentages reported by Dublin South Central (49%), Carlow/Kilkenny/South Tipperary (35%), Dublin South East/Wicklow (32%), Dublin South West/Kildare/West Wicklow (29%), Louth/Meath (27%), Midwest (25%) and Donegal (24%).
- 10/17 areas had fewer cases awaiting allocation at the end of August 2024 than at the end of August 2023. Largest decreases reported by Cork (down 427), Waterford/Wexford (down 252) and Dublin South West/Kildare/West Wicklow (down 194).
- 7/17 areas had more cases awaiting allocation at the end of August 2024 than at the end of August 2023. Largest increases reported by Dublin South Central (up 120), Louth/Meath (up 114) and Dublin South East/Wicklow (up 82).

• **1,933 mandated reports of abuse** received in August 2024, 111 (5%) fewer than July 2024 (2,044) and 148 (7%) fewer than August 2024 (2,081). This brings to 19,128 the number of reports for the first eight months of 2024, 180 (1%) more than the same period in 2023 (18,948).



• Mandated reports accounted for 28% (1,933) of all referrals received (6,879) in August 2024.



- Highest number of reports for August 2024 from An Garda Síochána (890; 46%) followed safeguarding officer (289; 15%); social workers (205; 11%), social care workers (108; 6%), managers of domestic violence shelters (89; 5%) and medical practitioners (69; 4%). These six sources account for 85%% (1,650) of reports for August 2024.
- Highest number of reports for 2024 YTD from An Garda Síochána (7,416; 39% followed by safeguarding officers (2,548; 13%), teachers (2,391; 13%), social workers (2,207; 12%), social care workers (893; 5%) and medical practitioners (677; 4%). These six sources account for 84% (16,132) of reports for 2024 YTD.

- Residential care includes 14 children in special care. Of the children in foster care (5,040), 71% (3,584) were in general foster care and 29% (1,456) were in relative foster care.
- Highest number of children in care reported by Cork (677) followed by Midwest (499) and Dublin North City (464).
- Fewest number reported by the Service for Separated Children Seeking International Protection (115) followed by Sligo/Leitrim West Cavan (116) and Mayo (144).
- Across the 17 Areas the highest rate of children in care per 1,000 children was reported by Dublin North City (9.3) followed by Waterford/Wexford (6.2).
- Lowest rate reported by Dublin South East/Wicklow (2.2) followed by Dublin South West/Kildare/West Wicklow (3.7).
- Nine areas reported a percentage equal to or higher than the national average of 4.6/1,000 children.




Children in Care

963 (17%) children in care at the end of August 2024 were in placements with private providers, 8 (<1%) fewer than July 2024 (971). First decrease after four consecutive monthly increases.

- **553 (57%)** children in placements with private providers were in **foster care**, **5** (<1%) fewer than July 2024 (558). First decrease after four consecutive monthly increases.
- 333 (35%) children were in **residential care**, 6 (2%) fewer than July 2024 (339). First decrease after three consecutive increases.
- The remaining 77 (8%) children were in "**Other**" **care placements**, three more than July 2024 (74). "Other" care placements include, disability units, mental health units, drug and alcohol rehabilitation centres etc.
- Highest number of children in placements with private providers reported by Dublin North City (122) followed by Dublin North (116), Dublin South West/Kildare/West Wicklow (111), Dublin South Central (109), and Midlands (84). These five areas account for 56% (542) of children in placements with private providers.

Children in Care

82% (4,750) of children in care at the end of August 2024 had an allocated worker with three areas reporting 100% (Donegal, Mayo and Galway/Roscommon), up one percentage point from July 2024 (81%).

These numbers of allocated cases reflect a changing environment in Tusla where allocation of cases to a social worker has become more difficult with reduced availability of social workers nationally. Many cases are now allocated to other professionals also reflecting the changing nature of social work teams. In many instances where cases are unallocated to a social worker there is a social care worker or leader allocated to the case.

- A total of 1,009 children were awaiting allocation, 84 (8%) fewer than July 2024 (1,093).
- Highest number awaiting allocation reported by Midwest (228; 46%) followed by Carlow/Kilkenny/South Tipperary (202; 66%), Dublin South West/Kildare/West Wicklow (142; 36%), Dublin South Central (83; 26%) and Louth/Meath (73; 17%). These five services account for 72% (728) of all cases awaiting allocation.

- 85% (4,921) of children in care at the end of August 2024 had an up-to-date care plan, no change from July 2024.
- A total of 838 children were awaiting an up-to-date care plan, 43 (5%) fewer than July 2024 (881).
- Highest numbers awaiting an up-to-date care plan reported by Dublin North City (127; 27%), Midwest (106; 21%), Dublin South Central (89; 27%) and Louth/Meath (83; 20%).

Note:

Tusla has moved to reporting on children in care with an up-to-date care plan and not just children having a care plan, hence this data is not comparable with data previously reported. An up-to-date care plan is a care plan that has been updated following a statutory child in care review.



Child Protection Notification System

- **1,060 children listed as "active"** on the Child Protection Notification System (CPNS) at the end of August 2024, 21 (2%) fewer than July 2024 (1,081).
- There were 133 (14%) more children "active" at the end of August 2024 than at the end of August 2023 (927).
- All children listed as "active" at the end of August 2024 had an **allocated social worker**.
- Highest number of children listed as "active" at the end of August 2024 was reported by Midwest (142) followed by Dublin South West/Kildare/West Wicklow (126), Cork (107) and Dublin North City (105).
- Fewest number listed as "active" reported by Mayo (20) followed by Cavan/Monaghan (21) and Sligo/Leitrim/West Cavan (21).
- The number of children "active" equates to about 9 children per 10,000 under 18 years.
- Highest rate per 10,000 population under 18 years reported by Dublin North City (21.1) followed by Midwest (14.7), Midlands (12.0) and Dublin South West/Kildare/West Wicklow (11.6).
- Lowest rates reported by Dublin South East/Wicklow (3.2), Waterford/Wexford (3.8) and Dublin North (5.2).
- Seven areas reported a rate equal to or higher than the national rate of 8.7/10,000
- 5/17 areas had more children listed as "active" at the end of August 2024 than at the end of July 2024. Largest increases reported by Midlands (up 6) and Mayo (up 3).
- 8/17 areas reported a decrease with the largest decreases reported by Dublin North (down 11), Waterford/Wexford (down 6) and Dublin North City (down 5). The remaining four areas, Midwest, Cavan/Monaghan, Galway/Roscommon and Dublin South East/Wicklow reported no change.
- 12/17 areas had more children active at the end of August 2024 than at the end of August 2023. Largest increases reported by Midwest (up 84), Louth/Meath (up 37) and Midlands (up 34).
- 5/17 areas reported a decrease. Largest decreases reported by Dublin North (down 49), Waterford/Wexford (down 32) and Donegal (down 18).






