# **Headline Data – January 2022**

### **Child Protection & Welfare**

- 21,830 cases open to social work at the end of January 2022.
- 79% (17,250) of cases open to social work had an allocated social worker.
- 4,580 (21%) cases awaiting allocation of a social worker, 227 (5%) fewer than December 2021 (4,807).
- Six areas account for 63% (2,902) of cases awaiting allocation: Louth/Meath (590) followed by Waterford/Wexford (547), Dublin South West/Kildare/West Wicklow (536), Dublin South Central (434), Cork (399) and Dublin South East/Wicklow (396).
- 8% (380) of cases awaiting allocation at the end of January 2022 were categorised as high priority, 56 (13%) fewer than December (436).

Cases awaiting allocation include cases held on duty, unallocated child protection and welfare cases including children in care.

## **Cases of Retrospective Abuse**

- 1,609 cases of retrospective abuse open to social work at the end of January 2022.
- 59% (957) of cases of retrospective abuse open to social work had an allocated social worker.
- 652 (41%) cases were awaiting allocation to a social worker, 23 (3%) fewer than December 2021 (675) and January 2021 (675).
- Four areas account for almost half (48%; 313) of all cases awaiting allocation: Waterford/Wexford (111), Galway/Roscommon (73), Midwest (66) and Dublin North City (63). Two areas (Mayo and Kerry) have no cases awaiting allocation.

## **Children in Care**

- 5,850 children in care at the end of January 2022; 13 fewer than December 2021 (5,863)
- 798 (14%) children in care at the end of January 2022 were in placements with private providers; 13 (2%) more than December 2021 (785 revised figure).
- 88% (5,171) of children in care at the end of January 2022 had an allocated social worker; no change from December 2021.
- A total of 679 children were awaiting an allocated social worker; 45 (6%) fewer than December 2021 (724 revised figure).

## **Child Protection Notification System (CPNS)**

- 966 children listed as "active" at the end of January 2022; 17 (2%) fewer than December 2021 (983), first decrease after two consecutive increases. There were 32 (3%) more children "active" at the end of January 2022 than January 2020 (934).
- · All children listed as "active" at the end of January 2022 had an allocated social worker.

## **Children's Services Regulation**

- 4,128 early years services on the register at the end of January 2022, five fewer than December 2021 (4,133). There were 78 (2%) fewer services on the register at the end of January 2022 than January 2021 (4,206).
- 196 inspections of early years services done in January 2022, 70 (56%) more than December 2021 (126).
- 1,837 children on the register for home education at the end of January 2022, 29 more than December 2021 (1,808) and the highest number for the period Jan-2021 to Jan-2022. The number of children on the register is up 8% (143) on January 2021 (1,694).
- 1,940 children on a waiting list for assessment at the end of January 2022, 18 more than December 2021 (1,922). The number of children on the waiting list is up 35% (505) on January 2021 (1,435).

## **Tusla Education Support Services**

Service activity for 2020/2021 impacted by the closure of schools (Covid-19)

- 527 referrals screened by senior educational welfare services in January 2022, eight fewer than December 2021 (535) and 57 more than January 2021 (470). Brings to 2,341 the number of referrals screened for the five months Sept 2021 Jan 2022, 404 (15%) fewer than Sept 2020 Jan 2021 (2,745).
- 1,925 referrals on a waiting list for educational welfare services at the end of January 2022, 15 more than December 2021 (1,910) and 16 more than January 2021 (1,909).
- 413 new individual children worked with in January 2022, 169 (69%) more than December 2021 (244) and 219 (113%) more than January 2021 (194).

## **Child Protection and Welfare**

### Referrals<sup>1</sup>

• **6,589 referrals** in January 2022, 681 (12%) more than December 2021 (5,908) and 1,658 (34%) more than January 2021 (4,931).

It should be noted that the data presented for each month is based on referrals logged on NCCIS at the time is extracted for reporting. Referrals logged after the date the data is extracted are not included, nor are figures updated retrospectively. Hence it is likely that the actual number of referrals for each of the months shown may be slightly higher.

## **Open Cases**

The data on cases presented below is based on the status of cases on the National Child Care Information System (NCCIS) at month end.

Data for May and June 2021 is not available due to the impact of the cyber attack. The data on open cases is based on the time actions are recorded on NCCIS, hence data during the period when the system was not available is not meaningful (pages 4-7).

- 21,830 cases open to social work at the end of January 2022, 582 (3%) more than December 2021 (21,248). Note: open cases include, all cases held on duty, allocated and unallocated child protection and welfare cases including children in care
- Open cases are up 1,864 (9%) on January 2021 (19,966).


## **Allocated Cases**

- 17,250 open cases allocated to a social worker at the end of January 2022, 809 (5%) more than December 2021 (16,441). Allocated cases are up 1,061 (7%) from January 2021 (16,189)
- Allocated cases account for 79% of open cases, up two percentage points from December 2021 (77%).


### # Referrals

### **Number of Allocated Cases**




# **Child Protection & Welfare**

## **Cases Awaiting Allocation of a Social Worker**


Cases awaiting allocation include cases held on duty, unallocated child protection and welfare cases including children in care

- **4,580 cases awaiting allocation of a social worker** at the end of January 2022, 227 (5%) fewer than December 2021 (4,807).
- Cases awaiting allocation are up 21% (803) from January 2021 (3,777).
- Cases awaiting allocation account for 21% of open cases (21,830), down two percentage points from December 2021 (23%).
- 61% (2,796) of cases awaiting allocation at the end of January 2022 were "active on duty". This means that actions were undertaken by dedicated duty teams or rotating social workers on a duty roster to progress the protection and welfare of the cases. Examples of actions undertaken include telephone calls relating to the concern, visits to see children, completing initial assessments and child in care reviews or care plans.
- Highest number of cases awaiting allocation reported by Louth/Meath (590) followed by Waterford/Wexford (547), Dublin South West/Kildare/West Wicklow (536), Dublin South Central (434), Cork (399) and Dublin South East/Wicklow (396).
- These six areas account for 63% (2.902) of cases awaiting allocation.
- 380 cases awaiting allocation at the end of January 2022 were categorised as high priority, 56 (13%) fewer than December (436). High priority cases are up 57 (18%) from January 2021 (323).
- High priority cases account for 8% of cases awaiting allocation.
- 54% (2,474) of cases awaiting allocation were categorised at medium priority while the remaining 38% (1,726) were low priority.
- Highest number of high priority cases reported by Louth/Meath (62) followed by Waterford/Wexford (44), Donegal (37), Cork (34), Dublin South West/Kildare/West Wicklow (30), Dublin North (29) and Dublin North City (28). These seven areas account for 69% (264) of all high priority cases awaiting.


### Number of Unallocated Cases

# **Child Protection & Welfare**

## **Cases Awaiting Allocation**

- 10 areas reported a decrease in unallocated cases from December 2021.
- Largest decrease reported by Dublin South East/Wicklow (down 90) followed by Midlands (down 74), Cork (down 72), Dublin South Central (down 59) and Waterford/Wexford (down 51). Largest increase reported by Louth Meath (up 96) followed by Kerry (up 49) and Cavan/Monaghan (up 27).
- All but four areas (Dublin North, Midwest, Dublin South Central and Kerry)
  had more cases awaiting allocation at the end of January 2022 than at the
  same time last year.
- Largest increases reported by Louth/Meath (up 407), Waterford/Wexford (up 257), Dublin South east/Wicklow (up 215), Cork (up 162) and Dublin North City (up 116).

- Largest decreases reported by Dublin North (down 390) followed by Midwest (down 126), Dublin South Central (down 114) and Kerry (down 46).
- Nationally 21% of open cases were unallocated at the end of January 2022. Seven areas reported a percentage equal to or higher than the national average of 21%. Highest percentage (37%) reported by Louth/Meath followed by Dublin South West/Kildare/West Wicklow (32%), Dublin South East/Wicklow (32%), Dublin South Central (31%), Waterford/Wexford (31%), Donegal (30%) and Carlow/Kilkenny/South Tipperary (26%).


### Referrals

• **318 referrals of retrospective abuse** in January 2022, 44 (16%) more than December 2021 (274) and 83 (35%) more than January 2021 (235).

Data presented on retrospective cases of abuse (pages 8-10) for May and June 2021 is based on 15 areas. Data for Donegal and Sligo/Leitrim/West Cavan not available due to the impact of the cyber-attack.

## **Open Cases**

• 1,609 cases open to social work at the end of January 2022, 41 more than December 2021 (1,568) and 177 (12%) more than January 2021 (1,432).



### **Allocated Cases**

- **957 cases allocated to a social worker** at the end of January 2022, 64 (7%) more than December 2021 (893) and 200 (26%) more than January 2021 (757).
- Allocated cases account for 59% of open cases, up two percentage points from the end of December 2021 (57%).




## **Cases Awaiting Allocation of a Social Worker**

- **652 cases awaiting allocation** at the end of January 2022, 23 (3%) fewer than December 2021 (675) and January 2021 (675).
- Cases awaiting allocation account for 41% of open cases, down from 43% at the end of December 2021.
- Highest number of cases awaiting in Waterford/Wexford (111) followed by Galway/Roscommon (73), Midwest (66) and Dublin North City (63). These four areas account for almost half (48%; 313) of cases awaiting allocation. Two areas (Mayo & Kerry) have no cases awaiting allocation.



- 41 high priority cases awaiting allocation at the end of January 2022, 10 (32%) more than December 2021 (31) and nine (18%) fewer than January 2021 (50).
- High priority cases accounted for 6% of cases awaiting allocation at the end of January 2022 (652).
- High priority cases are reported by six areas with the highest numbers reported by Midwest (15) followed by Donegal (10) and Dublin North City (7).

## **Unallocated Cases by Priority Level**



- **8 areas reported an increase** in cases awaiting allocation from December 2022. Largest increase reported by Waterford/Wexford (up 15) followed by Midwest (up 12) Dublin North (up 6) and Donegal (up 6).
- **8 areas reported an decrease** with the largest decrease reported by Galway/Roscommon (down 23) followed by Cork (down 20), Kerry (down 8) and Midlands (down 7).
- The remaining area (Mayo) reported no change.
- 41% (652) of open cases are awaiting allocation nationally, with nine areas reporting a percentage equal to or higher than the national average. Highest percentages reported by Galway/Roscommon (72%), Dublin South Central (69%), Donegal (68%), Midlands (57%), Dublin South East/Wicklow (56%) and Waterford / Wexford (50%).
- 7 areas had more cases awaiting allocation at the end of January 2022 than January 2021, while eight areas had fewer cases. Two areas (Mayo and Kerry) had no cases awaiting allocation at the end of either month. Largest increases reported by Dublin Nort City (up 36), Midlands (up 35), Dublin South East/Wicklow (34) and Midwest (33). Largest decreases reported by Carlow/Kilkenny/South Tipperary (down 95), Dublin South West / Kildare / West Wicklow (down 32), Dublin South Central (down 22) and Dublin North (down 13).


# Mandated Reports<sup>1</sup> – Child Protection & Welfare


- 1,747 mandated reports of abuse received in January 2022, 275 (19%) more than December 2021 (1,472). It should be noted that the data presented is based on mandated reports logged on NCCIS at the time is extracted for reporting. Referrals logged after the date the data is extracted are not included, nor are figures updated retrospectively. Hence it is likely that the actual number of referrals for each of the months shown may be slightly higher.
- Mandated reports accounted for 27% (1,747) of all referrals received (6,589) in January 2022.



- The number of mandated reports for January 2022, by area ranged from 34 (Mayo) to 230 (Cork).
- As a percentage of referrals, the highest percentage (47%) was reported by Dublin North City followed by Dublin North (40%), SLWC (38%) and Cork (35%).
- The lowest percentage was reported by Midwest (10%) followed by Waterford/Wexford (14%) and Dublin South West/Kildare/West Wicklow (15%).

## **Source of Reports**

• Highest number of reports for January 2022 from An Garda Síochána (732; 42%) followed by teachers (287; 16%), social workers (238; 14%), social care workers (94; 5%), safe guarding officers (76; 4%), managers of domestic violence shelters (74; 4%) and medical practitioners (66; 4%). These seven sources account for 90% (1,567) of reports for January 2022.




# **Mandated Reports<sup>1</sup> – Retrospective Abuse**

- The majority (89%; 273) of mandated reports for January 2022 were for sexual abuse.






# **Children in Care**

- 5,850 children in care at the end of January 2022; 13 fewer than December 2021 (5,863)
- 22 fewer children in care than the same time last year (5,872).
- 64% (3,758) of children in care are in general foster care, 26% (1,509) are in relative foster care, 8% (450) are in residential care and 2% (133) are in "other" care placements.
- 17 (4%) of the 450 children in residential placements are in special care



- Highest number of children in care reported by Cork (746) followed by Midwest (548) and Dublin North City (469).
- Fewest number reported by the Social Work Team for Separated Children Seeking International Protection (83) followed by Sligo/Leitrim West Cavan (106) and Mayo (145).
- Highest rate of children in care per 1,000 children was reported by Dublin North City (10.4/1,000) followed by Waterford/Wexford (6.2/1,000) and Midwest (5.7/1,000). Lowest rate reported by Dublin South East/Wicklow (2.5/1,000) followed by Dublin North (3.4/1,000) and Dublin South West/Kildare/West Wicklow (3.9/1,000).
- Seven areas reported a percentage equal to or higher than the national average of 4.8/1,000 children.


# **Children in Care**

• 798 (14%) children in care at the end of January 2022 were in placements with private providers; 13 (2%) more than December 2021 (785 revised figure).

• There were 72 (10%) more children in care in placements with private providers at the end of January 2022 than at the end of January 2021 (726).



### Children in Private Placements, by Placement Type




# **Children in Care**

- 88% (5,171) of children in care at the end of January 2022 had an allocated social worker; no change from December 2021.
- A total of 679 children were awaiting an allocated social worker; 45 (6%) fewer than December 2021 (724 revised figure).
- Highest number awaiting reported by Waterford/Wexford (129) followed by Carlow/Kilkenny/South Tipperary (89), Louth/Meath (68), Midwest (66), Cork (62) and Dublin North (59). These five areas account for 70% (473) of all cases awaiting allocation.


- 97% (5,701) of children in care at the end of January 2022 had an up-to-date care plan; no change from December 2021.
- A total of 149 children did not have an up-to-date care plan; 55 (27%) fewer than December 2021 (204 revised figure).
- Highest numbers with no up-to-date care plan reported by Louth/Meath
  (27), Dublin North City (21), Dublin South West/Kildare/West Wicklow (19)
  and Dublin South Central (18).

It should be noted that variances have been identified in how data on this metric are being reported by areas. In some areas care plans that have fallen due for review and not updated are included. Also, it should be noted that where a care plan is not up—to-date, the care plan in place (albeit that it is awaiting review) is used to support the care of the child.

# **Child Protection Notification System**

- 966 children listed as "active" at the end of January 2022; 17 (2%) fewer than December 2021 (983), first decrease after two consecutive increases. There were 32 (3%) more children "active" at the end of January 2022 than January 2020 (934).
- All children listed as "active" at the end of January 2022 had an allocated social worker.

- Highest number of children listed as "active" at the end of January 2022 reported by Cork (86) followed by Dublin North City (79), Midwest (76), Dublin South West/Kildare/West Wicklow (75), Midlands (74) and Dublin North (74).
- Fewest number listed as "active" reported by Sligo/Leitrim/West Cavan (15) followed by Louth/Meath (32), Kerry (32) and Mayo (32).
- Highest rate per 10,000 population under 18 years reported by Dublin North City (17.6/10,000) followed by Donegal (13.5/10,000) and Carlow/Kilkenny/South Tipperary (11.6/10,000).
- Lowest rates reported by Louth/Meath (3.4/10,000), Galway/Roscommon (5.1/10,000), Sligo/Leitrim/West Cavan (6.4/10,000) and Cork (6.4/10,000). Nine areas reported a rate equal to or higher than the national rate of 8.1/10,000
- 7/17 areas had more children listed as "active" at the end of January 2022 than December 2021. Largest increases reported by Dublin South West/Kildare/West Wicklow (up 6), Dublin South Central (up 6) and Sligo/Leitrim/West Cavan (up 6). Largest decrease reported by Cork (down 10) followed by Midlands (down 7), Midwest (down 7) and Dublin North (down 6).
- 9 areas had more children active at the end of January 2022 than at the same period last year. Largest increases reported by Cavan/Monaghan (up 24), Midlands (up 15) and Louth/Meath (up 13). Largest decrease reported by Waterford/Wexford (down 19), Dublin South West/Kildare/West Wicklow (down 12) and Kerry (down 11).

### # Children "Active" on the CPNS








## **ALTERNATIVE EDUCATION ASSESSMENT AND REGISTRATION SERVICE**




