Headline Data – June 2021

Child Protection & Welfare

Data for May and June 2021 is not available due to the impact of the cyber attack. The data on open cases is based on the time actions are recorded on NCCIS, hence data during the period when the system was not available is not meaningful.

- 82% (16,175) of cases open to social work (19,752) had an allocated social worker at the end of April 2021
- 3,577 cases awaiting allocation of a social worker at the end of April 2021, 211 (6%) more than March 2021 (3,366). Second consecutive monthly increase.
- Cases awaiting allocation are down 17% (714) from April 2020 (4,291) and 16% (662) from December 2020 (4,239).
- Six areas account for 62% (2,235) of cases awaiting allocation: Dublin South Central (548) followed by Dublin North (476), Dublin South West/Kildare/West Wicklow (326), Midwest (301), Waterford/Wexford (293) and Louth/Meath (291).
- 10% (342) of cases awaiting allocation at the end of April 2021 were categorised as high priority, 11 fewer than March 2021 (353). High priority cases are down 34 (9%) from December 2020 (376).

Cases awaiting allocation include cases held on duty, unallocated child protection and welfare cases including children in care

Cases of Retrospective Abuse

- 61% (784) of cases of retrospective abuse open to social work (1,276) had an allocated social worker at the end of June 2021 (based on data from 15 areas).
- 492 cases were awaiting allocation to a social worker, 54 (12%) more than May 2021 (438) (based on data from 15 areas). There were 547 cases awaiting at the end of June 2021 and 642 at the end of December 2020.
- Four areas account for 59% (288) of cases awaiting allocation: Cork (90) followed Waterford/Wexford (74), DSW/K/WW (68) and Galway/Roscommon (56). Two areas (Cavan/Monaghan, Mayo) have no cases awaiting allocation.

Children in Care

- 5,851 children in care at the end of June 2021; 24 fewer than May 2021 (5,875) and 106 fewer children in care than the same time last year (5,957).
- 750 (13%) children in care at the end of June 2021 were in placements with private providers; two fewer than May 2021 (752) and 30 (4%) more than at the end of June 2020 (720).
- 89% (5,233) of children in care at the end of June 2021 had an allocated social worker; down one percentage point from May 2021. 618 children were awaiting an allocated social worker, 33 more than May 2021 (585) and 219 (55%) more than Dec 2020 (399).

Child Protection Notification System

- 889 children listed as "active" at the end of June 2021; 57 fewer than May 2021 (946) and the fewest number since March 2020 (827). There were 100 fewer children "active" at the end of June 2021 than June 2020 (957).
- All children listed as "active" at the end of June 2021 had an allocated social worker.

Children's Services Regulation

- 4,159 early years services on the register at the end of June 2021, 24 fewer than May 2021 (4,183) and the seventh consecutive monthly decrease. There were 117 (3%) fewer services on the register at the end of June 2021 than June 2020 (4,276).
- 281 inspections of early years services done in June 2021. Brings to 1,255 the number of inspections for 2021. Number of inspections impacted, due to the closure of services under the Covid-19 restrictions.
- 1,786 children on the register for home education at the end of June 2021, no change from April 2021. The number of children on the register is up 14% (220) on June 2020 (1,566).
- 1,588 children on a waiting list for assessment at the end of June 2021, 13 (1%) more than May 2021 (1,575) and 153 (11%) more than Dec 2020 (1,435). The increase in numbers awaiting assessment in recent months is due to an increase in applications received over the same period.

Tusla Education Support Services

Service activity impacted by the closure of schools (Covid-19)

- 1,036 referrals screened by senior educational welfare services in June 2021, bringing the number of referrals screened for the 10 months (September June 2021) to 5,398. The number of referrals for the 10 months (September –June) (5,398) is up 1,022 (23%) on the same period in 2019/2020 (4,376).
- 2,458 referrals on a waiting list for educational welfare services at the end of June 2021, 455 (23%) more than May 2021 (2,003), third consecutive monthly increase. The number of referrals on a waiting list is up 1,329 (118%) from June 2020 (2,458).

Child Protection and Welfare

Data for May and June 2021 is not available due to the impact of the cyber attack. The data on open cases is based on the time actions are recorded on NCCIS, hence data during the period when the system was not available is not meaningful (pages 4 -7).

Referrals¹

• **6,300 referrals** in April 2021, 120 (2%) fewer than March 2021 (6,420). Referrals up 31% (1,494) on April 2020 (4,806). Fewer referrals received in April 2020, due to Covid-19 restrictions.

It should be noted that the data presented is based on referrals logged on NCCIS at the time is extracted for reporting. Referrals logged after the date the data is extracted are not included, nor are figures updated retrospectively. Hence it is likely that the actual number of referrals for each of the months shown may be slightly higher.


Open Cases

The data on cases presented below is based on the status of cases on the National Child Care Information System (NCCIS) at month end.


- 19,752 cases open to social work at the end of April 2021, 120 (1%) more than March 2021 (19,632). Note: open cases include, all cases held on duty, allocated and unallocated child protection and welfare cases including children in care
- Open cases are down 12% (2,807) on April 2020 (22,559).


Allocated Cases

- 16,175 open cases allocated to a social worker at the end of April 2021, 91 (1%) fewer than March 2021 (16,266).
- Allocated cases are down 11% (2,093) from April 2020 (18,268)
- Allocated cases account for 82% of open cases.










¹Referrals include referrals meeting the eligibility criteria for child protection and welfare services. Referrals not meeting the eligibility criteria for child protection and welfare services. Referrals not meeting the eligibility criteria for child protection and welfare services. Referrals not meeting the eligibility criteria for child protection and welfare include: a request for diversion to another agency; a report in which there are no reasonable grounds for concern or no harm identified to a child indicated; a report that does not warrant a Tusla child protection and welfare led intervention (these could be children who need additional supports to stop problems or difficulties worsening but social work led intervention is not required and diversion to Prevention Partnership and Family Support is considered). This was clarified in guidance issued to staff in October 2019. Prior to October 2019, only referrals meeting the eligibility criteria for child protection and welfare services were counted, with the exception of a small number of areas.


Cases Awaiting Allocation of a Social Worker

Cases awaiting allocation include cases held on duty, unallocated child protection and welfare cases including children in care


- 3,577 cases awaiting allocation of a social worker at the end of April 2021, 211 (6%) more than March 2021 (3,366). Second consecutive monthly increase.
- Cases awaiting allocation are down 17% (714) from April 2020 (4,291) and 16% (662) from December 2020 (4,239).
- Cases awaiting allocation account for 18% of open cases (19,752)
- 68% (2,435) of cases awaiting allocation at the end of April 2021 were "active on duty". This means that actions were undertaken by dedicated duty teams or rotating social workers on a duty roster to progress the protection and welfare of the cases. Examples of actions undertaken include telephone calls relating to the concern, visits to see children, completing initial assessments and child in care reviews or care plans.
- Highest number of cases awaiting allocation reported by Dublin South Central (548; 15%) followed by Dublin North (476; 13%), Dublin South West/Kildare/West Wicklow (326; 9%), Midwest (301; 8%), Waterford/Wexford (293; 8%) and Louth/Meath (291; 8%). These six areas account for 62% (2,235) of cases awaiting allocation.
- 342 cases awaiting allocation at the end of April 2021 were categorised as high priority, 11 fewer than March 2021 (353). High priority cases are down 34 (9%) from December 2020 (376).
- High priority cases account for 10% of cases awaiting allocation.
- 57% (2,031) of cases awaiting allocation were categorised at medium priority while the remaining 34% (1,204) were low priority.
- Highest number of high priority cases reported by Midwest (69), followed by Louth/Meath (38), Donegal (37), Dublin South Central (32) and Midlands (32). These five areas account for 61% (208) of all high priority cases awaiting.

Child Protection & Welfare

Cases Awaiting Allocation

- 8 areas reported an increase in unallocated cases from March 2021.
- Largest increase reported by Midlands (up 106) followed by Louth/Meath (up 85), Dublin North City (up 45), Dublin South West/Kildare/West Wicklow (37) and Galway/Roscommon (up 35).
- 9 areas reported a decrease in unallocated cases from March 2021.
- Largest decrease reported by Dublin North (down 29) followed by Cork (down 28), Kerry (down 27), Donegal (down 24) and Midwest (down 15).
- 8 areas had fewer cases awaiting at the end of April 2021 than the same period in 2020. Largest decrease reported by Dublin South West/Kildare/West Wicklow (down 624; 66%) followed by Dublin North City (down 186; 60%), Waterford/Wexford (down 170; 37%), Carlow/Kilkenny/South Tipperary (down 154; 52%) and Cork (down 118; 36%). Largest increases reported by Midwest (up 183; 155%), Dublin South East/Wicklow (up 112; 100%) and Dublin South Central (up 106; 24%).
- Nationally 18% of open cases were unallocated at the end of April 2021. Ten areas reported a percentage equal to or higher than the national average. Highest percentage (38%) reported by Dublin South Central followed by Dublin South East/Wicklow (26%), Dublin South West/Kildare/West Wicklow (23%), Louth/Meath (22%) and Donegal (22%).


Referrals

• **234 referrals of retrospective abuse** in June 2021, bringing the total number of referrals for the first six months of 2021 to 1,525. At least 1,289 referrals received during the same period in 2020. *Data for May 2020 based on data from 16 areas*.

Data presented on retrospective cases of abuse (pages 8-10) for May and June 2021 is based on 15 areas. Data for Donegal and Sligo/Leitrim/West Cavan not available due to the impact of the cyber-attack.


Open Cases

Note: all data on cases of retrospective abuse needs to be interpreted with caution due to concerns about the consistent interpretation of definitions.



- Allocated cases account for 61% of open cases.


Allocated Cases



Cases Awaiting Allocation of a Social Worker


- **492 cases awaiting allocation** at the end of June 2021, 54 (12%) more than May 2021 (438). (Data for May and June 2021 based on data for 15 areas).
- Cases awaiting allocation account for 39% of open cases
- Highest number of cases awaiting in Cork (90) followed Waterford/Wexford (74), DSW/K/WW (68) and Galway/Roscommon (56). These four areas account for 59% (288) of cases awaiting allocation. Two areas (Cavan/Monaghan and Mayo) have no cases awaiting allocation.

Cases Awaiting Allocation




- **24 high priority cases awaiting allocation** at the end of June 2021, four more than May 2021 (20).
- High priority cases accounted for 5% of cases awaiting allocation at the end of June 2021 (492).
- High priority cases are reported by six areas with the highest number reported by Galway/Roscommon (10) followed by Dublin South West/Kildare/West Wicklow (7).

- 3 of the 15 areas that returned data for June 2021 reported a decrease in cases awaiting allocation from May 2021, Kerry (down 28), Dublin North City (down 9) and Louth/Meath (down 1).
- **8 areas reported an increase** with the largest increase reported by Dublin South West/Kildare/West Wicklow and Cork, both up 25 and followed by the Midlands (up 12).
- The remaining four areas reported no change.
- 39% (492) of open cases are awaiting allocation nationally, with nine areas reporting a percentage equal to or higher than the national average. Highest percentages reported by Dublin South East/Wicklow (90%), Midlands (72%) and Galway/Roscommon (67%).
- 4 areas had fewer cases awaiting allocation at the end of June 2021 than June 2020, while nine areas reported an increase. Two areas (Cavan/Monaghan and Mayo) had no cases awaiting allocation at the end of either month. Kerry no data available for May 2020 and Donegal and SLWC no data available May and June 2021.





This means that areas no longer have to create an intake record on NCCIS to record the primary report type. Prior to this change, if an intake record had not been created on the system at the time the data were extracted, the mandated report would not have been included in the count.













- 106 fewer children in care than the same time last year (5,957).
- 65% (3,798) of children in care are in general foster care, 26% (1,503) are in relative foster care, 7% (434) are in residential care and 2% (116) are in "other" care placements.
- 17 (4%) of the 434 children in residential placements are in special care



- Highest number of children in care reported by Cork (749) followed by Midwest (569) and Dublin North City (484).
- Fewest number reported by the Social Work Team for Separated Children Seeking International Protection (52) followed by Sligo/Leitrim West Cavan (120) and Mayo (128).


Number of Children in Care by Area


Children in Care

- 750 (13%) children in care at the end of June 2021 were in placements with private providers; two fewer than May 2021 (752) and the second consecutive monthly decrease.
- There were 30 (4%) more children in care in placements with private providers at the end of June 2021 than at the end of June 2020 (720).



- 57% (424) of children in placements with private providers were in **foster care**, two fewer than May 2021 (426). This number (424) is up seven (2%) on June 2020 (417)
- 37% (281) of children in placements with private providers were in **residential care**, five fewer than May 2021 (286). This number (281) is up 16 (6%) on June 2020 (265).


Children in Care

- 89% (5,233) of children in care at the end of June 2021 had an allocated social worker; down one percentage point from May 2021
- A total of 618 children were awaiting an allocated social worker; 33 more than May 2021 (585) and 219 (55%) more than Dec 2020 (399).
- Highest number awaiting reported by Midwest (99) followed by Midlands (77), Dublin North City (67), Waterford/Wexford (66), Dublin North (60) and Louth/Meath (60). These six areas account for 69% (429) of all cases awaiting allocation.
- One area (Mayo) along with the Social Work Team for Separated Children Seeking International Protection reporting 100%


- 97% (5,650) of children in care at the end of June 2021 had an upto-date care plan; up one percentage point from May 2021.
- A total of 201 children did not have an up-to-date care plan; 31 fewer than May (232) and one more than Dec 2020 (200).

Children in Care with a Care Plan





• **889 children listed as "active" at the end of June 2021**; 57 fewer than May 2021 (946) and the fewest number since March 2020 (827). There were 100 fewer children "active" at the end of June 2021 than June 2020 (957).

The number of children listed as "active" from April 2020 needs to be interpreted with caution, due to the deferral of some review child protection conferences (where decisions are made to remove children listed as "active") during the Covid-19 restrictions. Guidance issued by Tusla on foot of the COVID-19 restrictions advised that following discussion and evaluation of safety plans, review conferences could be deferred for a maximum of 3 months.

- All children listed as "active" at the end of June 2021 had an **allocated social** worker.
- Highest number of children listed as "active" at the end of June 2021 reported by Midwest (91) followed by Cork (84) and Dublin North (82).
- Fewest number listed as "active" reported by Sligo/Leitrim/West Cavan (12) followed by Galway/Roscommon (18) and Louth/Meath (21).
- Highest rate per 10,000 population under 18 years reported by Dublin North City (14.5/10,000) followed by Donegal (14.0/10,000) and Carlow/Kilkenny/South Tipperary (12.4/10,000).
- Lowest rates reported by Galway/Roscommon (2.3/10,000) and Louth/Meath (2.3/10,000). Eight areas reported a rate equal to or higher than the national rate of 7.5/10,000
- 6 areas had more children listed as "active" at the end of June 2021 than May 2021. Largest increases reported Donegal and Dublin South East/Wicklow, both up six/. Largest decreases reported by Midlands (down 29), Midwest (down 11) and Dublin North City (down 10).
- 6 areas had more children active at the end of June 2021 than at the same period last year. Largest increases reported by Dublin North (up 30) and Dublin South East/Wicklow (up 27). Largest decreases reported by Carlow/Kilkenny/South Tipperary (down 45), Waterford/Wexford (down 36) and Galway/Roscommon (down 30).

Children "Active" on the CPNS





• 1,786 children on the register for home education at the end of June 2021, no change from April 2021. The number of children on the register is up 14% (220) on June 2020 (1,566).



• 1,588 children on a waiting list for assessment at the end of June 2021, 13 (1%) more than May 2021 (1,575) and 153 (11%) more than Dec 2020 (1,435). The increase in numbers awaiting assessment in recent months is due to an increase in applications received over the same period.


Service activity from March – June 2020 and January –March 2021 impacted by the closure of schools (Covid-19)

- 1,036 referrals screened by senior educational welfare services in June 2021, bringing the number of referrals screened for the 10 months (September June 2021) to 5,398.
- The number of referrals for June 2021 is up 656 on June 2020 (380) and the number of referrals for the 10 months (September –June) (5,398) is up 1,022 (23%) on the same period in 2019/2020 (4,376).


• 2,458 referrals on a waiting list for educational welfare services at the end of June 2021, 455 (23%) more than May 2021 (2,003), third consecutive monthly increase. The number of referrals on a waiting list is up 1,329 (118%) from June 2020 (2,458).

- 200 new individual children worked with in June 2021, 32 (19%) more than May 2021 (168) and 114 (134%) more than June 2020 (86).
- Brings to 2,413 the number of new individual children worked with for the 10 months September June 2021, 195 (9%) more than the same period in 2019/2020 (2,218).
