Headline Data – March 2022

Child Protection & Welfare

- 21,729 cases open to social work at the end of March 2022, 34 fewer than February 2022 (21,763).
- 79% (17,235) of cases open to social work had an allocated social worker.
- 4,494 (21%) cases awaiting allocation of a social worker, 44 (1%) more than February 2022 (4,450), first increase after two consecutive decreases.
- Five areas account for 51% (2.296) of cases awaiting allocation: Louth/Meath (526) followed by Dublin South West/Kildare/West Wicklow (507), Dublin North (446), Dublin South Central (409) and Cork (408).
- 8% (361) of cases awaiting allocation at the end of March 2022 were categorised as high priority, 47 (12%) fewer than February 2022 (408) and the fewest number since April 2021 (342).

Cases awaiting allocation include cases held on duty, unallocated child protection and welfare cases including children in care.

Cases of Retrospective Abuse

- 1,563 cases open to social work at the end of March 2022, three fewer than February 2022 (1,566) and 105 (7%) more than March 2021 (1,458).
- 54% (843) of cases of retrospective abuse open to social work had an allocated social worker, down from 59% at the end of February 2022.
- 720 cases awaiting allocation at the end of March 2022, 84 (13%) more than February 2022 (636) and 109 (18%) more than March 2021 (611).
- Six areas account for 63% (454) of all cases awaiting allocation: Midwest (113), Cork (76), Dublin North City (75), Dublin South West/Kildare/West Wicklow (73), Galway/Roscommon (66) and Donegal (51).

Children in Care

- 5,860 children in care at the end of March 2022; 34 more than February 2022 (5,826) and 19 fewer than March 2021 (5879)
- 823 (14%) children in care at the end of March 2022 were in placements with private providers; 12 (1%) more than February 2022 (811).
- 89% (5,222) of children in care at the end of March 2022 had an allocated social worker; no change from Feb 2022.
- A total of 638 children were awaiting an allocated social worker, four more than Feb 2022 (634).

Child Protection Notification System (CPNS)

- 971 children listed as "active" at the end of March 2022; four fewer than February 2022 (975). There were 48 (5%) more children "active" at the end of March 2022 than March 2021 (923).
- All children listed as "active" at the end of March 2022 had an allocated social worker.

Children's Services Regulation

- 4,118 early years services on the register at the end of March 2022, three fewer than February 2022 (4,121). There were 77 (2%) fewer services on the register at the end of March 2022 than March 2021 (4,195).
- 218 inspections of early years services done in March 2022, 10 (4%) fewer than February 2022 (228). This brings to 642 the number of inspections for the first three months of 2022, 245 (62%) more than the same period in 2021 (397). Number of inspections for early 2021 impacted due to the closure of services under the Covid-19 restrictions.
- 1,857 children on the register for home education at the end of March 2022, 19 more than February 2022 (1,838) and 85 (5%) more than March 2021 (1,772).
- 1,749 children on a waiting list for assessment at the end of March 2022, 148 (8%) fewer than February 2022 (1,897), the second consecutive monthly decrease and the fewest number since August 2021 (1,712).

Tusla Education Support Services

Service activity for 2020/2021 impacted by the closure of schools (Covid-19)

- 899 referrals screened by senior educational welfare services in March 2022, 188 (26%) more than February 2022 (711) and 539 (150%) more than March 2021 (360). Brings to 3,951 the number of referrals screened for the seven months Sept 2021 Mar 2022, 645 (20%) more than Sept 2020 Mar 2021 (3,306).
- 3,021 referrals on a waiting list for educational welfare services at the end of March 2022, 560 (23%) more than February 2022 (2,461) and 1,149 (61%) more than March 2021 (1,872).
- 366 new individual children worked with in March 2022, 28 (8%) more than February 2022 (338) and 184 (101%) more than March 2021 (182). Brings to 2,229 the number of new individual children worked with for the seven months Sept 2021 Mar 2022, 453 (26%) more than Sept 2020 Mar 2021 (1,776).

Child Protection and Welfare

Referrals¹

• **6,642 referrals** in March 2022, 361 (6%) more than February 2022 (6,281) and 78 (1%) more than March 2021 (6,564). This brings to 19,512 the number of referrals for the first three months of 2022, 2,740 (16%) more than the same period in 2021 (16,772).

It should be noted that the data presented for 2021 has been updated to reflect final validated figures for 2021. Data for 2022 is based on referrals logged on NCCIS at the time the data was extracted for reporting. Referrals logged after the date the data was extracted are not included, nor are figures updated until annual validation is complete.

Open Cases


- **21,729 cases open to social work** at the end of March 2022, 34 fewer than February 2022 (21,763). *Note: open cases include, all cases held on duty, allocated and unallocated child protection and welfare cases including children in care*
- Open cases are up 2,097 (11%) on March 2021 (19,632).


The data presented on cases is based on the status of cases on the National Child Care Information System (NCCIS) at month end.


Data for May and June 2021 is not available due to the impact of the cyber attack. The data on open cases is based on the time actions are recorded on NCCIS, hence data during the period when the system was not available is not meaningful (pages 4-7).

Allocated Cases

- 17,235 open cases allocated to a social worker at the end of March 2022, 78 fewer than February 2022 (17,313). Allocated cases are up 969 (6%) from March 2021 (16,266)
- Allocated cases account for 79% of open cases, down one percentage point from February 2022 (80%).


¹Referrals include referrals meeting the eligibility criteria for child protection and welfare services, multiple reports of the same concern and referrals not meeting the eligibility criteria for child protection and welfare services. Referrals not meeting the eligibility criteria for child protection and welfare include: a request for diversion to another agency; a report in which there are no reasonable grounds for concern or no harm identified to a child indicated; a report that does not warrant a Tusla child protection and welfare led intervention (these could be children who need additional supports to stop problems or difficulties worsening but social work led intervention is not required and diversion to Prevention Partnership and Family Support is considered). This was clarified in guidance issued to staff in October 2019. Prior to October 2019, only referrals meeting the eligibility criteria for child protection and welfare services were counted, with the exception of a small number of areas.


Child Protection & Welfare

Cases Awaiting Allocation of a Social Worker

Cases awaiting allocation include cases held on duty, unallocated child protection and welfare cases including children in care


- **4,494 cases awaiting allocation of a social worker** at the end of March 2022, 44 (1%) more than February 2022 (4,550). First increase after two consecutive decreases.
- Cases awaiting allocation are up 34% (1,128) from March 2021 (3,366).
- Cases awaiting allocation account for 21% of open cases (21,729), up one percentage point from February 2022 (20%).
- 72% (3,255) of cases awaiting allocation at the end of March 2022 were "active on duty". This means that actions were undertaken by dedicated duty teams or rotating social workers on a duty roster to progress the protection and welfare of the cases. Examples of actions undertaken include telephone calls relating to the concern, visits to see children, completing initial assessments and child in care reviews or care plans.
- Highest number of cases awaiting allocation reported by Louth/Meath (526) followed by Dublin South West/Kildare/West Wicklow (507), Dublin North (446), Dublin South Central (409) and Cork (408). These five areas account for 51% (2.296) of cases awaiting allocation.
- 361 cases awaiting allocation at the end of March 2022 were categorised as high priority, 47 (12%) fewer than February 2022 (408) and the fewest number since April 2021 (342).
- High priority cases account for 8% of cases awaiting allocation.
- 50% (2,267) of cases awaiting allocation were categorised at medium priority while the remaining 42% (1,866) were low priority.
- Highest number of high priority cases reported by Louth/Meath (63) followed by Donegal (44), Midlands (31), Dublin South Central (30), Dublin North (30), and Cork (30). These six areas account for 63% (228) of all high priority cases awaiting.











Child Protection & Welfare

Cases Awaiting Allocation

- 9 areas reported a decrease in unallocated cases from February 2022.
- Largest decrease reported by Waterford/Wexford (down 140; 27%) followed by Louth/Meath (down 65; 11%) and Dublin South Central (down 51; 11%). Largest increase reported by Dublin North (up 153; 52%) followed by Midlands (up 83; 28%) and Dublin South East/Wicklow (up 33; 11%).
- All but five areas (Dublin South Central, Midwest, Dublin North, Kerry and Galway/Roscommon)) had more cases awaiting allocation at the end of March 2022 than at the same time last year.
- Largest increases reported by Louth/Meath (up 320; 155%), Midlands (up 225; 149%) and Dublin South West/Kildare/West Wicklow (up 218; 75%). Largest decreases reported by Dublin South Central (down 116; 22%), Midwest (down 93; 29%) and Dublin North (down 59; 12%).
- Nationally 21% of open cases were unallocated at the end of March 2022. Eight areas reported a percentage equal to or higher than the national average of 21%. Highest percentage (34%) reported by Louth/Meath followed by Dublin South Central (30%), Dublin South East/Wicklow (29%) and Dublin South West/Kildare/West Wicklow 29%). Lowest percentage reported by Mayo (4%), followed by Galway/Roscommon (8%), Dublin North City (11%) and Sligo/Leitrim/West Cavan (11%).


Referrals

• **491 referrals of retrospective abuse** in March 2022, 50 (11%) more than February 2022 (441) and 153 (45%) more than March 2021 (338). Brings to 1,250 the number of referrals for the first three months of 2022, 432 (53%) more than the same period in 2021 (818).



Open Cases

• **1,563 cases open to social work** at the end of March 2022, three fewer than February 2022 (1,566) and 105 (7%) more than March 2021 (1,458).

Allocated Cases


- **843 cases allocated to a social worker** at the end of March 2022, 87 (9%) fewer than February 2022 (930) and four fewer than March 2021 (847).
- Allocated cases account for 54% of open cases, down from 59% at the end of February 2022.



Allocated Cases by Month

Cases Awaiting Allocation of a Social Worker

- **720 cases awaiting allocation** at the end of March 2022, 84 (13%) more than February 2022 (636) and 109 (18%) more than March 2021 (611).
- Cases awaiting allocation account for 46% of open cases, up from 41% at the end February 2022.
- Highest number of cases awaiting in Midwest (113) followed by Cork (76), Dublin North City (75), Dublin South West/Kildare/West Wicklow (73), Galway/Roscommon (66) and Donegal (51). These six areas account for 63% (454) of cases awaiting allocation. One area (Mayo) has no cases awaiting allocation.



- **51 high priority cases awaiting allocation** at the end of March 2022, one more than February 2022 (50) and the fifth consecutive monthly increase.
- High priority cases accounted for 7% of cases awaiting allocation at the end of March 2022 (720).
- High priority cases are reported by nine areas with the highest numbers reported by Midwest (23), Donegal (12), Dublin North City (5) and Louth/Meath (4).



Mar

- **7 areas reported an increase** in cases awaiting allocation from February 2022. Largest increase reported by Midwest (up 33) followed by Kerry (up 24), Cork (up 23) and Dublin South West/Kildare/West Wicklow (up 13).
- **7 areas reported an decrease** with the largest decrease reported by Dublin North (down 9), Galway/Roscommon (down 3) and Midlands (down 3).
- The remaining three areas (Dublin South East/Wicklow, Donegal and Mayo) reported no change.
- 46% (720) of open cases are awaiting allocation nationally, with nine areas reporting a percentage equal to or higher than the national average. Highest percentages reported by Dublin South Central (90%), Kerry (77%), Donegal (73%), Galway/Roscommon (66%), Midwest (65%) and Dublin South West/Kildare/West Wicklow (62%).

- **7 areas** had more cases awaiting allocation at the end of March 2022 than March 2021, six areas had fewer cases. Two remaining four areas (Dublin North, Louth/Meath, Donegal and Mayo) reported no change.
- Largest increases reported by Midwest (up 113), Dublin North City (41) and Dublin South East/Wicklow (40). Largest decreases reported by Carlow/Kilkenny/South Tipperary (down 46) and Waterford/Wexford (down 45)

• **1,869 mandated reports of abuse** received in March 2022, 158 (9%) more than February 2022 (1,711).


• Mandated reports accounted for 28% (1,869) of all referrals received (6,642) in March 2022.




Mandated Reports by Month

- The number of mandated reports for March 2022, by area ranged from 33 (Sligo/Leitrim/West Cavan) to 225 (Dublin North).
- As a percentage of referrals, the highest percentage (47%) was reported by Mayo followed by Dublin North (39%), Carlow/Kilkenny/South Tipperary (38%) and Cork (35%).
- The lowest percentages were reported by Waterford / Wexford (12%), Dublin South West/Kildare/West Wicklow (18%) and Midwest (19%)

• Highest number of reports for March 2022 were for emotional abuse (700; 37%) followed by physical abuse (526; 28%), sexual abuse (398; 21%) and neglect (245; 13%).

Source of Reports


- Highest number of reports for March 2022 from An Garda Síochána (722; 38%) followed by teachers (342; 18%), social workers (281; 15%), safeguarding officers (96; 5%), social care workers (88; 5%), medical practitioners (70; 4%) and managers of domestic violence shelters (64; 3%). These seven sources account for 89% (1,663) of reports for March 2022.
- · Highest number of reports year to date from An Garda Síochána (2,145; 40%) followed by teachers (987; 19%), social workers (728; 14%), social care workers (258; 5%), safeguarding officers (260; 5%), managers of domestic violence shelters (196; 4%) and medical practitioners (196; 4%). These seven sources account for 90% (4,770) of reports year to date.


Mandated Reports¹ – Retrospective Abuse

- The majority (81%; 387) of mandated reports for March 2022 were for sexual abuse.




Mandated Reports by Month





- **5,860 children in care at the end of March 2022**; 34 more than February 2022 (5,826)
- 19 fewer children in care than the same time last year (5,879).
- 64% (3,748) of children in care are in general foster care, 26% (1,500) are in relative foster care, 7% (436) are in residential care and 3% (176) are in "other" care placements.
- 16 (4%) of the 436 children in residential placements are in special care



- Highest number of children in care reported by Cork (733) followed by Midwest (541) and Dublin North City (468).
- Fewest number reported by Sligo/Leitrim West Cavan (106) followed by the Social Work Team for Separated Children Seeking International Protection (212) and Mayo (143).
- Highest rate of children in care per 1,000 children was reported by Dublin North City (10.4/1,000) followed by Waterford/Wexford (6.1/1,000) , Dublin South Central (5.8/1,000) and Midwest (5.6/1,000) . Lowest rate reported by Dublin South East/Wicklow (2.5/1,000) followed by Dublin North (3.5/1,000) and Dublin South West/Kildare/West Wicklow (3.8/1,000).
- Seven areas reported a percentage equal to or higher than the national average of 4.8/1,000 children.





Children in Care

- **823 (14%) children in care at the end of March 2022 were in placements with private providers**; 12 (1%) more than February 2022 (811).
 - Note: data prior to November 2021 should be interpreted with caution due to the inclusion of a small number of children in residential care in placements with voluntary organisations.
- There were 82 (11%) more children in care in placements with private providers at the end of March 2022 than at the end of March 2021 (741).





Children in Care with a Social Worker


- **89% (5,222) of children in care at the end of March 2022 had an allocated social worker**; no change from Feb 2022.
- A total of 638 children were awaiting an allocated social worker, four more than Feb 2022 (634).
- Highest number awaiting reported by Waterford/Wexford (135) followed by Carlow/Kilkenny/South Tipperary (77), Dublin North (72), Louth/Meath (70) and Midwest (51). These five areas account for 63% (405) of all cases awaiting allocation.



• 98% (5,727) of children in care at the end of March 2022 had a care plan; up one percentage point from Feb 2022.

- A total of 133 children did not have a care plan, 17 (11%) fewer than Feb 2022 (150).
- Highest numbers with no care plan reported by Louth/Meath (27), Dublin South Central (24) and Dublin North (24).



Child Protection Notification System

- Fewest number listed as "active" reported by Kerry (17) followed by Louth/Meath (22) and Sligo/Leitrim/West Cavan (27).
- Highest rate per 10,000 population under 18 years reported by Dublin North City (16.7/10,000) followed by Donegal (14.2/10,000) and Carlow/Kilkenny/South Tipperary (13.3/10,000).
- Lowest rates reported by Louth/Meath (2.4/10,000), Kerry (4.9/10,000) and Galway/Roscommon (5.4). Nine areas reported a rate equal to or higher than the national rate of 8.2/10,000
- 9/17 areas had more children listed as "active" at the end of March 2022 than February 2022. Largest increases reported by Carlow/Kilkenny/South Tipperary (up 7), Midwest (up 6) and Donegal (up 6). Largest decrease reported by Kerry (down 12) followed by Dublin north City (down 9) and Louth/Meath (down 7).
- 11 areas had more children active at the end of March 2022 than at the same period last year. Largest increases reported by Cavan/Monaghan (up 20), Sligo/Leitrim/West Cavan (up 16), Donegal (up 14) and Mayo (up 10). Largest decreases reported by Kerry (down 31) and Cork (down 6). One area Dublin North City reported no change.







Children Waiting Assessment for Registration


