Headline Data – March 2024

Child Protection & Welfare

- **7,749 referrals in March 2024**, 136 (2%) fewer than February 2024 (7,885) and 959 (11%) fewer than March 2023 (8,708). This brings to 23,226 the number of referrals for the first three months of 2024, 589 (2%) fewer than the same period in 2023 (23,815).
- **22,293 cases open to social work at the end of March 2024**, 149 (<1%) fewer than February 2024 (22,442) and 1,166 (5%) fewer than March 2023 (23,459). Open cases include child protection and welfare cases including children in care.
- 79% (17,700) of cases open to social work at the end of March 2024 had an allocated social worker.
- **4,593 cases awaiting allocation of a social worker at the end of March 2024**, 436 (9%) fewer than February 2024 (5,029) and the third consecutive monthly decrease.
- Five areas account for 62% (2,840) of cases awaiting allocation: Dublin South Central (1,040), Louth/Meath (624), Cork (494), Dublin South West/Kildare/West Wicklow (364) and Midwest (318).
- 8% (369) of cases awaiting allocation at the end of March 2024 were categorised as high priority, 38 (9%) fewer than February 2024 (407) and 32 (8%) fewer than March 2023 (401).

Children in Care

- **5,760 children in care at the end of March 2024**, five fewer than February 2024 (5,765). This figure includes 144 children under the Service for Separated Children Seeking International Protection (SCSIP), down one from 145 at the end of February 2024.
- **87.5% (5,042)* of all children in care are in foster care** (3,571 general foster care, and 1,471 relative foster), 8% (472) are in residential care (457 general residential care and 15 special care) and 4% (246) are in "other" care placements2.
- Across Tusla's 17 areas 89.3% (5,016/5,616) of children in care are in foster care.
- **891 (15%) children in care at the end of March 2024 were in placements with private providers**, 11 (1%) fewer than February 2024 (902).
- 83% (4,777) of children in care at the end of March 2024 had an allocated social worker. A total of 983 children were awaiting an allocated social worker, 26 (3%) fewer than February 2024 (1,009).
- 80% (4,627) of children in care at the end of March 2024 had an up-to-date care plan. A total of 1,133 children were awaiting an up-to-date care plan, five fewer than February 2024 (1,138).

*Decrease from previous months in the overall percentage of children in care in foster care is due to the inclusion of SCSIP as the majority of these children are placed in residential care.

Child Protection Notification System (CPNS)

- **1,007 children listed as "active" at the end of March 2024**, 46 (5%) more than February 2024 (961).
- There were 157 (18%) more children "active" at the end of March 2024 than at the end of March 2023 (850).
- All children listed as "active" at the end of March 2024 had an allocated social worker.

Children's Services Regulation

- **4,049 early years services on the register at the end of March 2024**, no change from February 2024 and 13 (<1%) fewer than March 2023 (4,062).
- **166 inspections of early years services done in March 2024**. This brings to 552 the number of inspections for the first three months of 2024, 54 (9%) fewer than the same period in 2023 (606).
- 2,455 children on the register for home education at the end of March 2024, 8 (<1%) more than February 2024 (2,447) and 395 (19%) more than March 2023 (2,060).
- **1,062 children on a waiting list for assessment at the end of March 2024**, 20 (2%) more than February 2024 (1,042) and 375 (26%) fewer than March 2023 (1,437). First increase after six consecutive monthly decreases.

Tusla Education Support Services

- 1,001 referrals screened by senior educational welfare services in March 2024. This brings to 5,050 the number of referrals for the first seven months of the academic year 2023-2024, 842 (20%) more than the same period in 2022-2023 (4,208).
- **3,429 referrals on a waiting list for educational welfare services at the end of March 2024**, 186 (6%) more than February 2024 (3,243) and the fifth consecutive monthly increase.
- **429 new individual children worked with in March 2024**. This brings to 2,586 the number of new individual children worked with for the first seven months of the academic year 2023-2024, 278 (12%) more than the same period in 2022-2023 (2,308).

Child Protection and Welfare

Referrals¹

- **7,749 referrals** in March 2024, 136 (2%) fewer than February 2024 (7,885) and 959 (11%) fewer than March 2023 (8,708).
- This brings to 23,226 the number of referrals for the first three months of 2024, 589 (2%) fewer than the same period in 2023 (23,815).

It should be noted that the data presented for 2023 has been updated to reflect final validated figures for this period. Data for 2024 is based on referrals logged on the Tusla Case Management (TCM) system at the time the data was extracted for reporting. Referrals logged after the date the data was extracted are not included, nor are figures updated until quarterly validation is complete.

Open Cases

• **22,293 cases open to social work** at the end of March 2024, 149 (<1%) fewer than February 2024 (22,442) and 1,166 (5%) fewer than March 2023 (23,459). *Open cases from September 2023 include cases awaiting categorisation. See note below.*


- 1) From September 2023, open cases (allocated/unallocated) include cases "awaiting categorisation" at month end. This is in addition to cases categorised as high, medium and low. The category "awaiting categorisation" was introduced this year to reflect better questions being asked at screening and awaiting information for slightly longer.
- 2) Open cases include, all cases held on duty, allocated and unallocated child protection and welfare cases including children in care.
- 3) The data presented on cases is based on the status of cases on the TCM at month end.

Allocated Cases


- 17,700 open cases were allocated to a social worker at the end of March 2024, 287 (2%) more than February 2024 (17,413) and 209 (1%) more than March 2023 (17,491). Note: comparison of data from September 2023 with previous months needs to be interpreted with caution due to the inclusion of cases awaiting categorisation from September 2023. Refer to notes above.
- Allocated cases account for 79% of open cases, up one percentage point from February 2023 (78%) and up four percentage points from March 2023 (75%).

Child Protection & Welfare

Cases Awaiting Allocation of a Social Worker

Cases awaiting allocation include cases held on duty, unallocated child protection and welfare cases including children in care

- **4,593 cases awaiting allocation of a social worker** at the end of March 2024, 436 (9%) fewer than February 2024 (5,029) and the third consecutive monthly decrease.
- Cases awaiting allocation are down 1,375 (23%) from March 2023 (5,968).


- Cases awaiting allocation account for 21% of open cases (22,293), down one percentage point from February 2024 (22%).
- 70% (3,227) of cases awaiting allocation at the end of March 2024 were "active on duty". This means that actions were undertaken by dedicated duty teams or rotating social workers on a duty roster to progress the protection and welfare of the cases. Examples of actions undertaken include telephone calls relating to the concern, visits to see children, completing initial assessments and child in care reviews or care plans.
- Highest number of cases awaiting allocation reported by Dublin South Central (1,040) followed by Louth/Meath (624), Cork (494), Dublin South West/Kildare/West Wicklow (364) and Midwest (318). These five areas account for 62% (2,840) of all cases awaiting allocation.
- **369 cases awaiting allocation at the end of March 2024 were categorised as high priority**, 38 (9%) fewer than February 2024 (407) and 32 (8%) fewer than March 2023 (401).
- High priority cases account for 8% of cases awaiting allocation.
- 55% (2,508) of cases awaiting allocation were categorised at medium priority, 35% (1,607) were low priority while the remaining 2% (109) were awaiting categorisation.
- Highest number of high priority cases reported by Midwest (84) followed by Midlands (81), Dublin South Central (39), Louth/Meath (35) and Galway/Roscommon (32). These five areas account for 73% (271) of all high priority cases awaiting.



Child Protection & Welfare

Cases Awaiting Allocation

- 10/17 areas reported a decrease in unallocated cases from February 2024.
- Largest decreases reported by Cork (down 164), Dublin North City (down 161) and Dublin South Central (down 109).
- 7/17 areas reported an increase in unallocated cases from February 2024. Largest increases reported by Louth/Meath (up 51), Midlands (up 24), Dublin North (up 22) and Galway/Roscommon (up 21).
- Nationally 21% of open cases were unallocated at the end of March 2024. Six areas reported a percentage equal to or higher than the national average of 21%, Dublin South Central (43%), Louth/Meath (37%), Carlow/Kilkenny/South Tipperary (33%), Midwest (23%), DSW/K/WW (23%) and Dublin South East/Wicklow (22%).
- 11/17 areas had fewer cases awaiting allocation at the end of March 2024 than at the end of March 2023. Largest decreases reported by Cork (down 417), Waterford/Wexford (down 372), Dublin North (down 359) and DSW/K/WW (down 248).
- 6/17 areas reported an increase as follows, Louth/Meath (up 300), Midwest (up 180), Galway/Roscommon (up 47), Dublin South Central (up 14), Cavan/Monaghan (up 14) and Mayo (up 1).



Mandated Reports¹ – Child Protection & Welfare

• **2,573 mandated reports of abuse** received in March 2024, 72 (3%) fewer than February 2024 (2,645) and 388 (13%) fewer than March 2023 (2,961). This brings to 7,521 the number of reports for the first three months of 2024, 22 (<1%) fewer than the same period in 2023 (7,499).

It should be noted that the data presented for 2023 has been updated to reflect final validated figures for this period. Data for 2024 is based on referrals logged on the Tusla Case Management (TCM) system at the time the data was extracted for reporting. Referrals logged after the date the data was extracted are not included, nor are figures updated until quarterly validation is complete.


• Mandated reports accounted for 33% (2,573) of all referrals received (7,749) in March 2024.




Mandated reports by Month

- The number of mandated reports for March 2024, by area ranged from 48 (Cavan/Monaghan) to 357 (Louth/Meath).
- As a percentage of referrals, the highest percentage (62%) was reported by Mayo.
- The lowest percentage was reported by Carlow/Kilkenny/South Tipperary (19%).

Highest number of reports for March 2024 were for emotional abuse (1,140; 44%) followed by physical abuse (642; 25%), sexual abuse (429; 17%) and neglect (362; 14%)

Mandated Reports – Child Protection & Welfare

- Highest number of reports for March 2024 from An Garda Síochána (974; 38%) followed by teachers (411; 16%), social workers (304; 12%), safeguarding officers (296; 12%); social care workers (111; 4%), and medical practitioners (90; 4%). These six sources account for 85%% (2,186) of reports for March 2024.
- Highest number of reports for 2024 YTD from An Garda Síochána (2,822; 38%) followed by teachers (1,188; 16%), safeguarding officers (946; 13%), social workers (888; 12%), social care workers (334; 4%), medical practitioners (266; 4%) and psychotherapists (99; 3%). These seven sources account for 88% (6,643) of reports for 2024 YTD.



- 5,760 children in care at the end of March 2024, five fewer than February 2024 (5,765).
- Of these, 5,616 were reported by Tusla's 17 areas and 144 were reported by the Service for Separated Children Seeking International Protection (SCSIP).
- Across Tusla's 17 areas there were four fewer children in care at the end of March 2024 (5,616) than at the end of February 2024 (5,620) and 20 (<1%) more than at the end March 2023 (5,596).
- 87.5% (5,042)* of all children in care are in foster care (3,571 general foster care, and 1,471 relative foster), 8% (472) are in residential care (457 general residential care and 15 special care) and 4% (246) are in "other" care placements².
- Across Tusla's 17 areas 89.3% (5,016/5,616) of children in care are in foster care.

*Decrease from previous months in the overall percentage of children in care in foster care is due to the inclusion of SCSIP; the majority of these children are placed in residential care.

- Highest number of children in care reported by Cork (690) followed by Midwest (492) and Dublin North City (470).
- Fewest number reported by Sligo/Leitrim West Cavan (112) followed by Mayo (143) and the Service for Separated Children Seeking International Protection (144).
- Across the 17 Areas the highest rate of children in care per 1,000 children was reported by Dublin North City (9.5) followed by Waterford/Wexford (6.1).
- Lowest rate reported by Dublin South East/Wicklow (2.3) followed by Dublin South West/Kildare/West Wicklow (3.6) and Dublin North (3.9).
- Nine areas reported a percentage equal to or higher than the national average of 4.6/1,000 children.

- **530 (59%)** children in placements with private providers were in **foster care**, **4** (<1%) fewer than February 2024 (534).
- 297 (33%) children were in **residential care**, 6 (2%) fewer than February 2024 (303).
- The remaining 64 (7%) children were in **"Other" care placements, 1** (<1%) fewer than February 2024 (65). "Other" care placements include, disability units, mental health units, drug and alcohol rehabilitation centres etc.


Highest number of children in placements with private providers reported by Dublin North City (112) followed by Dublin South West/Kildare/West Wicklow (107), Dublin South Central (107), Dublin North (98) and Midlands (70). These five areas account for 55% (494) of children in placements with private providers,

Children in Care

- 83% (4,777) of children in care at the end of March 2024 had an allocated social worker.
- A total of 983 children were awaiting an allocated social worker, 26 (3%) fewer than February 2024 (1,009).
- Highest number awaiting reported by Midwest (199; 40%) followed by Carlow/Kilkenny/South Tipperary (190; 61%), Dublin South West/Kildare/West Wicklow (136; 34%), Dublin South Central (99; 30%) and the Service for Separated Children Seeking International Protection (66; 46%), Midlands (64; 19%) and Louth/Meath (63; 15%). These seven services account for 83% (817) of all cases awaiting allocation.

• 80% (4,627) of children in care at the end of March 2024 had an up-to-date care plan.

- A total of 1,133 children were awaiting an up-to-date care plan, five fewer than February 2024 (1,138).
- Highest numbers awaiting an up-to-date care plan reported by Dublin North City (143; 30%), Midwest (142; 29%), Cork (117; 17%) and Midlands (102; 31%).

Tusla has moved to reporting on children in care with an up-to-date care plan and not just children having a care plan, hence this data is not comparable with data previously reported. 

Child Protection Notification System

- **1,007 children listed as "active"** at the end of March 2024, 46 (5%) more than February 2024 (961).
- There were 157 (18%) more children "active" at the end of March 2024 than at the end of March 2023 (850).
- All children listed as "active" at the end of March 2024 had an **allocated social** worker.
- Highest number of children listed as "active" at the end of March 2024 was reported by Dublin South West/Kildare/West Wicklow (119) followed by Midwest (118) and Cork (108).
- Fewest number listed as "active" reported by Sligo/Leitrim/West Cavan (13) followed by Kerry (17), Cavan/Monaghan (21) and Mayo (21).
- Highest rate per 10,000 population under 18 years reported by Dublin North City (16.7) followed by Donegal (14.9) and Midwest (12.2).
- Lowest rate per 10,000 population under 18 years reported by Dublin South East/Wicklow (4.2) followed by Kerry (4.9) and Waterford/Wexford (5.2).
- Seven areas reported a rate equal to or higher than the national rate of 8.3/10,000
- 10/17 areas had more children listed as "active" at the end of March 2024 than at the end of February 2024. Largest increases reported by Midwest (up 35) followed by Dublin South West/Kildare/West Wicklow (19).
- 6/17 areas reported a decrease. Largest decreases reported by Dublin South Central (down 9) Cork (down 9) and Dublin North City (down 8). The remaining area (Sligo/Leitrim/West Cavan) reported no change.
- 11/17 areas had more children active at the end of March 2024 than at the end of March 2023. Largest increases reported by Midwest (up 52), Dublin South West/Kildare/West Wicklow (up 36), Louth/Meath (up 36), Donegal (up 26) and Galway/Roscommon (up 26).
- 6/17 areas reported a decrease. Largest decreases reported by Dublin South Central (down 29), Waterford/Wexford (down 13) and Dublin North City (down 11).



Number and rate of children "active" on the CPNS, by area (ranked by rate)




EARLY YEARS INSPECTORATE

- **4,049 early years services on the register at the end of March 2024**, no change from February 2024 and 13 (<1%) fewer than March 2023 (4,062).
- **166 inspections** of early years services done in March 2024. This brings to 552 the number of inspections for the first three months of 2024, 54 (9%) fewer than the same period in 2023 (606).



ALTERNATIVE EDUCATION ASSESSMENT AND REGISTRATION SERVICE

- 2,455 children on the register for home education at the end of March 2024, 8 (<1%) more than February 2024 (2,447) and 395 (19%) more than March 2023 (2,060).
- **1,062 children on a waiting list for assessment at the end of March 2024**, 20 (2%) more than February 2024 (1,042) and 375 (26%) fewer than March 2023 (1,437). First increase after six consecutive monthly decreases.








Tusla Education Support Services

• **1,001 referrals screened** by senior educational welfare services in March 2024. This brings to 5,050 the number of referrals for the first seven months of the academic year 2023-2024, 842 (20%) more than the same period in 2022-2023 (4,208).

• **3,429 referrals on a waiting list** for educational welfare services at the end of March 2024, 186 (6%) more than February 2024 (3,243) and the fifth consecutive monthly increase.

• **429 new individual children worked** with in March 2024. This brings to 2,586 the number of new individual children worked with for the first seven months of the academic year 2023-2024, 278 (12%) more than the same period in 2022-2023 (2,308).
