# **Headline Data – May 2022**

### **Child Protection & Welfare**

- 21,748 cases open to social work at the end of May 2022, 207 (<1%) more than April 2022 (21,541), first increase after three consecutive monthly decreases.
- 76% (16,612) of cases open to social work had an allocated social worker.
- 5,136 cases awaiting allocation of a social worker at the end of May 2022, 505 (11%) more than April 2022 (4,631).
- Six areas account for 65% (3,316) of cases awaiting allocation: Dublin South West/Kildare/West Wicklow (700), Waterford/Wexford (590), Cork (584), Louth/Meath (576), Dublin North (443) and Dublin South Central (423).
- 7% (372) of cases awaiting allocation at the end of May 2022 were categorised as high priority, 44 (13%) more than April 2022 (328).

Cases awaiting allocation include cases held on duty, unallocated child protection and welfare cases including children in care.

### **Cases of Retrospective Abuse**

- 1,523 cases open to social work at the end of May 2022, 18 fewer than April 2022 (1,541).
- 59% (893) of cases of retrospective abuse open to social work had an allocated social worker, up from 58% at the end of April 2022.
- 630 cases awaiting allocation at the end of May 2022, 12 fewer than April 2022 (642) and the second consecutive decrease.
- Six areas account for 67% (421) of all cases awaiting allocation: Midwest (104), Dublin North City (75), Cork (72), Galway/Roscommon (71), Donegal (52) and Dublin South West/Kildare/West Wicklow (47).

### **Children in Care**

- 5,860 children in care at the end of May 2022; nine fewer than April 2022 (5,869) and 15 fewer children in care than the same time last year (5,875).
- 825 (14%) children in care at the end of May 2022 were in placements with private providers, 11 (1%) more than April 2022 (814) and 73 (10%) more than May 2021 (752).
- 88% (5,158) of children in care at the end of May 2022 had an allocated social worker; no change from April 2022.
- A total of 702 children were awaiting an allocated social worker, eight more than April 2022 (694).

### **Child Protection Notification System (CPNS)**

- 925 children listed as "active" at the end of May 2022; 70 (7%) fewer than April 2022 (995) when the highest number for the period Jan 2021 Apr 2022 reported.
- There were 21 (2%) fewer children "active" at the end of May 2022 than May 2021 (946).
- All children listed as "active" at the end of May 2022 had an allocated social worker.

### **Children's Services Regulation**

- 4,110 early years services on the register at the end of May 2022, three fewer than April 2022 (4,113). There were 73 (2%) fewer services on the register at the end of May 2022 than May 2021 (4,183).
- 267 inspections of early years services done in May 2022, 57 (27%) more than April 2022 (210). This brings to 1,119 the number of inspections for the first five months of 2022, 145 (15%) more than the same period in 2021 (974). Number of inspections for early 2021 impacted due to the closure of services under the Covid-19 restrictions.
- 1,857 children on the register for home education at the end of May 2022, nine fewer than April 2022 (1,866) and 71 (4%) more than May 2021 (1,786).
- 1,661 children on a waiting list for assessment at the end of May 2022, 37 (2%) fewer than April 2022 (1,698), the fourth consecutive monthly decrease and the fewest number since July 2021 (1,615).

### **Tusla Education Support Services**

Service activity for 2020/2021 impacted by the closure of schools (Covid-19)

- 861 referrals screened by senior educational welfare services in May 2022, 143 (14%) fewer than April 2022 (1,004) and 313 (57%) more than May 2021 (548). Brings to 5,816 the number of referrals screened for the nine months Sept 2021 May 2022, 1,454 (33%) more than Sept 2020 May 2021 (4,362).
- 3,604 referrals on a waiting list for educational welfare services at the end of May 2022, 75 (2%) more than April 2022 (3,529) and 1,601 (80%) more than May 2021 (2,003).
- 278 new individual children worked with in May 2022, 34 (14%) more than April 2022 (244) and 110 (65%) more than May 2021 (168). Brings to 2,751 the number of new individual children worked with for the nine months Sept 2021 May 2022, 538 (24%) more than Sept 2020 May 2021 (2,213).

### **Child Protection and Welfare**

#### Referrals<sup>1</sup>

• 7,607 referrals in May 2022, 1,487 (24%) more than April 2022 (6,120) and 1,906 (33%) more than May 2021 (5,701). This brings to at least 33,239 the number of referrals for the first five months of 2022, 4,368 (15%) more than the same period in 2021 (28,871). Figure for May 2021 lower than expected due to the HSE cyber-attack.

It should be noted that the data presented for 2021 has been updated to reflect final validated figures for 2021. Data for 2022 is based on referrals logged on NCCIS at the time the data was extracted for reporting. Referrals logged after the date the data was extracted are not included, nor are figures updated until annual validation is complete.

### **Open Cases**


• 21,748 cases open to social work at the end of May 2022, 207 (<1%) more than April 2022 (21,541), first increase after three consecutive monthly decreases. *Note:* open cases include, all cases held on duty, allocated and unallocated child protection and welfare cases including children in care.


The data presented on cases is based on the status of cases on the National Child Care Information System (NCCIS) at month end.


Data for May and June 2021 is not available due to the impact of the HSE cyber attack. The data on open cases is based on the time actions are recorded on NCCIS, hence data during the period when the system was not available is not meaningful (pages 4-7).

### **Allocated Cases**

- **16,612 open cases allocated** to a social worker at the end of May 2022, 298 (2%) fewer than April 2022 (16,910), third consecutive decrease.
- Allocated cases account for 76% of open cases, down three percentage points from April 2022.







<sup>&</sup>lt;sup>1</sup>Referrals include referrals meeting the eligibility criteria for child protection and welfare services, multiple reports of the same concern and referrals not meeting the eligibility criteria for child protection and welfare services. Referrals not meeting the eligibility criteria for child protection and welfare services. Referrals not meeting the eligibility criteria for child protection and welfare include: a request for diversion to another agency; a report in which there are no reasonable grounds for concern or no harm identified to a child indicated; a report that does not warrant a Tusla child protection and welfare led intervention (these could be children who need additional supports to stop problems or difficulties worsening but social work led intervention is not required and diversion to Prevention Partnership and Family Support is considered). This was clarified in guidance issued to staff in October 2019, only referrals meeting the eligibility criteria for child protection and welfare services were counted, with the exception of a small number of areas.


## **Child Protection & Welfare**

### **Cases Awaiting Allocation of a Social Worker**


Cases awaiting allocation include cases held on duty, unallocated child protection and welfare cases including children in care

- **5,136 cases awaiting allocation of a social worker** at the end of May 2022, 505 (11%) more than April 2022 (4,631). Third consecutive increase after two consecutive decreases.
- Cases awaiting allocation account for 24% of open cases (21,748), up from 21% at the end of April 2022.
- 73% (3,743) of cases awaiting allocation at the end of May 2022 were "active on duty". This means that actions were undertaken by dedicated duty teams or rotating social workers on a duty roster to progress the protection and welfare of the cases. Examples of actions undertaken include telephone calls relating to the concern, visits to see children, completing initial assessments and child in care reviews or care plans.
- Highest number of cases awaiting allocation reported by Dublin South West/Kildare/West Wicklow (700), followed by Waterford/Wexford (590), Cork (584), Louth/Meath (576), Dublin North (443) and Dublin South Central (423). These six areas account for 65% (3,316) of cases awaiting allocation.
- 372 cases awaiting allocation at the end of May 2022 were categorised as high priority, 44 (13%) more than April 2022 (328).
- High priority cases account for 7% of cases awaiting allocation.
- 50% (2,573) of cases awaiting allocation were categorised at medium priority while the remaining 43% (2,191) were low priority.
- Highest number of high priority cases reported by Louth/Meath (45) followed by Donegal (39), Dublin South East/Wicklow (34), Dublin North City (34), Dublin North (31) and Dublin South Central (30). These six areas account for 57% (213) of all high priority cases awaiting.


#### **Number of Unallocated Cases**

## **Child Protection & Welfare**

### **Cases Awaiting Allocation**

- 12 areas reported an increase in unallocated cases from April 2022.
- Largest increase reported by Dublin South West/Kildare/West Wicklow (up 111; 19%) followed by Waterford/Wexford (up 94; 19%), Dublin South Central (up 69; 19%), Cork (up 69; 13%) and Dublin North City (up 60; 27%).
- Of the five areas that reported a decrease, the largest decrease was reported by Dublin South East/Wicklow (down 16; 4%) followed by Cavan/Monaghan (down 12; 17%) and Midlands (down 10; 4%).
- Comparison with May 2021 not available due to the absence of data for May 2021 due the HSE cyber-attack.
- Nationally 24% of open cases were unallocated at the end of May 2022. Eight areas reported a percentage equal to or higher than the national average of 21%. Highest percentage (40%) reported by Louth/Meath and Dublin South West/Kildare/West Wicklow followed by Dublin South Central (34%) and Dublin South East/Wicklow (33%). Lowest percentage reported by Mayo (7%), followed by Sligo/Leitrim/West Cavan (8%) and Cavan/Monaghan (9%).


### Referrals

• **470 referrals of retrospective abuse** in May 2022, 79 (20%) more than April 2022 (391) and 250 (114%) more than May 2021 (220). Brings to 2,111 the number of referrals for the first five months of 2022, 820 (64%) more than the same period in 2021 (1,291).

Data presented on retrospective cases of abuse (pages 8-10) for May and June 2021 is based on 15 areas. Data for Donegal and Sligo/Leitrim/West Cavan not available due to the impact of the cyber-attack.


### **Open Cases**

Note: all data on cases of retrospective abuse needs to be interpreted with caution due to concerns about the consistent interpretation of definitions.


#### **Number of Referrals**



### **Allocated Cases**

- **893 cases allocated to a social worker** at the end of May 2022, six fewer than at the end of April 2022 (899).
- Allocated cases account for 59% of open cases, up from 58% at the end of April 2022.

#### **Number of Allocated Cases**




### **Cases Awaiting Allocation of a Social Worker**

- **630 cases awaiting allocation** at the end of May 2022, 12 (2%) fewer than April 2022 (642) and the second consecutive decrease.
- Cases awaiting allocation account for 41% of open cases, down from 42% at the end of April 2022.
- Highest number of cases awaiting in Midwest (104) followed by Dublin North City (75), Cork (72), Galway/Roscommon (71), Donegal (52) and Dublin South West/Kildare/West Wicklow (47). These six areas account for 67% (421) of cases awaiting allocation. Two areas (Kerry and Mayo) has no cases awaiting allocation.




- **45 high priority cases awaiting allocation** at the end of May 2022, three fewer than April 2022 (48) and the second consecutive decrease after five consecutive monthly increases.
- High priority cases accounted for 7% of cases awaiting allocation at the end of May 2022 (630), no change from April 2022.
- High priority cases are reported by nine areas with the highest numbers reported by Midwest (16), Donegal (12) and Dublin South West/Kildare West Wicklow (6), Dublin North City (6).

- **5 areas reported an increase** in cases awaiting allocation from April 2022, Galway/Roscommon (up 8), Dublin South East/Wicklow (up 5), Dublin South Central (up 4), Cork (up 3) and Dublin North (up 1).
- **8 areas reported an decrease** with the largest decrease reported by Dublin South West/Kildare/West Wicklow (down 14) followed by Carlow/Kilkenny/South Tipperary (down 6) and Waterford/Wexford (down 5).
- The remaining four areas (Midlands, Cavan/Monaghan, Kerry, Mayo) reported no change.
- 41% (630) of open cases are awaiting allocation nationally, with nine areas reporting a percentage equal to or higher than the national average. Highest percentages reported by Dublin South Central (77%), Donegal (69%), Galway/Roscommon (65%) and Midwest (59%).

- 11/15 areas had more cases awaiting allocation at the end of May 2022 than May 2021, three areas had fewer cases. Of the remaining three areas Mayo reported no change while data for Donegal and Sligo/Leitrim/West Cavan was not available for May 2021 due to the HSE cyber-attack.
- Largest increases reported by Midwest (up 104), Dublin North City (up 32) and Dublin South East/Wicklow (up 30). Largest decrease reported by Kerry (down 70) followed by Waterford/Wexford (down 43) and Carlow/Kilkenny/South Tipperary (down 1).

# Mandated Reports<sup>1</sup> – Child Protection & Welfare

• **2,009 mandated reports of abuse** received in May 2022, 371 (23%) more than April 2022 (1,638). This brings to at least 8,974 mandated reports for the first five months of 2022, 2,062 (30%) more than the same period in 2021 (6,912).

It should be noted that the data presented for 2021 has been updated to reflect final validated figures for 2021. Data for 2022 is based on reports logged on NCCIS at the time the data was extracted for reporting. Reports logged after the date the data was extracted are not included, nor are figures updated until annual validation is complete.

 Mandated reports accounted for 26% (2,009) of all referrals received (7,607) in May 2022.


### Mandated reports by Month




- The number of mandated reports for May 2022, by area ranged from 35 (Sligo/Leitrim/West Cavan) to 246 (Cork).
- As a percentage of referrals, the highest percentage (44%) was reported by Mayo followed by Dublin North City (41%) and Dublin North (36%).
- The lowest percentages were reported by Waterford / Wexford (11%), Dublin South West/Kildare/West Wicklow (15%) and Midwest (17%)

• Highest number of reports for April 2022 were for emotional abuse (718; 44%) followed by physical abuse (384; 23%), sexual abuse (332; 20%) and neglect (204; 12%).

# **Mandated Reports – Child Protection & Welfare**

### **Source of Reports**

- Highest number of reports for May 2022 from An Garda Síochána (836; 42%) followed by teachers (399; 20%), social workers (193; 10%), safeguarding officers (99; 5%), social care workers (85; 4%), medical practitioners (82; 4%) and managers of domestic violence shelters (69; 3%). These seven sources account for 88% (1,763) of reports for May 2022.
- Highest number of reports year to date from An Garda Síochána (3,729; 42%) followed by teachers (1,607; 18%), social workers (1,104; 12%), safeguarding officers (434; 5%), social care workers (433; 5%), medical practitioners (348; 4%) and managers of domestic violence shelters (306; 3%). These seven sources account for 88% (7,961) of reports year to date.



- **446 mandated reports of retrospective abuse** in May 2022, brings to 2,019 the number of reports for the first five months of 2022.
- Mandated reports accounted for 95% of all reports of retrospective abuse received in May 2022 (470).
- The majority (85%; 379) of mandated reports for May 2022 were for sexual abuse.






## **Children in Care**

- **5,860 children in care at the end of May 2022**; nine fewer than April 2022 (5,869).
- 15 fewer children in care than the same time last year (5,875).
- 64% (3,742) of children in care are in general foster care, 26% (1,507) are in relative foster care, 7% (439) are in residential care and 3% (172) are in "other" care placements.
- 15 (3%) of the 439 children in residential placements are in special care



- Highest number of children in care reported by Cork (731) followed by Midwest (538) and Dublin North City (471).
- Fewest number reported by Sligo/Leitrim West Cavan (108) followed by the Social Work Team for Separated Children Seeking International Protection (137) and Mayo (143).
- Highest rate of children in care per 1,000 children was reported by Dublin North City (10.5/1,000) followed by Waterford/Wexford (5.9/1,000), Dublin South Central (5.6/1,000) and Midwest (5.6/1,000). Lowest rate reported by Dublin South East/Wicklow (2.5/1,000) followed by Dublin North (3.5/1,000) and Dublin South West/Kildare/West Wicklow (3.8/1,000).
- Seven areas reported a percentage equal to or higher than the national average of 4.8/1,000 children.



## **Children in Care**

• 825 (14%) children in care at the end of May 2022 were in placements with private providers, 11 (1%) more than April 2022 (814).

Note: data prior to November 2021 should be interpreted with caution due to the inclusion of a small number of children in residential care in placements with voluntary organisations.

• There were 73 (10%) more children in care in placements with private providers at the end of May 2022 than at the end of May 2021 (752).








- 88% (5,158) of children in care at the end of May 2022 had an allocated social worker; no change from April 2022.
- A total of 702 children were awaiting an allocated social worker, eight more than April 2022 (694).
- Highest number awaiting reported by Carlow/Kilkenny/South Tipperary (123) followed by Waterford/Wexford (121), Dublin North (84), Cork (51), Dublin South West/Kildare/West Wicklow (48) and Midwest (43). These six areas account for 67% (470) of all cases awaiting allocation.

- 97% (5,666) of children in care at the end of May 2022 had a care plan; no change from April 2022.
- A total of 194 children did not have a care plan, 34 (21%) more than April 2022 (160)
- Highest numbers with no care plan reported by Louth/Meath (38), Social Work Team for Separated Children Seeking International Protection (27) and Dublin North (23).

# **Child Protection Notification System**

- 925 children listed as "active" at the end of May 2022; 70 (7%) fewer than April 2022 (995) when the highest number for the period Jan 2021 Apr 2022 reported.
- There were 21 (2%) fewer children "active" at the end of May 2022 than May 2021 (946).
- All children listed as "active" at the end of May 2022 had an allocated social worker.
- Highest number of children listed as "active" at the end of May 2022 reported by Midwest (93) followed by Dublin South West/Kildare/West Wicklow (81), Carlow/Kilkenny/South Tipperary (79), Cork (74), Dublin North City (73) and Waterford/Wexford (72).
- Fewest number listed as "active" reported by Kerry (20) followed by Louth/Meath (21) and Sligo/Leitrim/West Cavan (26).
- Highest rate per 10,000 population under 18 years reported by Dublin North City (16.2/10,000) followed by Donegal (12.8/10,000) and Carlow/Kilkenny/South Tipperary (12.5/10,000).
- Lowest rates reported by Louth/Meath (2.3/10,000), Dublin South East/Wicklow (3.9/10,000) and Galway/Roscommon (5.3/10,000). Nine areas reported a rate equal to or higher than the national rate of 7.8/10,000
- 4/17 areas had more children listed as "active" at the end of May 2022 than April 2022. Largest increase reported by Dublin South Central (up 4) followed by Waterford/Wexford (up 3), Cavan/Monaghan (up 2) and Kerry (up 1). Largest decreases reported by Dublin South East/Wicklow (down 17), Midlands (down 17), Carlow/Kilkenny/South Tipperary (down 8) and Dublin North City (down 8).
- 9/17 areas had more children active at the end of May 2022 than at the same period last year. Largest increases reported by Galway/Roscommon (up 23), Cavan/Monaghan (up 16), Sligo/Leitrim/West Cavan (up 14), Dublin south central (up 10) and Waterford/Wexford (up 10). Largest decreases reported by Dublin South East/Wicklow (down 23), Cork (down 18), Midlands (down 17), Dublin North (down 16) and Kerry (down 16).

#### # Children "Active" on the CPNS












