## **Headline Data – May 2024**

#### **Child Protection & Welfare**

- 9,040 referrals in May 2024, 665 (8%) more than April 2024 (8,375) and 339 (4%) more than May 2023 (8,701). This brings to 40,641 the number of referrals for the first five months of 2024, 1,435 (4%) more than the same period in 2023 (39,206).
- 21,977 cases open to social work at the end of May 2024, 16 (<1%) more than April 2024 (21,961) and 768 (3%) fewer than May 2023 (22,745). Open cases include child protection and welfare cases including children in care.
- 77% (16,984) of cases open to social work at the end of April 2024 had an allocated worker, down from 78% at the end of April 2024. (Ref note on Page 4).
- **4,993 cases awaiting allocation** at the end of May 2024, 212 (4%) more than April 2024 (4,781). Second consecutive monthly increase. Cases awaiting allocation are down 827 (14%) from May 2023 (5,820).
- Six areas account for 65% (3,241) of cases awaiting allocation: Dublin South Central (1,196) followed by Louth/Meath (457), Cork (453), Dublin South West/Kildare/West Wicklow (423), Dublin South East/Wicklow (350) and Midwest (344).
- 10% (505) of cases awaiting allocation at the end of May 2024 were categorised as high priority, five more than April 2024 (500) and 16 (3%) more than May 2023 (489).

### **Children in Care**

- 5,796 children in care at the end of April 2024, 15 (<1%) more than April 2024 (5,781). This figure includes 142 children under the Service for Separated Children Seeking International Protection (SCSIP).
- 87.3% (5,062)\* of all children in care are in foster care (3,591 general foster care, and 1,471 relative foster), 8% (483) are in residential care (470 general residential care and 13 special care) and 4% (251) are in "other" care placements<sup>2</sup>.
- Across Tusla's 17 areas 89.1% (5,036/5,654) of children in care are in foster care.
- 931 (16%) children in care at the end of May 2024 were in placements with private providers, 30 (3%) more than April 2024 (901).
- 82% (4,746) of children in care at the end of May 2024 had an allocated worker. A total of 1,050 children were awaiting allocation, 13 (1%) fewer than April 2024 (1,063).
- 84% (4,854) of children in care at the end of May 2024 had an up-to-date care plan. A total of 942 children were awaiting an up-to-date care plan, 98 (9%) fewer than April 2024 (1,040).

## **Child Protection Notification System (CPNS)**

- 1,026 children listed as "active" at the end of May 2024, 7 (1%) more than April 2024 (1,019) and the fourth consecutive monthly increase.
- There were 154 (18%) more children "active" at the end of May 2024 than at the end of May 2023 (872).
- All children listed as "active" at the end of May 2024 had an allocated social worker.

## **Children's Services Regulation**

- **4,051** early years services on the register at the end of May **2024**, two fewer than April 2024 (4,053) and 13 (<1%) fewer than May 2024 (4,064).
- **202 inspections** of early years services done in May 2024. This brings to 981 the number of inspections for the first five months of 2024, 62 (6%) fewer than the same period in 2023 (1,043).
- 2,494 children on the register for home education at the end of May 2024, 22 (<1%) more than April 2024 (2,472) and 393 (19%) more than May 2023 (2,101).
- **926** children on a waiting list for assessment at the end of May **2024**, 47 (5%) fewer than April 2024 (973) and 459 (33%) fewer than May 2023 (1,385).

### **Tusla Education Support Services**

- **1,126 referrals screened** by senior educational welfare services in May 2024. This brings to 7,447 the number of referrals for the first nine months of the academic year 2023-2024, 1,678 (29%) more than the same period in 2022-2023 (5,769).
- 3,808 referrals on a waiting list for educational welfare services at the end of May 2024, 213 (5%) fewer than April 2024 (4,021) and the first decrease after six consecutive monthly increases.
- 14 more referrals on a waiting list at the end of May 2024 (3,808) compared to May 2023 (3,794).
- **400 new individual children worked** with in May 2024. This brings to 3,412 the number of new individual children worked with for the first nine months of the academic year 2023-2024, 565 (20%) more than the same period in 2022-2023 (2,847).

<sup>\*</sup>Decrease from previous months in the overall percentage of children in care in foster care is due to the inclusion of SCSIP as the majority of these children are placed in residential care.

## **Child Protection and Welfare**

#### Referrals<sup>1</sup>

- **9,040 referrals** in May 2024, 665 (8%) more than April 2024 (8,375) and 339 (4%) more than May 2023 (8,701).
- This brings to 40,641 the number of referrals for the first five months of 2024, 1,435 (4%) more than the same period in 2023 (39,206).

It should be noted that the data presented for 2023 has been updated to reflect final validated figures for this period. Data for 2024 is based on referrals logged on the Tusla Case Management (TCM) system at the time the data was extracted for reporting. Referrals logged after the date the data was extracted are not included, nor are figures updated until quarterly validation is complete.

### **Open Cases**

• 21,977 cases open to social work at the end of May 2024, 16 (<1%) more than April 2024 (21,961) and 768 (3%) fewer than May 2023 (22,745). Open cases from September 2023 include cases awaiting categorisation. See note below.

#### Notes:

- 1) From September 2023, open cases (allocated/unallocated) include cases "awaiting categorisation" at month end. This is in addition to cases categorised as high, medium and low. The category "awaiting categorisation" was introduced this year to reflect better questions being asked at screening and awaiting information for slightly longer.
- 2) Open cases include, all cases held on duty, allocated and unallocated child protection and welfare cases including children in care.
- 3) The data presented on cases is based on the status of cases on the TCM at month end.

### **Allocated Cases**


- **16,984 open cases were allocated** at the end of May 2024, 196 (1%) fewer than April 2024 (17,180) and 59 (<1%) more than May 2023 (16,925).
- Allocated cases account for 77% of open cases, down one percentage point from April 2024 (78%) and up three percentage points from May 2023 (74%).

These numbers of allocated cases reflect a changing environment in Tusla where allocation of cases to a social worker has become more difficult with reduced availability of social workers nationally. Many cases are now allocated to other professionals also reflecting the changing nature of social work teams. In many instances where cases are unallocated to a social worker there is a social care worker or leader allocated to the case.


#### # Referrals

<sup>&</sup>lt;sup>1</sup>Referrals include referrals meeting the eligibility criteria for child protection and welfare services, multiple reports of the same concern and referrals not meeting the eligibility criteria for child protection and welfare services. Referrals not meeting the eligibility criteria for child protection and welfare include: a request for diversion to another agency; a report in which there are no reasonable grounds for concern or no harm identified to a child indicated; a report that does not warrant a Tusla child protection and welfare led intervention (these could be children who need additional supports to stop problems or difficulties worsening but social work led intervention is not required and diversion to Prevention Partnership and Family Support is considered).


## **Child Protection & Welfare**

### **Cases Awaiting Allocation**


Cases awaiting allocation include cases held on duty, unallocated child protection and welfare cases including children in care

- **4,993 cases awaiting allocation** at the end of May 2024, 212 (4%) more than April 2024 (4,781). Second consecutive monthly increase.
- Cases awaiting allocation are down 827 (14%) from May 2023 (5,820).
- Cases awaiting allocation account for 23% of open cases (21,977), up one percentage point from April 2024 (22%).
- 36% (1,778) of cases awaiting allocation at the end of May 2024 were "active on duty". This means that actions were undertaken by dedicated duty teams or rotating social workers on a duty roster to progress the protection and welfare of the cases. Examples of actions undertaken include telephone calls relating to the concern, visits to see children, completing initial assessments and child in care reviews or care plans.
- Highest number of cases awaiting allocation reported by Dublin South Central (1,196) followed by Louth/Meath (457), Cork (453), Dublin South West/Kildare/West Wicklow (423), Dublin South East/Wicklow (350) and Midwest (344). These six areas account for 65% (3,241) of all cases awaiting allocation.
- 505 cases awaiting allocation at the end of May 2024 were categorised as high priority, five more than April 2024 (500) and 16 (3%) more than May 2023 (489).
- · High priority cases account for 10% of cases awaiting allocation.
- 56% (2,805) of cases awaiting allocation were categorised at medium priority, 32% (1,577) were low priority while the remaining 2% (106) were awaiting categorisation.
- Highest number of high priority cases reported by Midwest (122) followed by Dublin South Central (96), Donegal (51) and Midlands (43). These four areas account for 62% (312) of all high priority cases awaiting.


#### **Number of Unallocated Cases**

## **Child Protection & Welfare**

### **Cases Awaiting Allocation**

- 7/17 areas reported a decrease in cases awaiting allocation from April 2024.
- Largest decreases reported by Louth/Meath (down 52), Midlands (down 50) and Cavan/Monaghan (down 20).
- 10/17 areas reported an increase in cases awaiting allocation from April 2024. Largest increases reported by Dublin South West/Kildare/West Wicklow (up 72), Dublin South East/Wicklow (up 64) and Dublin North (up 51).
- Nationally 23% of open cases were awaiting allocation at the end of May 2024.
  Eight areas reported a percentage equal to or higher than the national average of
  23%, Dublin South Central (49%), Dublin South East/Wicklow (33%),
  Carlow/Kilkenny/South Tipperary (32%), Donegal (29%), Louth/Meath (28%),
  Dublin South West/Kildare/West Wicklow (28%), Midwest (25%) and
  Waterford/Wexford (23%).
- 9/17 areas had fewer cases awaiting allocation at the end of May 2024 than at the end of May 2023. Largest decreases reported by Waterford/Wexford (down 414), Cork (down 290), Dublin South West/Kildare/West Wicklow (down 262) and Dublin North (down 154).
- 8/17 areas had more cases awaiting allocation at the end of May 2024 than at the end of May 2023. Largest increases reported by Louth/Meath (up 190), Dublin South Central (up 162) and Midwest (113).


## Mandated Reports<sup>1</sup> – Child Protection & Welfare

• 2,738 mandated reports of abuse received in May 2024, 218 (9%) more than April 2024 (2,520) and 123 (4%) fewer than May 2024 (2,861). This brings to 12,779 the number of reports for the first five months of 2024, 373 (3%) more than the same period in 2023 (9,545).

It should be noted that the data presented for 2023 has been updated to reflect final validated figures for this period. Data for 2024 is based on referrals logged on the Tusla Case Management (TCM) system at the time the data was extracted for reporting. Referrals logged after the date the data was extracted are not included, nor are figures updated until quarterly validation is complete.

 Mandated reports accounted for 30% (2,738) of all referrals received (9,040) in April 2024.


#### **Mandated reports by Month**




- The number of mandated reports for May 2024, by area ranged from 68 (Mayo & Sligo/Leitrim/West Cavan) to 374 (Dublin North).
- As a percentage of referrals, the highest percentage (61%) was reported by Mayo.
- The lowest percentage was reported by Dublin South West/Kildare/West Wicklow (22%).

• Highest number of reports for May 2024 were for emotional abuse (1,067; 39%) followed by physical abuse (737; 27%), sexual abuse (550; 20%) and neglect (384; 14%)

## **Mandated Reports – Child Protection & Welfare**

### **Source of Reports**

- Highest number of reports for May 2024 from An Garda Síochána (886; 32%) followed by teachers (456; 17%), safeguarding officers (395; 14%); social workers (319; 12%) and social care workers (145; 5%). These five sources account for 80%% (2,201) of reports for April 2024.
- Highest number of reports for 2024 YTD from An Garda Síochána (4,756; 37%) followed by teachers (2,014; 16%), safeguarding officers (1,647; 13%), social workers (1,428; 11%), social care workers (600; 5%) and medical practitioners (447; 3%). These six sources account for 85% (10,892) of reports for 2024 YTD.


## **Children in Care**

- 5,796 children in care at the end of April 2024, 15 (<1%) more than April 2024 (5,781).
- Of these, 5,654 were reported by Tusla's 17 areas and 142 were reported by the Service for Separated Children Seeking International Protection (SCSIP).
- Across Tusla's 17 areas there were eight (<1%) more children in care at the end of May 2024 (5,654) than at the end of April 2024 (5,646) and 48 (<1%) more than at the end May 2023 (5,606).
- 87.3% (5,062)\* of all children in care are in foster care (3,591 general foster care, and 1,471 relative foster), 8% (483) are in residential care (470 general residential care and 13 special care) and 4% (251) are in "other" care placements<sup>2</sup>.
- Across Tusla's 17 areas 89.1% (5,036/5,654) of children in care are in foster care.

\*Decrease from previous months in the overall percentage of children in care in foster care is due to the inclusion of SCSIP; the majority of these children are placed in residential care.

- Highest number of children in care reported by Cork (682) followed by Midwest (506) and Dublin North City (474).
- Fewest number reported by Sligo/Leitrim West Cavan (113) followed by Mayo (141) and the Service for Separated Children Seeking International Protection (142).
- Across the 17 Areas the highest rate of children in care per 1,000 children was reported by Dublin North City (9.5) followed by Waterford/Wexford (6.2).
- Lowest rate reported by Dublin South East/Wicklow (2.3) followed by Dublin South West/Kildare/West Wicklow (3.7) and Dublin North (4.0).
- Nine areas reported a percentage equal to or higher than the national average of 4.6/1,000 children.



## **Children in Care**

• 931 (16%) children in care at the end of May 2024 were in placements with private providers, 30 (3%) more than April 2024 (901).




- **546 (59%)** children in placements with private providers were in **foster care**, **10** (2%) more than April 2024 (536).
- 313 (34%) children were in **residential care**, 18 (6%) more than April 2024 (295).
- The remaining 72 (8%) children were in "Other" care placements, 2 (3%) more than April 2024 (70). "Other" care placements include, disability units, mental health units, drug and alcohol rehabilitation centres etc.

Highest number of children in placements with private providers reported by Dublin North City (121) followed by Dublin South Central (109), Dublin South West/Kildare/West Wicklow (108), Dublin North (104) and Midlands (77). These five areas account for 56% (519) of children in placements with private providers,

## **Children in Care**

• 82% (4,746) of children in care at the end of May 2024 had an allocated worker.

These numbers of allocated cases reflect a changing environment in Tusla where allocation of cases to a social worker has become more difficult with reduced availability of social workers nationally. Many cases are now allocated to other professionals also reflecting the changing nature of social work teams. In many instances where cases are unallocated to a social worker there is a social care worker or leader allocated to the case.

- A total of 1,050 children were awaiting allocation, 13 (1%) fewer than April 2024 (1,063).
- Highest number awaiting allocation reported by Midwest (221; 44%) followed by Carlow/Kilkenny/South Tipperary (193; 62%), Dublin South West/Kildare/West Wicklow (162; 41%), Dublin South Central (99; 30%) and the Service for Separated Children Seeking International Protection (68; 48%). These five services account for 71% (743) of all cases awaiting allocation.

- 84% (4,854) of children in care at the end of May 2024 had an upto-date care plan.
- A total of 942 children were awaiting an up-to-date care plan, 98 (9%) fewer than April 2024 (1,040).
- Highest numbers awaiting an up-to-date care plan reported by Dublin North City (150; 32%), Midwest (95; 19%), Cork (94; 14%), Dublin South Central (85; 26%) and Louth/Meath (85; 20%).

#### Note:

Tusla has moved to reporting on children in care with an up-to-date care plan and not just children having a care plan, hence this data is not comparable with data previously reported. An up-to-date care plan is a care plan that has been updated following a statutory child in care review.



## **Child Protection Notification System**

- 1,026 children listed as "active" at the end of May 2024, 7 (1%) more than April 2024 (1,019) and the fourth consecutive monthly increase.
- There were 154 (18%) more children "active" at the end of May 2024 than at the end of May 2023 (872).
- All children listed as "active" at the end of May 2024 had an allocated social worker.
- Highest number of children listed as "active" at the end of May 2024 was reported by Midwest (135) followed by Dublin South West/Kildare/West Wicklow (121), Cork (107) and Dublin North City (106).
- Fewest number listed as "active" reported by Sligo/Leitrim/West Cavan (13) followed by Mayo (16), Dublin South East/Wicklow (20) and Kerry (20).
- The number of children "active" equates to about 8 children per 10,000 under 18 years.
- Highest rate per 10,000 population under 18 years reported by Dublin North City (21.3) followed by Midwest (14.0), Donegal (11.2) and Dublin South West/Kildare/West Wicklow (11.1).
- Lowest rates reported by Dublin South East/Wicklow (2.2), Mayo (5.0) and Sligo/Leitrim/West Cavan (5.3).
- Five areas reported a rate equal to or higher than the national rate of 8.4/10,000
- 8/17 areas had more children listed as "active" at the end of May 2024 than at the end of April 2024. Largest increases reported by Midwest (up 14) and Dublin South Central (up 12).
- 9/17 areas reported a decrease. Largest decreases reported by Dublin South East/Wicklow (down 15) and Donegal (down 11).
- 10/17 areas had more children active at the end of May 2024 than at the end of May 2023. Largest increases reported by Midwest (up 72), Dublin South West/Kildare/West Wicklow (up 34) and Louth/Meath (up 30).
- 7/17 areas reported a decrease. Largest decreases reported by Dublin South East/Wicklow (down 19), Waterford/Wexford (down 16) and Donegal (down 10).










### ALTERNATIVE EDUCATION ASSESSMENT AND REGISTRATION SERVICE


## **Tusla Education Support Services**

• **1,126 referrals screened** by senior educational welfare services in May 2024. This brings to 7,447 the number of referrals for the first nine months of the academic year 2023-2024, 1,678 (29%) more than the same period in 2022-2023 (5,769).


