Headline Data – November 2024

Child Protection & Welfare

- **8664 referrals** in November 2024, 759 (8%) fewer than October 2024 (9,423) and 667 (8%) more than November 2023 (7,997). Brings to 88,500 the number of referrals for the first 11 months of 2024, 3,196 (4%) more than the same period in 2023 (85,304).
- **22,427 cases open to social work** at the end of November 2024, 520 (2%) more than October 2024 (21,907) and 134 (1%) more than November 2023 (22,293). *Open cases include child protection and welfare cases including children in care.*
- 77% (17,263) of cases open to social work at the end of November 2024 had an allocated worker, down one percentage point from October 2024. (Ref note on Page 4).
- **5,164 cases awaiting allocation** at the end of November 2024, 313 (6%) more than October 2024 (4,851). Second consecutive monthly increase. Cases awaiting allocation are up 77 (2%) from November 2023 (5,087).
- Six areas account for 73% (3,772) of cases awaiting allocation: Dublin South Central (1,030), Dublin South West/Kildare/West Wicklow (780), Midlands (674), Cork (580), Louth/Meath (420) and Waterford/Wexford (288).
- 9% (442) of cases awaiting allocation at the end of November 2024 were categorised as high priority, 14 (3%) more than October 2024 (428) and 9 (2%) more than November 2023 (433).

Child Abuse Substantiation Procedure (CASP)

- **66 referrals assigned to CASP Teams in November 2024**. Brings to 655 the number of referrals assigned for the first 11 months of 2024, 272 (29%) fewer than the same period in 2023 (927).
- **713 assessments open at the end of November 2024**, 7 (1%) more than October 2024 (706) and 61 (8%) fewer than November 2023 (774).
- 77% (546/713) of assessments open at the end of November 2024 were allocated to a social worker, up two percentage point from October 2024 (75%), fourth consecutive monthly increase.
- Remaining 23% (167) were awaiting allocation with six fewer cases awaiting allocation at the end of November 2024 than at the end of October 2024 (173). Some 90 (35%) fewer assessments awaiting allocation at the end of November 2024 than at the end of November 2023 (257).

Children in Care

- **5,795 children (0-17 years) in care at the end of November 2024, 11 (<1%) more than October 2024 (5,784).** Figure includes 118 children under the Service for Separated Children Seeking International Protection (SCSIP)
- **87.3% (5,058)** of all children in care (17 Areas and SCSIP) are in **foster care** (3,588 general foster care, and 1,470 relative foster), **9% (524) are in residential care** (512 general residential care and 12 special care) and **3.7% (213) are in "other" care placements**.

Children in Care (contd.)

- Across Tusla's 17 areas 88.7% (5,038/5,677) of children in care are in foster care.
- 1,000 (17%) children in care at the end of November 2024 were in placements with private providers, 12 (1%) more than October 2024 (988).
- 86% (4,957) of children in care at the end of November 2024 had an allocated worker. A total of 838 children were awaiting allocation, 37 (4%) fewer than October 2024 (875).
- 84% (4,880) of children in care at the end of November 2024 had an up-to-date care plan. A total of 915 children were awaiting an up-to-date care plan, 41 (5%) more than October 2024 (874).

Child Protection Notification System (CPNS)

- **1,030 children listed as "active"** on the Child Protection Notification System (CPNS) at the end of November 2024, 6 (<1%) fewer than October 2024 (1,036), fourth consecutive monthly decrease.
- There were 68 (7%) more children "active" at the end of November 2024 than at the end of November 2023 (962).
- All children listed as "active" at the end of November 2024 had an **allocated social worker**.

Children's Services Regulation

- **4,042 early years services on the register at the end of November 2024**, two fewer than October 2024 (4,044) and one more than November 2023 (4,041).
- **259 inspections** of early years services in November 2024. This brings to 2,199 the number of inspections for the first 11 months of 2024, 78 (3%) fewer than the same period in 2023 (2,277).
- **2,226 children on the register** for home education at the end of November 2024, 25 (1%) more than October 2024 (2,201).
- **656 children on a waiting list for assessment at the end of November 2024**, 70 (10%) fewer than October 2024 (726) and 464 (41%) fewer than November 2023 (1,120).

Tusla Education Support Services

- 859 referrals screened by senior educational welfare services in November 2024. This brings to 1,924 the number of referrals for the first three months of the academic year 2024 2025, some 439 (30%) more than the same period in the previous academic year (1,485).
- **3,300 referrals on a waiting list** for educational welfare services at the end of November 2024, 82 (3%) more than October 2024 (3,218).
- 804 (32%) more referrals on a waiting list at the end of November 2024 (3,300) than at the end of November 2023 (2,496).

Child Protection and Welfare

Referrals¹

- **8664 referrals** in November 2024, 759 (8%) fewer than October 2024 (9,423) and 667 (8%) more than November 2023 (7,997).
- This brings to 88,500 the number of referrals for the first 11 months of 2024, 3,196 (4%) more than the same period in 2023 (85,304).

It should be noted that the data presented for the first six months of 2024 has been updated to reflect final validated figures for this period. Data for Jul-Nov 2024 is based on referrals logged on the Tusla Case Management (TCM) system at the time the data was extracted for reporting. Referrals logged after the date the data was extracted are not included, nor are figures updated until quarterly validation is complete.

Open Cases

• **22,427 cases open to social work** at the end of November 2024, 520 (2%) more than October 2024 (21,907) and 134 (1%) more than November 2023 (22,293).





Allocated Cases

- **17,263 open cases were allocated to a worker** at the end of November 2024, 207 (1%) more than October 2024 (17,056) and 57 (<1%) more than November 2023 (17,206).
- Allocated cases account for 77% of open cases, down one percentage point from October 2024 (78%).


These numbers of allocated cases reflect a changing environment in Tusla where allocation of cases to a social worker has become more difficult with reduced availability of social workers nationally. Many cases are now allocated to other professionals also reflecting the changing nature of social work teams. In many instances where cases are unallocated to a social worker there is a social care worker or leader allocated to the case.












¹Referrals include referrals meeting the eligibility criteria for child protection and welfare services, multiple reports of the same concern and referrals not meeting the eligibility criteria for child protection and welfare services. Referrals not meeting the eligibility criteria for child protection and welfare include: a request for diversion to another agency; a report in which there are no reasonable grounds for concern or no harm identified to a child indicated; a report that does not warrant a Tusla child protection and welfare led intervention (these could be children who need additional supports to stop problems or difficulties worsening but social work led intervention is not required and diversion to Prevention Partnership and Family Support is considered).




Cases Awaiting Allocation

Cases awaiting allocation include cases held on duty, unallocated child protection and welfare cases including children in care

- **5,164 cases awaiting allocation** at the end of November 2024, 313 (6%) more than October 2024 (4,851). Second consecutive monthly increase.
- Cases awaiting allocation are up 77 (2%) from November 2023 (5,087).
- Cases awaiting allocation account for 23% of open cases (22,427), up one percentage point from October 2024 (22%).
- **34% (1,766) of cases awaiting allocation at the end of November 2024 were "active on duty".** This means that actions were undertaken by dedicated duty teams or rotating social workers on a duty roster to progress the protection and welfare of the cases. Examples of actions undertaken include telephone calls relating to the concern, visits to see children, completing initial assessments and child in care reviews or care plans.
- Highest number of cases awaiting allocation reported by Dublin South Central (1,030) followed by Dublin South West/Kildare/West Wicklow (780), Midlands (674), Cork (580), Louth/Meath (420) and Waterford/Wexford (288). These six areas account for 73% (3,772) of all cases awaiting allocation.
- 442 cases awaiting allocation at the end of November 2024 were categorised as high priority, 14 (3%) more than October 2024 (428) and 9 (2%) more than November 2023 (433).
- · High priority cases account for 9% of cases awaiting allocation.
- 61% (3,147) of cases awaiting allocation were categorised at medium priority, 29% (1,488) were low priority while the remaining 2% (87) were awaiting categorisation.
- Highest number of high priority cases reported by Dublin South Central (69), Midlands (65), Carlow/Kilkenny/South Tipperary (61), Louth/Meath (58), Midwest (47) and Donegal (32). These six areas account for 75% (332) of all high priority cases awaiting.

Cases Awaiting Allocation

- 7/17 areas reported a decrease in cases awaiting allocation from October 2024.
- Largest decreases reported by Midwest (down 71), Cavan/Monaghan (down 20) and Waterford/Wexford (down 19).
- 10/17 areas reported an increase in cases awaiting allocation from October 2024. Largest increases reported by Cork (up 114), Midlands (up 107) and Dublin South West/Kildare/West Wicklow (up 93).
- Nationally 23% of open cases were awaiting allocation at the end of November 2024. Six areas reported a percentage equal to or higher than the national average of 23%. Highest percentages reported by Dublin South Central (45%), Dublin South West/Kildare/West Wicklow (40%), Midlands (35%), Carlow/Kilkenny/South Tipperary (33%), Louth/Meath (25%) and Cork (23%).
- 13/17 areas had fewer cases awaiting allocation at the end of November 2024 than at the end of November 2023. Largest decreases reported by Cork (down 218), Donegal (down 107) and Dublin North City (down 97)
- 4/17 areas had more cases awaiting allocation at the end of November 2024 than at the end of November 2023. Increases reported by Midlands (up 437), Dublin South West/Kildare/West Wicklow (up 235), Dublin South Central (up 64) and Louth/Meath (up 54).



Mandated Reports¹ – Child Protection & Welfare

• **2,686 mandated reports of abuse** received in November 2024, 245 (8%) fewer than October 2024 (2,931) and 171 (7%) more than November 2023 (2,515). This brings to 27,654 the number of reports for the first 11 months of 2024, 1,130 (4%) more than the same period in 2023 (26,524).

It should be noted that the data presented for the first six months of 2024 has been updated to reflect final validated figures for this period. Data for Jul-Nov 2024 is based on referrals logged on the Tusla Case Management (TCM) system at the time the data was extracted for reporting. Referrals logged after the date the data was extracted are not included, nor are figures updated until quarterly validation is complete.

• Mandated reports accounted for 31% (2,686) of all referrals received (8,664) in November 2024.




Mandated reports by Month


- The number of mandated reports for November 2024, by area ranged from 59 (Sligo/Leitrim/West Cavan) to 307 (Louth/Meath).
- As a percentage of referrals, the highest percentage (63%) was reported by Mayo.
- The lowest percentage (20%) was reported by Waterford/Wexford.

Highest number of reports for November 2024 were for emotional abuse (1,117; 42%) followed by physical abuse (758; 28%), sexual abuse (435; 16%) and neglect (376; 14%).









Mandated Reports – Child Protection & Welfare

Source of Reports

- Highest number of reports for November 2024 from An Garda Síochána (988; 37%) followed by teachers (487; 18%), safeguarding officer (361; 13%); social workers (269; 10%), social care workers (114; 4%), medical practitioners (78; 3%) and psychotherapists (70; 3%). These seven sources account for 88%% (2,367) of reports for November 2024.
- Highest number of reports for 2024 YTD from An Garda Síochána (10,452; 37.8%) followed by teachers (3,896; 14%), safeguarding officers (3,724; 14%), social workers (3,082; 11%), social care workers (1,296; 5%) and medical practitioners (936; 3%). These six sources account for 85% (23,386) of reports for 2024 YTD.

Child Abuse Substantiation Procedure (CASP)


It is Tusla's statutory obligation and responsibility to promote the welfare of children under Section 3 of the Child Care Act 1991 and under Section 8 (1)(b) of the Child and Family Agency Act 2013. In meeting this obligation and responsibility, where there is a need to share information with a relevant third party to protect an identified child or yet to be identified child or children from harm, Tusla must carry out an assessment of allegations of child abuse in line with fair procedures. This is called a 'substantiation assessment' – an assessment that examines and weighs up all the evidence and decides if the allegation is founded on the balance of probabilities. If the allegation is founded a determination is made that the person who is the subject of the abuse allegations poses a potential risk to a child or children. Tusla calls this process the CASP – Child Abuse Substantiation Procedure.


Referrals


Assessments Closed

Open Assessments at Month End







Allocation Status of Open Assessments

- 77% (546/713) of assessments open at the end of November 2024 were allocated to a social worker, up two percentage point from October 2024 (75%), fourth consecutive monthly increase.
- The remaining 23% (167) were awaiting allocation with six fewer cases awaiting allocation at the end of November 2024 than at the end of October 2024 (173).
- 90 (35%) fewer assessments awaiting allocation at the end of November 2024 than at the end of November 2023 (257).





Children in Care

- 5,795 children (0-17 years) in care at the end of November 2024, 11 (<1%) more than October 2024 (5,784). Figure includes 118 children under the Service for Separated Children Seeking International Protection (SCSIP)1.

- Residential care (524) includes 12 children in special care. Of the children in foster care (5,058), 71% (3,588) were in general foster care and 29% (1,470) were in relative foster care.
- Highest number of children in care reported by Cork (660) followed by . Midwest (493) and Dublin North City (463).
- Fewest number reported by the Service for Separated Children Seeking International Protection (118) and Sligo/Leitrim West Cavan (120).
- Across the 17 Areas the highest rate of children in care per 1,000 children was reported by Dublin North City (9.5) followed by Waterford/Wexford (6.3) and Donegal (5.6).
- Lowest rate reported by Dublin South East/Wicklow (2.3) followed by Dublin South West/Kildare/West Wicklow (3.8).
- Nine areas reported a percentage equal to or higher than the national average of 4.7/1,000 children.




Children in Care

1,000 (17%) children in care at the end of November 2024 were in placements with private providers, 12 (1%) more than October 2024 (988).



Children in Care with Private Providers

- 559 (56%) children in placements with private providers were in foster care, two more than October 2024 (557).
- **357 (36%)** children were in **residential care**, 10 (3%) more than October 2024 (347). .
- The remaining **84 (8.4%)** children were in **"Other" care placements**, no change • from November 2024. "Other" care placements include, disability units, mental health units, drug and alcohol rehabilitation centres etc.
- Highest number of children in placements with private providers reported by Dublin North City (127) followed by Dublin North (118), Dublin South West/Kildare/West Wicklow (116), Dublin South Central (114) and Midlands (86). These five areas account for 56% (561) of children in placements with private providers.

Children in Care

• 86% (4,957) of children in care at the end of November 2024 had an allocated worker with two areas reporting 100% (Donegal and Mayo), up one percentage point from October 2024 (85%).

These numbers of allocated cases reflect a changing environment in Tusla where allocation of cases to a social worker has become more difficult with reduced availability of social workers nationally. Many cases are now allocated to other professionals also reflecting the changing nature of social work teams. In many instances where cases are unallocated to a social worker there is a social care worker or leader allocated to the case.

- A total of 838 children were awaiting allocation, 37 (4%) fewer than October 2024 (875).
- Highest number awaiting allocation reported by Carlow/Kilkenny/South Tipperary (205; 66%) followed by Midwest (161; 33%), Dublin South West/Kildare/West Wicklow (119; 28%), Louth/Meath (66 ; 16%) and Dublin South Central (64; 20%). These five areas account for 73% (615) of all cases awaiting allocation.
- 84% (4,880) of children in care at the end of November 2024 had an up-to-date care plan, down one percentage point from October 2024 (85%).
- A total of 915 children were awaiting an up-to-date care plan, 41 (5%) more than October 2024 (874).
- Highest numbers awaiting an up-to-date care plan reported by Dublin South Central (116; 35%), Midwest (101; 20%), Dublin South West/Kildare/West Wicklow (96; 23%), Dublin North City (92; 20%) and Cork (92; 14%).



Child Protection Notification System

- **1,030 children listed as "active"** on the Child Protection Notification System (CPNS) at the end of November 2024, 6 (<1%) fewer than October 2024 (1,036), fourth consecutive monthly decrease.
- There were 68 (7%) more children "active" at the end of November 2024 than at the end of November 2023 (962).
- All children listed as "active" at the end of November 2024 had an **allocated social worker**.
- Highest number of children listed as "active" at the end of November 2024 was reported by Midlands (118) followed by Dublin North City (113), Dublin South West/Kildare/West Wicklow (106), Midwest (97) and Dublin South Central (107).
- Fewest number listed as "active" reported by Cavan/Monaghan (15) followed by Mayo (20) and Kerry (24).
- The number of children "active" equates to about 9 children per 10,000 under 18 years.
- Highest rate per 10,000 population under 18 years reported by Dublin North City (23.1) followed by Midlands (14.6) and Dublin South Central (13.0).
- Lowest rates reported by Dublin South East/Wicklow (3.6) and Cavan/Monaghan (4.0)
- Seven areas reported a rate equal to or higher than the national rate of 8.5/10,000
- 9/17 areas had more children listed as "active" at the end of November 2024 than at the end of October 2024. Largest increases reported by Donegal (up 8), Dublin North (up 7) and Dublin North City (up 6).
- 7/17 areas reported a decrease with the largest decreases reported by Midwest (down 14), Galway/Roscommon (down 10) and Dublin South West/Kildare/West Wicklow (down 7). The remaining area (Waterford/Wexford) reported no change.
- 10/17 areas had more children active at the end of November 2024 than at the end of November 2023. Largest increases reported by Midlands (up 59), Dublin South Central (up 47), Midwest (up 26), Galway/Roscommon (up 25).
- 7/17 areas reported a decrease. Largest decreases reported by Dublin North (down 43), Cork (down 33) and Donegal (down 32).



Number and rate of children "active" on the CPNS, by area (ranked by rate)









Children Awaiting Assessment for Registration


Tusla Education Support Services

- **3,300 referrals on a waiting list** for educational welfare services at the end of November 2024, 82 (3%) more than October 2024 (3,218).
