Headline Data – October 2023

Child Protection & Welfare

- 7.947 referrals in October 2023, 70 (1%) more than September 2023 (7,877) and 796 (11%) more than October 2022 (7,151). This brings to 76,716 the number of referrals for the first 10 months of 2023, 8,147 (12%) more than the same period in 2022 (68,569).
- 22,516 cases open to social work at the end of October 2023, 153 (1%) more than September 2023 (22,363) and 356 (2%) more than October 2022 (22,160). Note: comparison of data from September 2023 with previous months needs to be interpreted with caution due to the inclusion of cases awaiting categorisation from September 2023. Refer to note on page 4.
- 77% (17,236) of cases open to social work at the end of October 2023 had an allocated social worker.
- 5,280 cases awaiting allocation of a social worker at the end of October 2023, 110 (2%) fewer than September 2023 (5,390) and 1,403 (21%) fewer than January 2023 when a high of 6,683 was reported.
- Six areas account for 68% (3,602) of cases awaiting allocation: Dublin South Central (1,038), Cork (834), Dublin South West/Kildare/West Wicklow (589), (Louth/Meath (426), Waterford/Wexford (426) and Midwest (289).
- 9% (484) of cases awaiting allocation at the end of October 2023 were categorised as high priority, two more than September 2023 (482) and 97 (25%) more than October 2022 (387).

Children in Care

- 5,576 children in care at the end of October 2023. *Note: this data does not include children under the Service for Separated Children Seeking International Protection*
- Across the 17 Tusla areas there were 18 more children in care at the end of October 2023 than at the end of September 2023 (5,558) and 88 (2%) fewer than the same period in 2022 (5,664).
- 812 (15%) children in care at the end of October 2023 were in placements with private providers..
- Across the 17 Tusla areas there were 12 (2%) more children in care with private providers at the end of October 2023 than at the end of September 2023 (800).
- 80% (4,475) of children in care at the end of October 2023 had an allocated social worker, up one percentage point from September 2023 (79%).
- Across the 17 areas, a total of 1,101 children were awaiting an allocated social worker, 76 (6%) fewer than September 2023 (1,177).

Child Protection Notification System (CPNS)

- 975 children listed as "active" at the end of October 2023, 48 (5%) more than September 2023.
- There were 111 (13%) more children "active" at the end of October 2023 than at the end of October 2022 (864).
- All children listed as "active" at the end of October 2023 had an allocated social worker.

Children's Services Regulation

- 4,036 early years services on the register at the end of October 2023, six fewer than September 2023 (4,042) and 38 (<1%) fewer than October 2022 (4,074).
- 232 inspections of early years services done in October 2023. This brings to 2,020 the number of inspections for the first 10 months of 2023, 106 (5%) fewer than the same period in 2022 (2,126).
- 2,365 children on the register for home education at the end of October 2023, 56 (2%) more than September 2023 (2,309) and 441 (23%) more than October 2022 (1,924).
- 1,161 children on a waiting list for assessment at the end of October 2023, 88 (7%) fewer than September 2023 (1,249) and 354 (23%) fewer than October 2022 (1,515).

Tusla Education Support Services

- 514 referrals screened by senior educational welfare services in October 2023, 221 (75%) more than September 2023 (293). This brings to 807 the number of referrals for the first two months of the academic year 2023-2024, 77 (9%) fewer than the same period in 2022-2023 (884).
- 2,446 referrals on a waiting list for educational welfare services at the end of October 2023, 214 (8%) fewer than September 2023 (2,660). Fourth consecutive decrease after seventh consecutive increases.
- 401 new individual children worked with in October 2023, 76 (23%) more than September 2023 (325). This brings to 726 the number of new individual children worked with for the first two months of the academic year 2023-2024, 74 (11%) fewer than the same period in 2022-2023 (652).

Child Protection and Welfare

Referrals¹

• 7.947 referrals in October 2023, 70 (1%) more than September 2023 (7,877) and 796 (11%) more than October 2022 (7,151). This brings to 76,716 the number of referrals for the first 10 months of 2023, 8,147 (12%) more than the same period in 2022 (68,569).

It should be noted that the data presented for January – June 2023 has been updated to reflect final validated figures for this period. Data for remainder of 2023 is based on referrals logged on the Tusla Case Management (TCM) system at the time the data was extracted for reporting. Referrals logged after the date the data was extracted are not included, nor are figures updated until quarterly validation is complete.

Open Cases

• **22,516 cases open to social work** at the end of October 2023, 153 (1%) more than September 2023 (22,363) and 356 (2%) more than October 2022 (22,160). *Open cases from September 2023 include cases awaiting categorisation. See note below.*


Notes:

- 1) From September 2023, open cases (allocated/unallocated) include cases "awaiting categorisation" at month end. This is in addition to cases categorised as high, medium and low. The category "awaiting categorisation" was introduced this year to reflect better questions being asked at screening and awaiting information for slightly longer.
- 2) Open cases include, all cases held on duty, allocated and unallocated child protection and welfare cases including children in care.
- 3) The data presented on cases is based on the status of cases on the TCM at month end.


Allocated Cases

- 17,236 open cases were allocated to a social worker at the end of October 2023, 263 (2%) more than September 2023 (16,973) and 1,045 (6%) more than October 2022 (16,191). Note: comparison of data from September 2023 with previous months needs to be interpreted with caution due to the inclusion of cases awaiting categorisation from September 2023. Refer to notes above.
- Allocated cases account for 77% of open cases, up one percentage point from September 2023 (76%) and four percentage points from October 2022 (73%).


Number of Referrals

¹Referrals include referrals meeting the eligibility criteria for child protection and welfare services, multiple reports of the same concern and referrals not meeting the eligibility criteria for child protection and welfare services. Referrals not meeting the eligibility criteria for child protection and welfare include: a request for diversion to another agency; a report in which there are no reasonable grounds for concern or no harm identified to a child indicated; a report that does not warrant a Tusla child protection and welfare led intervention (these could be children who need additional supports to stop problems or difficulties worsening but social work led intervention is not required and diversion to Prevention Partnership and Family Support is considered).



Cases Awaiting Allocation of a Social Worker


Cases awaiting allocation include cases held on duty, unallocated child protection and welfare cases including children in care

- 5,280 cases awaiting allocation of a social worker at the end of October 2023, 110 (2%) fewer than September 2023 (5,390). Note: comparison of data from September 2023 with August 2023 and previous months needs to be interpreted with caution due to the inclusion of cases awaiting categorisation from September 2023. Refer to notes on previous page.
- There were 689 (12%) fewer cases awaiting allocation at the end of October 2023 than at the end of October 2022 (5,969) and 1,403 (21%) fewer than January 2023 when a high of 6,683 was reported.
- Cases awaiting allocation account for 23% of open cases (22,516), down one percentage point from September 2023 (24%).
- 60% (3,170) of cases awaiting allocation at the end of October 2023 were "active on duty". This means that actions were undertaken by dedicated duty teams or rotating social workers on a duty roster to progress the protection and welfare of the cases. Examples of actions undertaken include telephone calls relating to the concern, visits to see children, completing initial assessments and child in care reviews or care plans.
- Highest number of cases awaiting allocation reported by Dublin South Central (1,038) followed by Cork (834), Dublin South West/Kildare/West Wicklow (589), (Louth/Meath (426), Waterford/Wexford (426) and Midwest (289). These six areas account for 68% (3,602) of all cases awaiting allocation.
- 484 cases awaiting allocation at the end of October 2023 were categorised as high priority, two more than September 2023 (482) and 97 (25%) more than October 2022 (387).
- High priority cases account for 9% of cases awaiting allocation.
- 56% (2,949) of cases awaiting allocation were categorised at medium priority, 33% (1,737) were low priority while the remaining 2% (110) were awaiting categorisation.
- Highest number of high priority cases reported by Dublin South Central (71), Louth/Meath (63). DSW/K/WW (51), Midlands (49), WD/WX (43) and CW/K/ST (42). These six areas account for 66% (319) of all high priority cases awaiting.


Number of Unallocated Cases

Child Protection & Welfare

Cases Awaiting Allocation

- 8/17 areas reported a decrease in unallocated cases from September 2023.
- Largest decreases reported by Donegal (down 111; 35%), Waterford/Wexford (down 105; 20%), Dublin North (down 66; 29%) and Dublin South West/Kildare/West Wicklow (down 41; 7%).
- 8/17 areas reported an increase, in unallocated cases from September 2023. The largest increases were reported by Louth/Meath (up 106; 33%), Cork (51; 7%), Midlands (40; 20%) and Dublin South Central (29; 3%).
- The remaining area (Dublin South East/Wicklow) reported no change, from September 2023.

- Nationally 23% of open cases were unallocated at the end of October 2023. Seven areas reported a percentage equal to or higher than the national average of 23%, Dublin South Central (49%), Dublin South West/Kildare/West Wicklow (35%), Louth/Meath (31%), Carlow/Kilkenny/South Tipperary (31%), Cork (30%), Waterford/Wexford (28%) and Donegal (24%).
- 11/17 areas had fewer cases awaiting allocation at the end of October 2023 than at the end of October 2022. Largest decreases reported by Dublin North City (down 438; 63%), Dublin North (down 255; 61%), Waterford/Wexford (down 231; 35%), Dublin South East/Wicklow (down 210; 48%), DSW/K/WW (down 140; 19%) and CW/K/ST (down 118; 31%).
- Of the six areas that reported an increase, the largest increase was reported by Dublin South Central (up 275; 36%), Cork (up 217; 35%), Midwest (up 183; 173%) and Louth/Meath (up 118; 38%).


Mandated Reports¹ – Child Protection & Welfare

• 2,409 mandated reports of abuse received in October 2023, 71 (3%) more than September 2023 (2,338). This brings to 23,308 the number of reports for the first 10 months of 2023, 4,549 (24%) more than the same period in 2022 (18,759).

It should be noted that the data presented for Jan-Jun 2023 has been updated to reflect final validated figures for this period. Data for the remaining months of 2023 is based on referrals logged on the Tusla Case Management (TCM) system at the time the data was extracted for reporting. Referrals logged after the date the data was extracted are not included, nor are figures updated until quarterly validation is complete.

• Mandated reports accounted for 30% (2,409) of all referrals received (7,947) in October 2023.


Mandated reports by Month




- The number of mandated reports for October 2023, by area ranged from 52 (Donegal) to 320 (Louth/Meath).
- As a percentage of referrals, the highest percentage (68%) was reported by Mayo followed by Louth/Meath (44%).
- The lowest percentages were reported by Midlands (18%) and Midwest (20%),

• Highest number of reports for October 2023 were for emotional abuse (1,011; 42%) followed by physical abuse (624; 26%), sexual abuse (448; 19%) and neglect (326; 14%).

Source of Reports


- Highest number of reports for October 2023 from An Garda Síochána (877; 36%) followed by teachers (483; 20%), social workers (277; 12%), safeguarding officers (248; 10%), social care workers (86; 4%), medical practitioners (82; 3%), psychologists (61; 2.5%) and managers of domestic violence shelters (60; 2.5%). These eight sources account for 90% (2,174) of reports for October 2023.
- Highest number of reports for 2023 YTD from An Garda Síochána (9,414; 40%) followed by teachers (3,442; 15%), social workers (2,713; 12%), safeguarding officers (2,237; 10%), social care workers (1,082; 5%), medical practitioners (860; 4%) and psychotherapists (681; 3%). These seven sources account for 88% (20,429) of reports or 2023 YTD.

Children in Care


- 5,576 children in care at the end of October 2023. Note this data does not include children under the Service for Separated Children Seeking International Protection —data not available at this time.
- Across the 17 Tusla areas there were 18 more children in care at the end of October 2023 than at the end of September 2023 (5,558) and 88 (2%) fewer than the same period in 2022 (5,664).
- 90% (5,021) of children in care are in foster care (3,528 general foster care, 1,482 relative foster care and 11 in supported lodgings¹), 7% (403) in residential care (389 general residential care and 14 special care) and 152 (3%) are in "other" care placements².



Note: data for 2023 does not include children under the Service for Separated Children Seeking International Protection.

- Highest number of children in care reported by Cork (705) followed by Midwest (513), Dublin North City (455) and Waterford/Wexford (423)
- Fewest number reported by Sligo/Leitrim West Cavan (111) followed by Mayo (142) and Cavan/Monaghan (154).
- Highest rate of children in care per 1,000 children was reported by Dublin North City (10.1) followed by Waterford/Wexford (6.2). Lowest rate reported by Dublin South East/Wicklow (2.3) followed by Dublin South West/Kildare/West Wicklow (3.6).
- Nine areas reported a percentage equal to or higher than the national average of 4.7/1,000 children.

Children in Care

- 812 (15%) children in care at the end of October 2023 were in placements with private providers. Note: data for 2023 does not include children under the Service for Separated Children Seeking International Protection data not available at this time.
- Across the 17 Tusla areas there were 12 (2%) more children in care with private providers at the end of October 2023 than at the end of September 2023 (800). Note: comparison of data from February 2023 with data for previous months needs to be interpreted with caution due to validation of the data on implementation of the Tusla Case Management System (TCM) in February 2023.

- 495 (61%) children in placements with private providers were in **foster care**, 7 (1%) more than September 2023 (488).
- 261 (32%) children were in **residential care**, three more than September 2023 (258).
- The remaining 56 (7%) children were in "Other" care placements, up two (4%) from September 2023 (54). "Other" care placements include, disability units, mental health units, drug and alcohol rehabilitation centres etc.



Children in Care

- 80% (4,475) of children in care at the end of October 2023 had an allocated social worker, up one percentage point from September 2023 (79%). Note this data does not include children under the Service for Separated Children Seeking International Protection data not available at this time.
- Across the 17 areas, a total of 1,101 children were awaiting an allocated social worker, 76 (6%) fewer than September 2023 (1,177).
- Highest number awaiting reported by Carlow/Kilkenny/South Tipperary
 (191; 60%) followed by Midwest (161; 31%), Waterford/Wexford (124; 29%),
 Louth/Meath (120; 30%), DSW/K/WW (118; 30%) and Dublin South Central
 (96; 28%). These six areas account for 74% (810) of all cases awaiting
 allocation.

• 75% (4,185) of children in care at the end of October 2023 had an up-to-date care plan.



- 975 children listed as "active" at the end of October 2023, 48 (5%) more than September 2023.
- There were 111 (13%) more children "active" at the end of October 2023 than at the end of October 2022 (864).
- All children listed as "active" at the end of October 2023 had an allocated social worker.
- Highest number of children listed as "active" at the end of October 2023 was reported by Dublin South West/Kildare/West Wicklow (113) followed by Cork (111) and Dublin North (100).
- Fewest number listed as "active" reported by Cavan/Monaghan (15) followed by Mayo (20) and Sligo/Leitrim/West Cavan (28).
- Highest rate per 10,000 population under 18 years reported by Dublin North City (18.0) followed by Donegal (14.9) and Kerry (12.2).
- Lowest rate per 10,000 population under 18 years reported by Galway/Roscommon (3.8) followed by Cavan/Monaghan (4.1) and Dublin South East/Wicklow (5.0).
- Eight areas reported a rate equal to or higher than the national rate of 8.2/10,000
- 10/17 areas had more children listed as "active" at the end of October 2023 than at the end of September 2023. Largest increases reported by Midwest (up 24), Louth/Meath (up 12), Cork (up 9) and Dublin South East/Wicklow (9).

Children "Active" on the CPNS










