

# 1.0 PERFORMANCE OVERVIEW

This report provides an update on the performance and activity of Tusla services at the end of Q1 2024. It is structured around key performance and activity measures included in the Agency's Business Plan. The data presented was provided by services and refers to the latest performance and activity information available at this time. **These data can change from data previously published due to the ongoing validation of data.** 

The summary by service type set out below provides an overview of the Q1 2024 position regarding activity and performance.

# CHILD PROTECTION AND WELFARE SERVICES

# **REFERRALS** (data on referrals reported quarterly in arrears)

- 22,752 referrals to Child Protection and Welfare Services during Q4 2023. This brings to 91,924 the number of referrals for 2023, 9,069 (11%) more than 2022 (82,855).
- More than half of referrals for 2023 (59.5%; 54,721) were for welfare concerns, 38% (34,928) were for abuse/neglect, and the primary report type was not recorded for the remaining 2.5% (2,275) of referrals.
- Most common source of referrals in 2023 was members of An Garda Siochána accounting for 33% (30,666) of referrals, followed to a lesser extent by social workers (14%; 12,565), teachers (11%; 9,910) and safeguarding officers (9%; 8,199). Mandated persons accounted for 89% (82,020) of all sources.
- 55% (12,486/22,752) of referrals for Q4 2023 were closed following screening, 29% (6,572) of referrals for Q4 2023 progressed to the next stage of the referral process the preliminary enquiry stage. The remaining referrals (16%; 3,694) were either at the screening stage, awaiting closure following screening, or another process stage, when the data was extracted for reporting.
- 53% (6,672) of referrals for Q4 2023 were closed following screening as assessment / safety planning was already ongoing, while a further 35% (4,407) were closed to social work with no further action required, 7% (842) were diverted to Tusla's Prevention Partnership and Family Support (PPFS) services and 1% (148) were diverted to another agency.
- At the time the Q4 2023 data was extracted for reporting, 98% (6,460/6.572) of preliminary enquiries were completed.
- Of the preliminary enquiry completed, 45% (2,939) required no further action; 33% (2,119) required an initial assessment, while assessment / safety planning was ongoing in 5% (294) of cases. Some 11% (710) of referrals were closed with diversion to PPFS.
- At the time the Q4 2023 data was extracted for reporting, 55% (1,158/2,119) of initial assessments required following a preliminary enquiry were completed.
- 51% (593) of referrals that required an initial assessment following the preliminary enquiry were closed to social work following completion of the initial assessment. Of these 61% (362) required

- no further action, 17.5% (104) were diverted to another agency for a service, 17% (103) were diverted to Tusla PPFS service, while the remaining 4% (24) were closed as assessment/safety planning already ongoing.
- 30% (351) of referrals required safety planning following completion of the initial assessment, a further 15% (176) required a children protection response / child protection conference and 3% (38) required admission to care.

# **SOCIAL WORK ACTIVITY DATA**

- 22,293 cases open to social work nationally at the end of Q1 2024, 211 (1%) more than Q4 2023 (22,082) and 1,166 (5%) fewer than Q1 2023 (23,459).
- 79% (17,700) of open cases were allocated to a social worker at the end of Q1 2024, up three percentage points from Q4 2023 (76%).
- 4,593 (21%) cases were awaiting allocation, 738 (14%) fewer than Q4 2023 (5,331) and 1,375 (23%) fewer than Q1 2023 (5,968).
- Five areas account for 62% (2,840) of cases awaiting allocation, Dublin South Central (1,040; 23%), Louth/Meath (624; 14%), Cork (494; 11%), Dublin South West/Kildare/West Wicklow (364; 8%) and Midwest (318; 7%).
- 70% (3,227) of cases awaiting allocation at the end of Q1 2024 were "active" on a duty system.
- 8% (369) of cases awaiting allocation at the end of Q1 2024 were categorised as high priority, 79 (18%) fewer than Q4 2023 (448) and 32 (8%) fewer than Q1 2023 (401).
- 55% (2,508) of cases awaiting allocation were categorised at medium priority, 35% (1,607) were low priority while the remaining 2% (109) were awaiting categorisation.
- 60% (2,740/4,593) of cases awaiting allocation at the end of Q1 2024 were waiting three months or less and of these 53% (1,439) were waiting less than one month.
- 55% (202/369) of high priority cases awaiting allocation at the end of Q1 2024 were waiting 3 months or less and of these 61% (123) were waiting less than one month.

# **CHILD PROTECTION NOTIFICATION SYSTEM**

- 1,007 children listed as 'active' on the Child Protection Notification System (CPNS) at the end of Q1 2024, 45 (5%) more than Q4 2024 (962) and the fifth consecutive increase.
- 157 (18%) more children "active" at the end of Q1 2024 than at the end of Q1 2023 (850).
- 82% (822/1,007) of children were listed as "active" for no longer than 12 months, down slightly from 83% (796/962) at the end of Q4 2023.
- 7% (72/1,007) of children were listed as "active" for > 18 months, down slightly from 8% (73/962) at the end of Q4 2023.
- All children listed as "active" at the end of Q1 2024 had an allocated social worker.

# **ALTERNATIVE CARE SERVICES**

### **CHILDREN IN CARE**

- 5,760 children in care at the end of Q1 2024. This figure includes 144 children reported by the Service for Separated Children Seeking International Protection (SCSIP). Across the 17 Tusla areas there was one more child in care at the end of Q1 2024 than at the end of Q4 2023 (5,615).
- 87.5% (5,042) of children in care were in foster care (general, relative) at the end of Q1 2024 and 8.2% (472) were in a residential (general and special care) placement. The remaining 4.3% (246) of children were in "Other" care placements. "Other" includes at home under a care order, supported lodgings, detention centre, disability unit, hospital, special emergency arrangement, not specified etc.
- Across the 17 Areas, 89% (5,016/5,616) were in foster care, 7.2% (405) were in residential care and the remaining 3.5% (195) were in "other" care placements.
- 891 (15%) children in care at the end of Q1 2024 were in placements with private providers.
   Across the 17 areas there were 8 (1%) more children in placements with private providers at the end of Q1 2024 (836) than at the end of Q4 2023 (828).
- 83% (4,777) of children in care at the end of Q1 2024 had an allocated social worker. A total of 983 (17%) children were awaiting allocation of a social worker at the end of Q1 2024.
- 80% (4,627) of children in care had an up-to-date care plan. A total of 1,133 (20%) of children were awaiting an up-to-date care plan.
- 97% (3,588/3,720) of children in care aged 6 to 15 years (inclusive) were in full time education at the end of Q1 2024, no change from Q4 2023.
- 93% (884/950) of children in care aged 16 and 17 years were in full time education at the end of Q1 2024, no change from Q4 2023.

### **AFTERCARE**

- 128 referrals for an aftercare service in Q1 2024.
- 2,932 young persons/adults in receipt of aftercare services at the end of Q1 2024, 28 (1%) more than Q4 2023 (2,904) and 29 (1%) fewer than Q1 2023 (2,961).
- 76% (1,673/2,207) of those 18-22 years inclusive in receipt of an aftercare service at the end of Q1 2024 were in education/accredited training.
- 81% (2,388) of young persons/adults in receipt of aftercare services at the end of Q1 2024 had an aftercare plan, down two percentage point from Q4 2023 (83%). A total of 544 were awaiting a plan, 63 (13%) greater than Q4 2023 (481).
- 90% (2,035/2,265) of those assessed as needing an aftercare worker had an aftercare worker at the end of Q1 2021, no change from Q4 2023. A total of 230 young people were awaiting an aftercare worker at the end of Q1 2024, eight more than Q4 2023 (222).
- 98% (269/274) of young people < 18 years assessed as needing an aftercare worker had an aftercare worker at the end of Q1 2024.

• 89% (1,766/1,991) of 18–22-year-olds assessed as needing an aftercare worker had an aftercare worker at the end of Q1 2024.

### **ADOPTION SERVICES**

- 47 new children referred for adoption during Q1 2024. At least 216 new children referred for adoption in 2023. Data for Q1 and Q2 2023 incomplete.
- 44 completed initial assessments awaiting allocation to a social worker for full assessment at the end of Q1 2024. Of these, 20 (45%) were waiting for 0-8 weeks, 7 (16%) were waiting > 8 weeks to 16 weeks (inclusive) while the remaining 17 (39%) were waiting more than 16 weeks.

### **FOSTER CARERS**

- 3,847 foster carers (all types minus Brussels II Regulation) on the panel of approved foster carers at the end of Q1 2024, seven (<1%) fewer than Q4 2023 (3,854) and 94 (2%) fewer than Q1 2023 (3,941).
- 56 Tusla foster carers (general & relative) and 14 private foster carers approved in Q1 2024.
- 15 applicants to be general foster carers awaiting assessment at the end of Q1 2024 with a further 13 applicants awaiting approval by the foster care committee.
- 61 applications for general foster care and 120 applications for relative foster care in progress at the end of Q1 2024.
- 94% (2,072) of general foster carers on the panel had an allocated link (social) worker at the end of Q1 2024, up one percentage point from Q4 2023 (93%)
- 144 general foster carers were awaiting an allocated link worker, 12 (8%) fewer than Q4 2023 (156).
- 95% (945) of relative foster carers on the panel had an allocated link (social) worker at the end of Q1 2024, no change from Q4 2023.
- 53 relative foster carers on the panel were awaiting an allocated link worker at the end of Q1 2024, no change from Q4 2023.
- 95% (180) of unapproved relative foster carers who had a child placed with them for >12 weeks had an allocated link (social) worker. A total of 10 carers were awaiting a link worker, three fewer than Q4 2023 (13). The 10 carers were reported across three areas.

# CHILDREN'S SERVICES REGULATION

# **EARLY YEARS INSPECTORATE**

- 4,049 early years services (EYS) on the register nationally at the end of Q1 2024, five more than Q4 2023 (4,044) and 13 (<1%) fewer than Q1 2023 (4,062).
- 552 inspections (all types) carried out in Q1 2024, 54 (9%) fewer than Q1 2023 (606). A total of 2,391 inspections carried out in 2023.
- 182 incidents notified to the Inspectorate in Q1 2024. A total of 855 incidents notified in 2023.

- 84 unsolicited information submissions received by the Inspectorate during Q1 2024. A total of 490 unsolicited information submissions received by the Inspectorate during 2023.
- 9 services were found to have closed in Q1 2024. A total of 115 services were found to have closed in 2023.

# **ALTERNATIVE CARE INSPECTION & MONITORING SERVICE**

- 166 non-statutory residential centres at the end Q1 2024; 2 (1%) more than Q4 2023 (164).
- 48 inspections (all types) were conducted in Q1 2024.
- 5 non-statutory foster care services at the end Q1 2024, no change from Q4 2023. Two non-statutory foster care services visited, and two monitoring visits conducted during Q1 2024.

# **ALTERNATIVE EDUCATION ASSESSMENT AND REGISTRATION SERVICE**

#### **Home Education**

- 2,455 children on the register for home education at the end of Q1 2024, eight more than Q4 2023 (2,447) and 395 (19%) more than Q1 2023 (2,060).
- 287 applications received for home education during Q1 2024, 39 (12%) fewer than Q4 2023 (326) and 65 (18%) fewer than Q1 2023 (352).
- 284 assessments (all types) for home education carried out in Q1 2024, 35 (11%) fewer than Q4 2023 (319) and 59 (26%) more than Q1 2023 (225).
- 1,062 children on a waiting list for assessment at the end of Q1 2024, 38 (3%) fewer than Q4 2023 (1,100) and 375 (26%) fewer than Q1 2023 (1,437).

## **Independent Schools**

- 60 assessed independent schools on the register at the end of Q1 2024, up two from Q4 2023 (58).
- 6,434 children in assessed independent schools at the end of Q1 2024 with 4,733 of these children
  on the register.
- 14 schools due for assessment at the end of Q1 2024.

# **TUSLA EDUCATION SUPPORT SERVICES**

# **Educational Welfare: Academic Year September 2023 – August 2024**

- 5,050 referrals screened by senior educational welfare officers (EWO) for the seven months Sept -Mar 2024, 842 (20%) more than the same period in the previous academic year (4,208).
- 3,429 screened referrals on a waiting list at the end of March 2024, 49 (1%) fewer than March 2023 (3,478).
- 2,586 new individual children worked with for the seven months Sep Mar 2024, 278 (12%) more than the same period in the previous academic year (2,308).
- 491 school attendance notices (SANs) issued for the seven months Sep Mar, 129 (36%) more than the same period in the previous academic year (362). The SANs issued were in respect of 348 individual children, 95 (38%) more than the same period in the previous academic year (253).

- 61 summonses issued for the seven months Sep-Mar 2023, 4 (6%) fewer than the same period in the previous academic year (65). The summonses were in respect of 50 individual children, 6 (14%) more than the same period in the previous academic year (44).
- 193 Section 24 meetings convened by EWOs for the seven months Sep-Mar 2024, 12 (7%) more than the same period in the previous academic year (181).

# **FAMILY SUPPORT SERVICES**

# Family Support Services (data reported bi-annually, Q2 and Q4)

Family Support Services includes those services funded through a Service Arrangement with the Agency and those funded internally and delivered through the Agency. Data needs to be interpreted in the context of varying response rates.

- At least 19,792 children were in receipt of family support services at the end 2023. This equates to almost 2% of children (0-17 years). Based on a response rate of 89%.
- At least 25,087 children referred to family support services during the last six months of 2023. This brings to 47,260 the number of children referred for 2023. This equates to about 4.0% of children (0-17 years).
- 64% (30,092) of children referred to family support services in 2023 received a service during 2023. The percentage who received a service ranged from 34% (Sligo/Leitrim/West Cavan) to 96% (Mayo). Nine areas reported a percentage equal to or higher than the national average of 64%.

# Meitheal (data reported bi-annually, Q2 and Q4)

- 1,163 Meitheal processes requested during the last six months of 2023. This brings to 2,492 the number of processes requested for 2023, 172 (7%) more than 2022 (2,320).
- The most common pathway for all requests received during 2023 was "Direct Access" accounting for 73% (1,820) of requests. "Social Work Diversion" accounted for a further 20% (490) while "Social Work Step-Down" accounted for 7% (182) of requests.
- 84% (2,095/2,492) of Meitheal requests received during 2023 proceeded to Stage 2 (Discussion Stage).
- 1,725 Meitheal processes reached completion of Stage 2 in 2023.
- 53% (911) of processes reaching completion of Stage 2 proceeded to delivery (Stage 3) (Meitheal Support Meeting).
- 1,473 Meitheal processes were closed during 2023.
- 23% (334) of all Meitheal processes were closed following submission of a Meitheal request form (Stage 1); 36% (535) were closed following completion of the Strengths and Needs Form (Stage 2 Discussion Stage); 12% (177) were closed following commencement of Meitheal support meetings (Stage 3) and 29% (427) were closed post-delivery.
- 120 Child and Family Support Networks1 (CFSN) operating at the end of 2023 with a further eight planned/pre planning stage.

# **PEOPLE & CHANGE**

- 5,025 whole time equivalent (WTE) staff (excluding agency staff) employed by Tusla at the end of Q1 2024, 6 (<1%) more than Q4 2023 (5,019) and 244 (5%) more than Q1 2023 (4,781).
- 169 new staff joined Tusla (came onto Tusla's payroll) in the first three months of 2024, 60 (26%) fewer than the same period in 2023 (229).
- 101 staff left Tusla (i.e., resigned, career breaks, excluding retirements) in the first three months of 2024, 19 (16%) fewer than the same period in 2023 (120). A further, 28 staff retired in the first three months of 2024, 7 (33%) more than the same period in 2023 (21).
- At the end of Q1 2024, the overall absence rate for the Agency was 6.7%, down from 7.5% at the end of Q4 2023 and up from 6.03% at the end of Q1 2023.
- e-learning training activity: 7,889 completions were achieved in Q1 2024
- Classroom training: 1,290 participants attended in Q1 2024.

# **FINANCE**

- The outturn for the year to date (March YTD) is an overspend of €14.443 million (5%)
- The net expenditure is €282.790 million against a budget allocation of €268.346 million.
- Pay costs are under-spent against budget by €1.365 million.
- Non-pay costs are over-spent against budget year to date by €16.568 million.



# 2.1 REFERRALS (CHILD WELFARE AND CHILD ABUSE/NEGLECT)

### **Number of Referrals**

• 22,752 referrals to Child Protection and Welfare Services during Q4 2023<sup>1</sup>. This brings to 91,924 the number of referrals for 2023, 9,069 (11%) more than 2022 (82,855).



• More than half of referrals for 2023 (59.5%; 54,721) were for welfare concerns, 38% (34,928) were for abuse/neglect, and the primary report type was not recorded for the remaining 2.5% (2,275) of referrals (Tables 1 and 2).

# **Referrals by Area**

- The number of referrals for 2023 equates to about 75 referrals per 1,000 population under 18 years. *Note, the actual number of children referred is likely to be fewer has more than one referral can be received in relation to a child.* The rate of referrals ranges from about 40 per 1,000 (Dublin South East/Wicklow) to 110 per 1,000 (Midlands and Dublin North City). Eight areas reported a rate equal to or higher than the national average of 75/1,000.
- The highest number of referrals for 2023 was reported by Dublin North (9,341) followed by Midlands (8,889), Dublin South West/Kildare/West Wicklow (8,873) and Cork (8,333). The fewest number was reported by Mayo (1,320) followed by Sligo/Leitrim/West Cavan (1,517) and Donegal (2,572). A breakdown of referrals by area is presented in Table 3 below.

# **Source of Referrals**

• The most common source of referrals in 2023 was members of An Garda Síochána accounting for 33% (30,666) of referrals, followed to a lesser extent by social workers (14%; 12,565), teachers (11%; 9,910) and safeguarding officers (9%; 8,199). Mandated persons accounted for 89% (82,020) of all sources. The source of all referrals is presented in Table 4 below.

# **Screening**

- 55% (12,486/22,752) of referrals for Q4 2023 were closed following screening (Table 8).
- 29% (6,572) of referrals for Q4 2023 progressed to the next stage of the referral process the preliminary enquiry stage. The remaining referrals (16%; 3,694) were either at the screening stage, awaiting closure following screening, or another process stage, when the data was extracted for reporting.

- 51% (593) of referrals that required an initial assessment following the preliminary enquiry were closed to social work following completion of the initial assessment. - 70% (3,227) of cases awaiting allocation at the end of Q1 2024 were "active" on a duty system.
- 8% (369) of cases awaiting allocation at the end of Q1 2024 were categorised as high priority, 79 (18%) fewer than Q4 2023 (448) and 32 (8%) fewer than Q1 2023 (401).
- 55% (2,508) of cases awaiting allocation were categorised at medium priority, 35% (1,607) were low priority while the remaining 2% (109) were awaiting categorisation.
- 60% (2,740/4,593) of cases awaiting allocation at the end of Q1 2024 were waiting three months or less and of these 53% (1,439) were waiting less than one month.
- 55% (202/369) of high priority cases awaiting allocation at the end of Q1 2024 were waiting 3 months or less and of these 61% (123) were waiting less than one month.


#### Number of open cases by year

- The number of open of cases ranged from 2,538 (11%) in Cork to 346 (2%) in Sligo/Leitrim/West Cavan. Eight of the 17 areas had between 1,000 and 2,000 cases; a further six areas had fewer than 1,000 cases while the remaining three areas (Cork, Dublin North and Dublin South Central) had in excess of 2,000 cases.
- 8 areas reported an increase in open cases from Q4 2023. The largest increases were reported by Louth/Meath (up 271), Dublin South Central (up 189) and Dublin South East/Wicklow (up 80).





The actions undertaken must have occurred within the monthly MTP reporting period. There must be evidence of actions progressing the protection and welfare of the child and not simply a management review of a file. These cases will form a separate category on the MTP returns template under cases awaiting allocation.

- Dublin South Central reported the highest number of cases awaiting allocation (1,040; 23%) followed by Louth/Meath (624; 14%), Cork (494; 11%), Dublin South West/Kildare/West Wicklow (364; 8%) and Midwest (318; 7%). These five areas account for 62% (2,840) of cases awaiting allocation.
- 5 areas reported an increase in cases awaiting allocation from Q4 2023 with the largest increases reported by Louth/Meath (up 223), Galway/Roscommon (up 68), Midlands (up 15) and Donegal (up 14).
- 12 areas reported a decrease with the largest decreases reported by Cork (down 252), Dublin North City (down 250), Dublin South West/Kildare/West Wicklow (down 185) and Waterford/Wexford (down 111).

- The highest number of high priority cases was reported by Midwest (84) followed by Midlands (81), Dublin South Central (39), Louth/Meath (35) and Galway/Roscommon (32). These five areas account for 73% (271) of all high priority cases awaiting.



- All children listed as "active" at the end of Q1 2024 had an allocated social worker.
- 1,007 children listed as 'active' on the Child Protection Notification System (CPNS)<sup>5</sup> at the end of Q1 2024, 45 (5%) more than Q4 2024 (962) and the fifth consecutive increase.
- 157 (18%) more children "active" at the end of Q1 2024 than at the end of Q1 2023 (850).



- The number listed as "active" equates to about 8 children per 10,000 under 18 years and ranges from 4.2/10,000 in Dublin South East/Wicklow to 16.7/10,000 in Dublin North City, double the national average. Seven areas reported a rate equal to or higher than the national average.
- Dublin South West/Kildare/West Wicklow reported the highest number (119) of children "active", followed by Midwest (118) and Cork (108). Sligo/Leitrim/West Cavan reported the fewest number (13) followed by Kerry (17), Cavan/Monaghan (21) and Mayo (21).



# 3.1 CHILDREN IN CARE (FOSTER CARE / RESIDENTIAL CARE)

#### **KEY FACTS**

- 5,760 children in care at the end of Q1 2024. This figure includes 144 children reported by the Service for Separated Children Seeking International Protection (SCSIP). Across the 17 Tusla areas there was one more child in care at the end of Q1 2024 than at the end of Q4 2023 (5,615).
- 87.5% (5,042) of children in care were in foster care (general, relative) at the end of Q1 2024 and 8.2% (472) were in a residential (general and special care) placement. The remaining 4.3% (246) of children were in "Other" care placements. "Other" includes at home under a care order, supported lodgings, detention centre, disability unit, hospital, special emergency arrangement, not specified etc.
- Across the 17 Areas, 89% (5,016/5,616) were in foster care, 7.2% (405) were in residential care and the remaining 3.5% (195) were in "other" care placements.
- 891 (15%) children in care at the end of Q1 2024 were in placements with private providers. Across the 17 areas there were 8 (1%) more children in placements with private providers at the end of Q1 2024 (836) than at the end of Q4 2023 (828).
- 83% (4,777) of children in care at the end of Q1 2024 had an allocated social worker. A total of 983 (17%) children were awaiting allocation of a social worker at the end of Q1 2024.
- 80% (4,627) of children in care had an up-to-date care plan. A total of 1,133 (20%) of children were awaiting an up-to-date care plan.
- 97% (3,588/3,720) of children in care aged 6 to 15 years (inclusive) were in full time education at the end of Q1 2024, no change from Q4 2023.
- 93% (884/950) of children in care aged 16 and 17 years were in full time education at the end of Q1 2024, no change from Q4 2023.

#### 3.1.1 Number of Children in Care

• 5,760 children in care at the end of Q1 2024. This figure includes 144 children reported by the Service for Separated Children Seeking International Protection. Across the 17 Tusla areas there was one more child in care at the end of Q1 2024 than at the end of Q4 2023 (5,615).

- Across the 17 areas the number of children in care ranged from 690 in Cork to 112 in Sligo/Leitrim/West Cavan.
- Dublin North City reported the highest rate of children in care per 1,000 population under 18 years (9.5), more than double the national rate, followed by Waterford/Wexford (6.1), Donegal (5.1) and Midwest (5.1). Lowest rate reported by Dublin South East/Wicklow (2.3) followed by Dublin South West/Kildare/West Wicklow (3.6) and Dublin North (3.9).





Number of children in placements with private providers





- 95% (2,265/2,388) of those with an aftercare plan were assessed as needing an aftercare worker. Thirteen areas along with the Service for SCSIP reported 100%.









## 6.1 FAMILY SUPPORT SERVICES<sup>14</sup>

#### **KEY FACTS**

Data needs to be interpreted in the context of varying response rates

- At least 19,792 children were in receipt of family support services at the end 2023. This equates to almost 2% of children (0-17 years). *Based on a response rate of 89%*.
- At least 25,087 children referred to family support services during the last six months of 2023. This brings to 47,260 the number of children referred for 2023. This equates to about 4.0% of children (0-17 years).
- 64% (30,092) of children referred to family support services in 2023 received a service during 2023. The percentage who received a service ranged from 34% (Sligo/Leitrim/West Cavan) to 96% (Mayo). Nine areas reported a percentage equal to or higher than the national average of 64%.

The data presented below needs to be interpreted in the context of varying response rates.

## **6.1.1 Family Support Providers**

- 399 family support providers commissioned (H2 2023)
- 89% (356) of services commissioned provided data for H2 2023, up from 82% (347/421) in H1 2023. Response rate ranged from 50% (Midlands) to 100% in six areas (Dublin South Central, Cavan/Monaghan, Midwest, Galway/Roscommon, Mayo and Donegal).

## 6.1.6 Parenting Support Service

- 9,879 parents/guardians/care givers were referred to a parenting support service during the last six months of 2023. This brings to 19,877 the number referred for 2023.

#### 6.2 MEITHEAL

A key component of Tusla's Prevention, Partnership and Family Support (PPFS) programme of work is the roll-out of **Meitheal** - a national practice model (common approach to practice) for all agencies working with children, young people and their families. This model is designed to ensure that the needs and strengths of children and their families are effectively identified and understood and responded to in a timely way so that children and families get the help and support needed to improve children's outcomes and realise their rights. It is an early intervention response tailored to the needs of an individual child or young person and is used where more than one agency involvement is needed. There are three stages of the Meitheal process; preparation, discussion and delivery.

#### **KEY FACTS**

- 1,163 Meitheal processes requested during the last six months of 2023. This brings to 2,492 the number of processes requested for 2023, 172 (7%) more than 2022 (2,320).
- The most common pathway for all requests received during 2023 was "Direct Access" accounting for 73% (1,820) of requests. "Social Work Diversion" accounted for a further 20% (490) while "Social Work Step-Down" accounted for 7% (182) of requests.
- 84% (2,095/2,492) of Meitheal requests received during 2023 proceeded to Stage 2 (Discussion Stage).
- 1,725 Meitheal processes reached completion of Stage 2 in 2023.
- 53% (911) of processes reaching completion of Stage 2 proceeded to delivery (Stage 3) (Meitheal Support Meeting).
- 1,473 Meitheal processes were closed during 2023.
- 23% (334) of all Meitheal processes were closed following submission of a Meitheal request form (Stage 1); 36% (535) were closed following completion of the Strengths and Needs Form (Stage 2 Discussion Stage); 12% (177) were closed following commencement of Meitheal support meetings (Stage 3) and 29% (427) were closed post-delivery.








