## **1.0 PERFORMANCE OVERVIEW**

This report provides an update on the performance and activity of Tusla services at the end of Q2 2024. It is structured around key performance and activity measures included in the Agency's Business Plan. The data presented was provided by services and refers to the latest performance and activity information available at this time. **These data can change from data previously published due to the ongoing validation of data.** 

The summary by service type set out below provides an overview of the Q2 2024 position regarding activity and performance.

## CHILD PROTECTION AND WELFARE SERVICES

## **REFERRALS (data on referrals reported quarterly in arrears)**

- 23,599 referrals to Child Protection and Welfare Services during Q1 2024, 847 (4%) more than Q4 2023 (22,752) and 216 (1%) fewer than Q1 2023 (23,815).
- More than half of referrals for Q1 2024 (59%; 13,833) were for welfare concerns, 41% (9,641) were for abuse/neglect, and the primary report type was not recorded for the remaining <1% (125) of referrals
- Most common source of referrals in Q1 2024 was members of An Garda Síochána accounting for 33% (7,854) of referrals, followed to a lesser extent by teachers (13%; 2,970), social workers (12%; 2,739) and safeguarding officers (11%; 2,549). Mandated persons accounted for 90% (21,317) of all sources.
- 56% (13,156/23,599) of referrals for Q1 2024 were closed following screening. 29% (6,776) progressed to the next stage of the referral process the preliminary enquiry stage. The remaining referrals (16%; 3,667) were either at the screening stage, awaiting closure following screening, or another process stage, when the data was extracted for reporting.
- 52% (6,871) of referrals for Q1 2024 were closed following screening, as assessment / safety planning was already ongoing, while a further 34% (4,514) were closed to social work with no further action required, 9% (1,123) were diverted to Tusla's Prevention Partnership and Family Support (PPFS) services and 2% (198) were diverted to another agency.
- At the time the Q1 2024 data was extracted for reporting, 99% (6,687/6.776) of preliminary enquiries were completed.
- Of the preliminary enquiry completed, 44% (2,968) required no further action; 35% (2,323) required an initial assessment, while assessment / safety planning was ongoing in 5% (344) of cases. Some 9% (616) of referrals were closed with diversion to PPFS
- At the time the Q1 2024 data was extracted for reporting, 56% (1,308/2,323) of initial assessments required following a preliminary enquiry were completed.
- 54% (706) of referrals that required an initial assessment following the preliminary enquiry were closed to social work following completion of the initial assessment. Of these 58% (413) required no further action, 20% (139) were diverted to another agency for a service, 15% (109) were

diverted to Tusla PPFS service, while the remaining 6% (45) were closed as assessment/safety planning already ongoing.

• 25% (329) of referrals required safety planning following completion of the initial assessment, a further 18% (236) required a children protection response / child protection conference and 3% (37) required admission to care.

## SOCIAL WORK ACTIVITY DATA

- 21,408 cases open1 to social work nationally at the end of Q2 2024, 885 (4%) fewer than Q1 2024 (22,293) and 1,403 (6%) fewer than Q2 2023 (22,811).
- 77% (16,509) of open cases were allocated to a worker<sup>1</sup> at the end of Q2 2024, down two percentage points from Q1 2024 (79%).
- 4,899 (23%) cases were awaiting allocation, 306 (7%) more than Q1 2024 (4,593) and 799 (14%) fewer than Q2 2023 (5,698).
- Six areas account for 67% (3,265) of cases awaiting allocation, Dublin South Central (1,194), Cork (482), Dublin South West/Kildare/West Wicklow (462), Louth/Meath (450), Dublin South East/Wicklow (340) and Midwest (337).
- 33% (1,627) of cases awaiting allocation at the end of Q2 2024 were "active" on a duty system.
- 10% (500) of cases awaiting allocation at the end of Q2 2024 were categorised as high priority, 131 (36%) more than Q1 2024 (369) and 24 (5%) fewer than Q2 2023 (524).
- 58% (2,855) of cases awaiting allocation were categorised at medium priority, 30% (1,465) were low priority while the remaining 2% (79) were awaiting categorisation.
- 62% (3,014/4,899) of cases awaiting allocation at the end of Q2 2024 were waiting three months or less and of these 45% (1,366) were waiting less than one month.
- 65% (327/500) of high priority cases awaiting allocation at the end of Q2 2024 were waiting 3 months or less and of these 58% (191) were waiting less than one month.

## CHILD PROTECTION NOTIFICATION SYSTEM

- 1,024 children listed as 'active' on the Child Protection Notification System (CPNS) at the end of Q2 2024, 17 (2%) more than Q1 2024 (1,007) and the sixth consecutive increase.
- 135 (15%) more children "active" at the end of Q2 2024 than at the end of Q2 2023 (889).
- 83% (850/1,024) of children were listed as "active" for no longer than 12 months, up slightly from 82% (822/1,007) at the end of Q1 2024.
- 5% (56/1,024) of children were listed as "active" for > 18 months, down from 7% (72/1,007) at the end of Q1 2024.
- All children listed as "active" at the end of Q2 2024 had an allocated social worker.

<sup>&</sup>lt;sup>1</sup> The number of allocated cases reflects a changing environment in Tusla where allocation of cases to a social worker has become more difficult with reduced availability of social workers nationally. Many cases are now allocated to other professionals also reflecting the changing nature of social work teams. In many instances where cases are unallocated to a social worker there is a social care worker or leader allocated to the case.

## **ALTERNATIVE CARE SERVICES**

## **CHILDREN IN CARE**

- 5,804 children in care at the end of Q2 2024, 44 (<1%) more than Q1 2024 (5,760). This figure (5,804) includes 141 children reported by the Service for Separated Children Seeking International Protection.
- 87.4% (5,072) of all children in care were in foster care (general, relative) at the end of Q2 2024, 8.4% (488) were in a residential care (general and special care) placement, while the remaining 4.2% (244) were in "Other" care placements. "Other" includes at home under a care order, supported lodgings, detention centre, disability unit, hospital, special emergency arrangement, not specified etc.
- Across the 17 Areas, 89.1% (5,046/5,663) of children were in foster care, 7.3% (411) were in residential care and the remaining 3.6% (206) were in "other" care placements.
- 946 (16%) children in care at the end of Q2 2024 were in placements with private providers, 55 (6%) more than Q1 2024 (891).
- Across the 17 areas there were 39 (5%) more children in placements with private providers at the end of Q2 2024 (875) than at the end of Q1 2024 (836).
- 80% (4,671) of children in care at the end of Q2 2024 had an allocated worker. Some 1,133 (20%) children were awaiting allocation of worker at the end of Q2 2024, 150 (15%) more than Q1 2024 (983).
- 84% (4,847) of children in care had an up-to-date care plan. A total of 957 (16%) of children were awaiting an up-to-date care plan, 176 (16%) fewer than Q1 2024 (1,133).
- 95% (3,552/3,742) of children in care aged 6 to 15 years (inclusive) were in full time education at the end of Q2 2024, down two percentage points from Q1 2024 (97%).
- 92% (891/965) of children in care aged 16 and 17 years were in full time education at the end of Q2 2024, down one percentage point from Q1 2024 (93%).

## AFTERCARE

- 179 referrals for an aftercare service in Q2 2024. This brings to 307 the number of referrals for the first six months of 2024, 41 (15%) more than the same period in 2023 (266).
- 2,915 young persons/adults in receipt of aftercare services at the end of Q2 2024, six (<1%) fewer than Q1 2024 (2,921) and 73 (2%) fewer than Q2 2023 (2,988).
- 77% (1,681/2,176) of those 18-22 years inclusive in receipt of an aftercare service at the end of Q2 2024 were in education/accredited training.
- 82% (2,394) of young persons/adults in receipt of aftercare services at the end of Q2 2024 had an aftercare plan, up one percentage point from Q1 2024 (81%). A total of 521 were awaiting a plan, 26 (5%) fewer than Q1 2024 (547).
- 89% (2,025/2,288) of those assessed as needing an aftercare worker had an aftercare worker at the end of Q2 2024, down one percentage point from Q1 2024. A total of 263 young people were awaiting an aftercare worker at the end of Q2 2024, 33 (14%) more than Q1 2024 (230).

- 99% (291/294) of young people < 18 years assessed as needing an aftercare worker had an aftercare worker at the end of Q2 2024.
- 87% (1,734/1,994) of 18–22-year-olds assessed as needing an aftercare worker had an aftercare worker at the end of Q2 2024.

## **ADOPTION SERVICES**

- 42 new children referred for adoption during Q2 2024. This brings to 89 the number of new children referred for adoption during the first six months of 2024. A total of 225 new children referred for adoption in 2023.
- 47 completed initial assessments awaiting allocation to a social worker for full assessment at the end of Q2 2024. Of these, 23 (49%) were waiting for 0-8 weeks, 14 (30%) were waiting > 8 weeks to 16 weeks (inclusive) while the remaining 10 (21%) were waiting more than 16 weeks.

## **FOSTER CARERS**

- 3,842 foster carers (all types minus Brussels II Regulation) on the panel of approved foster carers at the end of Q2 2024, two (<1%) fewer than Q1 2024 (3,844) and 25 (<%) fewer than Q2 2023 (3,867).
- 51 Tusla foster carers (22 general & 29 relative) and seven private foster carers approved in Q2 2024. This brings to 107 the number of Tusla foster carers (50 general and 57 relative) and 18 the number of private foster carers approved in the first six months of 2024.
- 16 applicants to be general foster carers awaiting assessment at the end of Q2 2024 with a further six applicants awaiting approval by the foster care committee.
- 70 applications for general foster care and 130 applications for relative foster care in progress at the end of Q2 2024.
- 93% (2,053) of general foster carers on the panel had an allocated link (social) worker at the end of Q2 2024, down one percentage point from Q1 2024 (94%)
- 162 general foster carers were awaiting an allocated link worker, 18 (13%) more than Q1 2024 (144).
- 95% (943) of relative foster carers on the panel had an allocated link (social) worker at the end of Q2 2024, no change from Q1 2022.
- 50 relative foster carers on the panel were awaiting an allocated link worker at the end of Q2 2024, three fewer than Q1 2024 (53).
- 96% (167) of unapproved relative foster carers who had a child placed with them for >12 weeks had an allocated link (social) worker. A total of seven carers were awaiting a link worker, three fewer than Q1 2024 (10). The seven carers were reported across two areas.

## **CHILDREN'S SERVICES REGULATION**

## EARLY YEARS INSPECTORATE

- 4,026 early years services (EYS) on the register nationally at the end of Q2 2024, 23 (<1%) fewer than Q1 2024 (4,049) and Q2 2023 (4,049).
- 617 inspections (all types) carried out in Q2 2024. This brings to 1,169 the number of inspections for the first six months of 2024, 65 (5%) fewer than the same period in 2023 (1,234).
- 195 incidents notified to the Inspectorate in Q2 2024, bringing the number notified for the first six months of 2024 to 377. A total of 855 incidents notified in 2023.
- 108 unsolicited information submissions received by the Inspectorate during Q2 2024, bringing the number of submissions for the first six months of 2024 to 192. A total of 490 unsolicited information submissions received by the Inspectorate during 2023.
- 32 services were found to have closed in the first six months of 2024, bringing the number for the first six months of 2024 to 41. A total of 115 services were found to have closed in 2023.

## **ALTERNATIVE CARE INSPECTION & MONITORING SERVICE**

- 170 non-statutory residential centres at the end Q2 2024; 4 (2%) more than Q1 2024 (166).
- 54 inspections (all types) were conducted in Q2 2024, bringing to 102 the number of inspections for the first six months of 2024. A total of 102 inspections were also carried out during the same period in 2023.
- 5 non-statutory foster care services at the end Q2 2024, no change from Q1 2024. Two nonstatutory foster care services visited, and two monitoring visits conducted during the first six months of 2024.

## **ALTERNATIVE EDUCATION ASSESSMENT AND REGISTRATION SERVICE**

#### Home Education

- 2,536 children on the register for home education at the end of Q2 2024, 81 (3%) more than Q1 2024 (2,455) and 373 (17%) more than Q2 2023 (2,163).
- 271 applications1 received for home education during Q2 2024, bringing to 558 the number of applications received for the first six months of 2024, 39 (7%) fewer than the same period in 2023 (597).
- 357 assessments (all types) for home education carried out in Q2 2024, bringing to 641 the number of assessments carried out for the first six months of 2024, 205 (47%) more than the same period in 2023 (436).
- 876 children on a waiting list for assessment at the end of Q2 2024, 186 (18%) fewer than Q1 2024 (1,062) and 479 (35%) fewer than Q2 2023 (1,355).

#### **Independent Schools**

• 61 assessed independent schools on the register at the end of Q2 2024, up one from Q1 2024 (60).

- 6,545 children in assessed independent schools at the end of Q2 2024 with 4,627 of these children on the register.
- 6 schools due for assessment at the end of Q2 2024.

## **TUSLA EDUCATION SUPPORT SERVICES**

## Educational Welfare: Academic Year September 2023 – August 2024

- 7,747 referrals screened by senior educational welfare officers (EWO) for the 10 months Sept Jun 2024, 1,024 (15%) more than the same period in the previous academic year (6,723).
- 4,165 screened referrals on a waiting list at the end of June 2024, 132 (3%) more than June 2023 (4,033).
- 3,579 new individual children worked with for the 10 months Sep Jun 2024, 536 (18%) more than the same period in the previous academic year (3,043).
- 646 school attendance notices (SANs) issued for the 10 months Sep Jun, 156 (32%) more than the same period in the previous academic year (490). The SANs issued were in respect of 467 individual children, 125 (37%) more than the same period in the previous academic year (342).
- 122 summonses issued for the 10 months Sep- Jun 2023, 17 (16%) more than the same period in the previous academic year (105). The summonses were in respect of 103 individual children, 34 (49%) more than the same period in the previous academic year (69).
- 264 Section 24 meetings convened by EWOs for the 10 months Sep-Jun 2024, 11 (4%) more than the same period in the previous academic year (253).

## FAMILY SUPPORT SERVICES

## Family Support Services (data reported bi-annually, Q2 and Q4)

Family Support Services includes those services funded through a Service Arrangement with the Agency and those funded internally and delivered through the Agency. Data needs to be interpreted in the context of varying response rates.

- At least 437 family support providers commissioned (H1 2024), *based on data from 16/17 areas.* 84% (368) of services provided data for H1 2024.
- At least 21,333 children were in receipt of family support services at the end of H1 2024. This equates to almost 2% of children (0-17 years).
- At least 24,613 children were referred to family support services during the first six months of 2024. This equates to about 2.0% of children (0-17 years).
- 64% (15,662) of children referred to family support services during the first six months of 2024 received a service during that period. The percentage who received a service ranged from 33% (Waterford/Wexford) to 95% (Sligo/Leitrim/West Cavan). Eleven areas reported a percentage equal to or higher than the national average of 64%.

## Meitheal (data reported bi-annually, Q2 and Q4)

- 1,414 Meitheal processes requested during the first six months of 2024.
- The most common pathway for requests received during the first six months of 2024 was "Direct Access" accounting for 66% (935) of requests. "Social Work Diversion" accounted for a further 24% (345) while "Social Work Step-Down" accounted for 9.5% (134) of requests.
- 80% (1,129/1,414) of Meitheal requests received during the first six months of 2024 proceeded to Stage 2 (Discussion Stage).
- 885 Meitheal processes reached completion of Stage 2 in the first six months of 2024.
- 54% (476) of processes reaching completion of Stage 2 proceeded to delivery (Stage 3) (Meitheal Support Meeting).
- 961 Meitheal processes were closed during the first six months of 2024.
- 30% (290) of all Meitheal processes were closed following submission of a Meitheal request form (Stage 1); 27% (260) were closed following completion of the Strengths and Needs Form (Stage 2 Discussion Stage); 13% (125) were closed following commencement of Meitheal support meetings (Stage 3); 30% (286) were closed post-delivery.
- 118 Child and Family Support Networks (CFSN) operating at the end of Q2 2024 with a further nine planned/pre planning stage.

## **PEOPLE & CHANGE**

- 5,125 whole time equivalent (WTE) staff (excluding agency staff) employed by Tusla at the end of Q2 2024, 100 (2%) more than Q1 2024 (5,025) and 287 (6%) more than Q2 2023 (4,838).
- 390 new staff joined Tusla (came onto Tusla's payroll) in the first six months of 2024, 93 (19%) fewer than the same period in 2023 (483).
- 201 staff left Tusla (i.e., resigned, career breaks, excluding retirements) in the first six months of 2024, 16 (7%) fewer than the same period in 2023 (217). A further 65 staff retired in the first six months of 2024, 9 (16%) more than the same period in 2023 (56).
- At the end of Q2 2024, the overall absence rate for the Agency was 6.79%, up slightly from 6.7% at the end of Q1 2024 (6.7%) and up 1.55 percentage points from Q2 2023 (5.24%).
- e-learning training activity: 11,572 completions were achieved in Q2 2024
- Classroom training: 2,604 participants attended in Q2 2024.

## FINANCE

- The outturn for the year to date (June YTD) is an overspend of €28,092 million (5%)
- The net expenditure is €549,196 million against a budget allocation of €521,104 million.
- Pay costs are under-spent against budget by €3,074 million.
- Non-pay costs are over-spent against budget year to date by €31,587 million.



## **Number of Referrals**

• More than half of referrals for Q1 2024 (59%; 13,833) were for welfare concerns, 41% (9,641) were for abuse/neglect, and the primary report type was not recorded for the remaining <1% (125) of referrals (Tables 1 and 2).

#### **Referrals by Area**

- The number of referrals for Q1 2024 equates to about 19 referrals per 1,000 population under 18 years. *Note, the actual number of children referred is likely to be fewer as more than one referral can be received in relation to a child.* The rate of referrals ranges from about 10 per 1,000 (Dublin South East/Wicklow) to 30 per 1,000 (Dublin South Central). Seven areas reported a rate equal to or higher than the national average of 19/1,000.
- The highest number of referrals for Q1 2024 was reported by Dublin South West/Kildare/West Wicklow (2,384) followed by Midlands (2,328), Dublin North (2,210), Cork (2,209) and Dublin South Central (2,116). The fewest number was reported by Sligo/Leitrim/West Cavan (364) followed by Mayo (377) and Kerry (558). A breakdown of referrals by area is presented in Table 3 below.

### **Source of Referrals**

• The most common source of referrals in Q1 2024 was members of An Garda Síochána accounting for 33% (7,854) of referrals, followed to a lesser extent by teachers (13%; 2,970), social workers (12%; 2,739) and safeguarding officers (11%; 2,549). Mandated persons accounted for 90% (21,317) of all sources. The source of all referrals is presented in Table 4 below.

## Screening

- 56% (13,156/23,599) of referrals for Q1 2024 were closed following screening (Table 8).
- 29% (6,776) of referrals for Q1 2024 progressed to the next stage of the referral process the preliminary enquiry stage. The remaining referrals (16%; 3,667) were either at the screening stage, awaiting closure following screening, or another process stage, when the data was extracted for reporting.

- 54% (706) of referrals that required an initial assessment following the preliminary enquiry were closed to social work following completion of the initial assessment. Of these 58% (413) required no further action, 20% (139) were diverted to another agency for a service, 15% (109) were diverted to Tusla PPFS service, while the remaining 6% (45) were closed as assessment/safety planning already ongoing.
- 25% (329) of referrals required safety planning following completion of the initial assessment, a further 18% (236) required a children protection response / child protection conference and 3% (37) required admission to care.

- 77% (16,509) of open cases were allocated to a worker at the end of Q2 2024, down two percentage points from Q1 2024 (79%).
- 4,899 (23%) cases were awaiting allocation, 306 (7%) more than Q1 2024 (4,593) and 799 (14%) fewer than Q2 2023 (5,698).
- Six areas account for 67% (3,265) of cases awaiting allocation, Dublin South Central (1,194), Cork (482), Dublin South West/Kildare/West Wicklow (462), Louth/Meath (450), Dublin South East/Wicklow (340) and Midwest (337).
- 33% (1,627) of cases awaiting allocation at the end of Q2 2024 were "active" on a duty system.
- 10% (500) of cases awaiting allocation at the end of Q2 2024 were categorised as high priority, 131 (36%) more than Q1 2024 (369) and 24 (5%) fewer than Q2 2023 (524).
- 58% (2,855) of cases awaiting allocation were categorised at medium priority, 30% (1,465) were low priority while the remaining 2% (79) were awaiting categorisation.
- 62% (3,014/4,899) of cases awaiting allocation at the end of Q2 2024 were waiting three months or less and of these 45% (1,366) were waiting less than one month.
- 65% (327/500) of high priority cases awaiting allocation at the end of Q2 2024 were waiting 3 months or less and of these 58% (191) were waiting less than one month.

- The number of open of cases ranged from 2,381 (11%) in Cork to 268 (1%) in Sligo/Leitrim/West Cavan. Nine of the 17 areas had between 1,000 and 2,000 cases; a further six areas had fewer than 1,000 cases while the remaining two areas (Cork and Dublin South Central) had in excess of 2,000 cases.
- 4 areas reported an increase in open cases from Q1 2024. The largest increase was reported by Galway/Roscommon (up 175) followed by Cavan/Monaghan (up 70).
- Of the 13 areas that reported a decrease, the largest decreases were reported by Dublin North (down 252), Midlands (down 202) and Cork (down 157).



#### Number of open cases by area



• 77% (16,509) of open cases were allocated to a worker at the end of Q2 2024, down two percentage points from Q1 2024 (79%). Note: data from September 2023 includes cases awaiting categorisation, hence comparison with previous quarters needs to be interpreted with caution.<sup>4</sup>

**Note:** the number of allocated cases reflects a changing environment in Tusla where allocation of cases to a social worker has become more difficult with reduced availability of social workers nationally. Many cases are now allocated to other professionals also reflecting the changing nature of social work teams. In many instances where cases are unallocated to a social worker there is a social care worker or leader allocated to the case.



These six areas account for 67% (3,265) of cases awaiting allocation.
- 10 areas reported an increase in cases awaiting allocation from Q1 2024 with the largest increases reported by Dublin South Central (up 154), Dublin South West/Kildare/West Wicklow (up 98) and Dublin South East/Wicklow (up 89).
- 7 areas reported a decrease with the largest decrease reported by Louth/Meath (down 174) followed by Galway/Roscommon (down 31).




#### Number of open cases awaiting allocation by area

- 10% (500) of cases awaiting allocation at the end of Q2 2024 were categorised as high priority, 131 (36%) more than Q1 2024 (369) and 24 (5%) fewer than Q2 2023 (524).
- 58% (2,855) of cases awaiting allocation were categorised at medium priority, 30% (1,465) were low priority while the remaining 2% (79) were awaiting categorisation.
- The highest number of high priority cases was reported by Dublin South Central (102) followed by Midwest (96), Louth/Meath (56) and Midlands (53). These four areas account for 61% (307) of all high priority cases awaiting.



- 1,024 children listed as 'active' on the Child Protection Notification System (CPNS)<sup>6</sup> at the end of Q2 2024, 17 (2%) more than Q1 2024 (1,007) and the sixth consecutive increase.
- 135 (15%) more children "active" at the end of Q2 2024 than at the end of Q2 2023 (889).



#### Number "Active" on CPNS


- The number listed as "active" equates to about 8 children per 10,000 under 18 years and ranges from 2.9/10,000 in Dublin South East/Wicklow to 19.7/10,000 in Dublin North City, more than double the national average. Seven areas reported a rate equal to or higher than the national average.
- Midwest reported the highest number (139) of children "active", followed by Dublin South West/Kildare/West Wicklow (121) and Cork (103). Sligo/Leitrim/West Cavan reported the fewest number (15) followed by Mayo (17) and Cavan/Monaghan (21).

- 7/17 areas reported an increase in the number "active" from Q1 2024. The largest increases were reported by Dublin South Central (up 30), Midwest (up 21) and Dublin North City (up 15).







- 77% (1,681/2,176) of those 18-22 years inclusive in receipt of an aftercare service at the end of Q2 2024 were in education/accredited training.
- 82% (2,394) of young persons/adults in receipt of aftercare services at the end of Q2 2024 had an aftercare plan, up one percentage point from Q1 2024 (81%). A total of 521 were awaiting a plan, 26 (5%) fewer than Q1 2024 (547).
- 89% (2,025/2,288) of those assessed as needing an aftercare worker had an aftercare worker at the end of Q2 2024, down one percentage point from Q1 2024. A total of 263 young people were awaiting an aftercare worker at the end of Q2 2024, 33 (14%) more than Q1 2024 (230).
- 99% (291/294) of young people < 18 years assessed as needing an aftercare worker had an aftercare worker at the end of Q2 2024.
- 87% (1,734/1,994) of 18–22-year-olds assessed as needing an aftercare worker had an aftercare worker at the end of Q2 2024.

#### 3.2.1 Referrals for an aftercare service received in the quarter



#### 3.2.4 Young adults 21-22 years (inclusive) in receipt of aftercare services

- 21% (606) of those in receipt of an aftercare service (2,915) were 21 22 years inclusive and of these 77% (465) were in education/accredited training, up from 74% at the end of Q1 2022 (table below).











# 6.1 FAMILY SUPPORT SERVICES<sup>16</sup>

#### **KEY FACTS**

- At least 437 family support providers commissioned (H1 2024), *based on data from 16/17 areas*. 84% (368) of services provided data for H1 2024.
- At least 21,333 children were in receipt of family support services at the end of H1 2024. This equates to almost 2% of children (0-17 years).
- At least 24,613 children were referred to family support services during the first six months of 2024. This equates to about 2.0% of children (0-17 years).
- 64% (15,662) of children referred to family support services during the first six months of 2024 received a service during that period. The percentage who received a service ranged from 33% (Waterford/Wexford) to 95% (Sligo/Leitrim/West Cavan). Eleven areas reported a percentage equal to or higher than the national average of 64%.

The data presented below needs to be interpreted in the context of varying response rates.

#### 6.1.1 Family Support Providers

- At least 437 family support providers commissioned (H1 2024) *based on data from 16/17 areas*.
- 84% (368) of services commissioned provided data for H1 2024. Response rates ranged from 52% (Dublin South Central) to 100% in six areas (Dublin South West/Kildare/West Wicklow Kerry, Midwest, Galway/Roscommon, Mayo and Donegal).

# 6.2 MEITHEAL

A key component of Tusla's Prevention, Partnership and Family Support (PPFS) programme of work is the roll-out of **Meitheal** - a national practice model (common approach to practice) for all agencies working with children, young people and their families. This model is designed to ensure that the needs and strengths of children and their families are effectively identified and understood and responded to in a timely way so that children and families get the help and support needed to improve children's outcomes and realise their rights. It is an early intervention response tailored to the needs of an individual child or young person and is used where more than one agency involvement is needed. There are three stages of the Meitheal process; preparation, discussion and delivery.

#### **KEY FACTS**

- 1,414 Meitheal processes requested during the first six months of 2024.
- The most common pathway for requests received during the first six months of 2024 was "Direct Access" accounting for 66% (935) of requests. "Social Work Diversion" accounted for a further 24% (345) while "Social Work Step-Down" accounted for 9.5% (134) of requests.
- 80% (1,129/1,414) of Meitheal requests received during the first six months of 2024 proceeded to Stage 2 (Discussion Stage).
- 885 Meitheal processes reached completion of Stage 2 in the first six months of 2024.
- 54% (476) of processes reaching completion of Stage 2 proceeded to delivery (Stage 3) (Meitheal Support Meeting).
- 961 Meitheal processes were closed during the first six months of 2024.
- 30% (290) of all Meitheal processes were closed following submission of a Meitheal request form (Stage 1); 27% (260) were closed following completion of the Strengths and Needs Form (Stage 2 Discussion Stage); 13% (125) were closed following commencement of Meitheal support meetings (Stage 3); 30% (286) were closed post-delivery.
- 118 Child and Family Support Networks (CFSN) operating at the end of Q2 2024 with a further nine planned/pre planning stage.

#### 6.2.1 Meitheal Activity Data

- 1,414 Meitheal processes requested during the first six months of 2024.
- Highest number of requests reported by Carlow/Kilkenny/South Tipperary (274; 19.4%) followed by Waterford/Wexford (216; 15.3%) and Cork (153; 10.8%).

- 961 Meitheal processes were closed during the first six months of 2024. The number of processes closed ranged from 201 (Carlow/Kilkenny/South Tipperary) to 14 (Dublin North).
- 30% (290) of all Meitheal processes were closed following submission of a Meitheal request form (Stage 1). The percentage closed following submission of a Meitheal request form ranged from 100% (14/14) in Dublin North to none in two areas (Dublin South East/Wicklow and Cavan/Monaghan). Eight areas reported a percentage equal to or higher than the national average of 30%.

- 27% (260) of Meitheal processes were closed following completion of the Strengths and Needs Form (Stage 2 Discussion Stage). The percentage closed following completion of the Strengths and Needs Form ranged 82% (102/124) in Cavan/Monaghan to none in two areas (Dublin North and Dublin South Central). Four areas reported a percentage equal to or higher than the national average (27%).
- 13% (125) of Meitheal processes were closed following commencement of Meitheal support meetings (Stage 3). 






