1.0 PERFORMANCE OVERVIEW

This report provides an update on the performance and activity of Tusla services at the end of Q4 2021. It is structured around key performance and activity measures included in the Agency's Business Plan. The data presented was provided by services and refers to the latest performance and activity information available at this time. **These data can change from data previously published due to the ongoing validation of data.**

The summary by service type set out below provides an overview of the Q4 2021 position regarding activity and performance.

CHILD PROTECTION AND WELFARE SERVICES

REFERRALS (based on data extracted from NCCIS on 26 January 2022)

- 18,657 referrals to Child Protection and Welfare Services during Q3 20211; 597 (3%) more than Q2 2021 (18,060) and 908 (5%) more than Q3 2020 (17,749). This brings to 53,489 the number of referrals for the first nine months of 2021, 1,262 (2%) more than the same period in 2020 (52,227). The number of referrals for 2020 / 2021 needs to be interpreted in the context of the closure of schools and other services at various times, due to the pandemic.
- 51% (9,520) of referrals for Q3 2021 were for welfare concerns, 34% (6,413) were for abuse/neglect, and the primary report type was not recorded for the remaining 15% (2,724) of referrals. Similar breakdown to Q1 and Q2 2021.
- The most common source of referrals in 2021 YTD is members of An Garda Siochána accounting for 38% (20,109) of referrals, followed to a lesser extent by social workers (11%; 5,896) and teachers (7%; 3,811). Mandated persons account for 84% (45,094) of all sources. The mandated person was not specified for 8% (4,186) of referrals.
- 52% (9,696) of referrals for Q3 2021 were closed following screening. 44% (8,244) progressed to the next stage of the referral process the preliminary enquiry stage. The remaining 4% (717) of referrals for Q3 2021 were either at the screening stage, awaiting closure following screening, or another process stage, when the data was extracted for reporting (26th Jan 2022).
- 94% (7,753) of preliminary enquiries were completed at the time the data was extracted and 14% (1,085) of completed preliminary enquiries were completed with 5 working days.
- 48% (3,685) of referrals with a completed preliminary enquiry required no further action and were closed; 28% (2,146) required an initial assessment while assessment / safety planning was ongoing in 13% (991) of cases. Some 6% (484) of referrals were closed with diversion to PPFS.
- 55% (1,170) of initial assessments required following a preliminary enquiry were completed, 15% (331) were ongoing/ awaiting sign-off while the remaining 30% (645) were awaiting commencement. 34% (403) of initial assessments completed were completed within 40 days of receipt of referral.
- 47% (552) of referrals that required an initial assessment following the preliminary enquiry were closed to social work following completion of the initial assessment. 26% (298) of referrals required safety planning following completion of the initial assessment, a further 19% (226)

required a children protection response / child protection conference and 4% (50) required admission to care

SOCIAL WORK ACTIVITY DATA

Data for Q2 2021 is not available due to the impact of the cyber-attack on Tusla systems. The data on cases open to social work is based on the time actions are completed on NCCIS, hence data for the period while the system was unavailable is not meaningful.

- 21,248 cases open1 to social work nationally at the end of Q4 2021, 92 (<1%) more than Q3 2021 (21,156) and 105 (<1%) more than Q4 2021 (21,143).
- 77% (16,441/21,248) of open cases were allocated to a named social worker at the end of Q4 2021; down one percentage points from Q3 2021 (78%).
- 4,807 (23%) cases were awaiting allocation, 212 (5%) more than Q3 2021 (4,595) and 568 (13%) more than Q4 2020 (4,239).
- 9% (436) of cases awaiting allocation at the end of Q4 2021 were categorised as high priority, eight fewer than Q3 2021 (444) and 60 (16%) more than Q4 2020 (376).
- 73% (3,526/4,807) of cases awaiting allocation at the end of Q4 2021 were three months or less and of these 53% (1,865) were waiting less than one month.
- 78% (339/436) of high priority cases awaiting allocation at the end of Q4 2021 were waiting 3 months or less and of these 72% (244) were waiting less than one month.

CHILD PROTECTION NOTIFICATION SYSTEM

- 983 children listed as 'active' on the Child Protection Notification System (CPNS) at the end of Q4 2021, 126 (15%) more than Q3 2021 (857) and the first quarterly increase after five consecutive decreases.
- 44 (5%) more children 'active' at the end of Q4 2021 than at the end of Q4 2020 (939).

The number of children listed as "active" for 2020 needs to be interpreted with caution, due to some review child protection conferences (where decisions are made to remove children listed as "active") being deferred due to Covid-19 restrictions. Guidance issued by Tusla on foot of the COVID-19 restrictions in March 2020 advised that following discussion and evaluation of safety plans, review conferences may be deferred for a maximum of 3 months.

- 83% (817) of children were listed as "active for no longer than 12 months. 5% (48) were listed as "active" for > 24 months
- All but two children listed as "active" at the end of Q4 2021 had an allocated social worker. The two children have since been allocated.

NATIONAL OUT OF HOURS SERVICE

- 852 referrals to the National Out of Hours Service in Q4 2021, bringing the number for 2021 to 2,718. The number of referrals for 2021 (2718) is up 437 (19%) on 2020 (2,281).
- 201 children were placed by the National Out of Hours Service in Q4 2021, bringing the number of children placed for 2021 to 698. The number of children placed for 2021 (698) is up 173 (33%) from 2020 (525).

ALTERNATIVE CARE SERVICES

CHILDREN IN CARE

- 5,863 children in care at the end of Q4 2021, 22 (<1%) more than Q3 2021 (5,841), first increase after six consecutive decreases. The number of children in care is down 19 (<1%) on Q4 2020 (5,882).
- 90% (5,266) of children in care were in foster care (general and relative) at the end of Q4 2021 and 8% (459) were in a residential (general and special care) placement.
- 786 (13%) children in care at the end of Q4 2021 were in placements with private providers¹; four (1%) more than Q3 2021 (782) and 57 (8%) more than Q4 2020 (729).
- 87% (5,128) of children in care at the end of December 2021 had an allocated social worker; down one percentage points from Q3 2021
- 735 children were awaiting allocation of a social worker at the end of Q4 2021; 61 (9%) more than at the end of Q3 2021 (674).

AFTERCARE

- 122 referrals in Q4 2021 bringing the number of referrals for 2021 to 523, some 137 (21%) fewer 2020 (660).
- 3,059 young persons/adults in receipt of aftercare services at the end of Q4 2021, 24 more than Q3 2021 (3,035) and 116 (4%) more than Q4 2020 (2,943). Quarter on quarter increase.
- 76% (1,788/2,339) of those 18-22 years inclusive in receipt of an aftercare service were in education/accredited training.
- 82% (2,500) of young persons/adults in receipt of aftercare services at the end of Q4 2021 had an aftercare plan, down one percentage point from Q3 2021. A total of 559 were awaiting a plan, 44 (9%) more than Q3 2021 (515).
- 94% (2,080/2,203) of those assessed as needing an aftercare worker had an aftercare worker at the end of Q4 2021, up three percentage points from Q3 2021. A total of 123 young people were awaiting an aftercare worker at the end of Q4 2021, 75 (38%) fewer than Q3 2021 (198).

ADOPTION SERVICES

- 440 new enquiries regarding information and tracing received in Q4 2021. This brings to 2,807 the number of enquiries for 2021, 1,566 (126%) more than 2020 (1,241).
- 715 applicants awaiting an information and tracing service at the end of Q4 2021, eight fewer than Q3 2021 (723). The number of applicants awaiting an information and tracing service is up 161 (29%) on Q4 2020 (554).
- At the end of Q4 2021, the length of time from application (production of ID) to the provision of personal information in line with GDPR legislation ranged from 8 weeks to 16 weeks against a target of 8 weeks, no change from Q3 2021.
- 40 receipted completed applications for adoption (all types) received during Q4 2021. This brings to 199 the number of completed applications received for 2021, 41 (26%) more than 2020 (158).
- 37 new children were referred for adoption in Q4 2021. This brings to 208 the number of children referred for adoption in 2021, 12 (6%) more than 2020 (196).
- 49 completed assessments (all types) were presented to local adoption committees during Q4 2021. This brings to 170 the number of assessments presented for 2021, 15 (10%) more than the same period in 2020 (155).

FOSTER CARERS

- 4,039 foster carers (all types minus Brussels II Regulation) on the panel of approved foster carers at the end of Q4 2021, 23 more than Q3 2021 (4,016 revised data) and four more than Q4 2020 (4,035).
- 90% (2,201) of general foster carers on the panel had an allocated link (social) worker at the end of Q4 2021, up two percentage points from Q3 2021 (88%)
- 234 general foster carers were awaiting an allocated link worker; 62 (21%) fewer than Q3 2021 (296).
- 90% (953) of relative foster carers on the panel had an allocated link (social) worker at the end of Q4 2021, no change from Q3 2021.
- 109 relative foster carers on the panel were awaiting an allocated link worker at the end of Q4 2021; three more than Q3 2021 (106).
- 246 relative foster carers unapproved at the end of Q4 2021; 18 more than Q3 2021 (228).
- All of the 191 foster carers who had a child placed with them for >12 weeks, had an allocated link (social) worker at the end of Q4 2021.

CHILDREN'S SERVICES REGULATION

EARLY YEARS INSPECTORATE

- 4,133 early years services (EYS) on the register nationally at the end of Q4 2021, seven fewer than Q3 2021 (4,140) and 77 (2%) fewer than Q4 2020 (4,210).
- 682 inspections (all types1) carried out in Q4 2021. This brings to 2,504 the number of inspections for 2021; a total of 1,812 inspections carried out in 2020. Inspections from March 2020 to early 2021 impacted due to Covid-19 restrictions.
- 1,463 incidents notified to the Inspectorate in Q4 2021. This brings to 2,894 the number of incidents notified in 2021. A total of 774 incidents notified during in 2020.
- 73 unsolicited information submissions1 received by the Inspectorate during Q4 2021. This brings to 268 the number received for 2021. A total of 253 submissions received in 2020.
- 19 services were found to have closed in Q4 2021, bringing to 141 the number of services found to be closed in 2021. A total of 197 services were found to have closed in 2020.

NON-STATUTORY ALTERNATIVE CARE SERVICES

- 144 non-statutory residential centres at the end Q4 2021; two fewer than Q3 2021 (146)
- A total of 36 inspections (all types) were conducted in Q4 2021. This beings to 165 the number of inspections for 2021, 53 (47%) more than 2020 (112).
- 6 non-statutory foster care services at the end Q4 2021; no change from Q3 2021.
- 3 services were visited during Q4 2021, and three monitoring visits was conducted during the same period. This brings to seven the number of services that were visited and seven the number of monitoring visits made.

ALTERNATIVE EDUCATION ASSESSMENT AND REGISTRATION

Home Education

- 1,808 children on the register for home education at the end of Q4 2021; 15 more than Q3 2021 (1,793) and 160 (10%) more than Q4 2020 (1,648).
- 490 applications1 received for home education during Q4 2021, 34 (7%) more than Q3 2021 (456). This brings to 1,546 the number for 2021, some 377 (20%) fewer than 2020 (1,923). The sharp increase in applications since the early part of 2020 has been linked to the Covid-19 pandemic with more parents/guardians opting to home educate their children.
- 88 assessments (all types) for home education carried out in Q4 2021, 24(38%) more than Q3 2021 (64). This brings to 459 the number of assessments carried out for 2021, 219 (32%) fewer than 2020 (678).
- 61 children registered for home education1 in Q4 2021. This brings to 387 the number of children registered 2021, 50 (15%) more than 2020 (337).
- 1,922 children on a waiting list for assessment at the end of Q4 2021, 86 (5%) more than Q3 2021 (1,836) and the sixth consecutive increase.

Independent Schools

- 56 assessed independent schools on the register at the end of Q4 2021, up six from Q3 2021 (50).
- 5,947 children in assessed independent schools at the end of Q4 2021 with 4,462 of these children on the register.
- 34 schools due for review assessment (\geq 3-year cycle) at the end of Q4 2021.

TUSLA EDUCATION SUPPORT SERVICES

Educational Welfare: Academic Year September 2021 – August 2022

Data presented needs to be interpreted in the context of the impact of Covid-19 on school attendance and service provided.

- 1,814 referrals1 screened by senior educational welfare officers (EWO) for the four months Sept
 Dec 2021, 461 (20%) fewer than the same period in 2020 (2,275).
- 1,910 screened referrals on a waiting list at the end of December 2021, 234 (14%) more than December 2020 (1,676).
- 1,112 new individual children worked with for the four months Sept Dec 2021, 147 (12%) fewer than the same period in 2020 (1,259).
- 172 school attendance notices (SANs) issued for the four months Sept Dec 2021, 137 (391%) more than the same period in 2020 (35). The SANs issued were in respect of 114 individual children, 92 (418%) more than the same period in 2020 (22).
- 12 summonses issued for the four months Sept Dec 2021. None issued during the same period in 2020. The summonses pertained to seven individual children.
- 44 Section 241 meetings convened by EWOs for the four months Sept Dec 2021, 3 (6%) fewer than the same period in 2020 (47).

PREVENTION, PARTNERSHIP & FAMILY SUPPORT

Family Support Services (data reported bi-annually, Q2 and Q4)

Family Support Services includes those services funded through a Service Arrangement with the Agency and those funded internally and delivered through the Agency. Data needs to be interpreted in the context of varying response rates.

- At least 17,075 children were in receipt of family support services at the end Q4 2021 (based on 80% response rate).
- At least 16,291 children referred to family support services during the last six months of 2021, bringing the total number of children referred to at least 32,473. This equates to about 2.7% of the child population (0-17 years).
- 69% (11,270) of children referred to family support services in the last six months of 2021 received a service while 73% (23,807) of all children referred in 2021 received a service. The percentage who received a service in 2021 ranged from 53% (Midlands) to 99% (Mayo). Seven areas reported a percentage equal to or higher than the national average of 73%.

Meitheal (data reported bi-annually, Q2 and Q4)

- 1,131 Meitheal processes requested in the last six months of 2021 bringing the total number of Meitheal processes requested for 2021 to at least 2,373. The number of requests is up 86 on the 2,287 reported in 2020.
- The most common pathway for requests is "Direct Access" accounting for 67% (759/1,131) of all requests for the last six months of 2021 and 67% (1,584/2,373) of all requests for 2021. "Social Work Diversion" accounted for a further 18% (199) of requests for the last six months of 2021 and 21% (488/2,373) of all requests for 2021. "Social Work Step-Down" accounted for the remaining 15% (173) of all requests for the last six months of 2021 and 13% (301/2,373) of all requests for 2021.
- 82% (932/1,131) of Meitheal requests received in the last six months of 2021 proceeded to Stage 2 (Discussion Stage) while 86% (2,041/2,373) of all requests received in 2021 proceeded to Stage 2 (Discussion Stage).
- 742 Meitheal processes reached completion of Stage 2 in the last six months of 2021, bringing the total number of Meitheal processes reaching completion of Stage 2 in 2021 to 1,596.
- 46% (741) of processes reaching completion of Stage 2 in 2021, proceeded to delivery (Stage 3) (Meitheal Support Meeting).
- 828 Meitheal processes were closed in the last six months of 2021 bringing the total number of Meitheal processes closed in 2021 to 1,580. 24% (386) of Meitheal processes were closed following submission of a Meitheal request form (Stage 1); 39% (617) of Meitheal processes were closed following completion of the Strengths and Needs Form (Stage 2 Discussion Stage); 11% (171) of Meitheal processes were closed following commencement of Meitheal support meetings (Stage 3); 26% (406) of Meitheal processes were closed post-delivery
- 122 Child and Family Support Networks1 (CFSN) operating at the end of Q4 2021. A further 15 CFSNs are planned/pre planning stage.

HUMAN RESOURCES

- 4,579 whole time equivalent (WTE) staff (excluding agency staff) employed by Tusla at the end of Q4 2021, 63 (1%) more than Q3 2021 (4,516) and 18.45 (<1%) fewer than Q4 2020 (4,598).
- 415 new staff joined Tusla (came onto Tusla's payroll) in 2021
- 347 staff left Tusla (i.e., resigned, career breaks, excluding retirements) in 2021 and 89 staff retired in 2021
- At the end of December 2021, the overall absence rate for the Agency was 7.25%, 0.99 percentage points higher than Q3 2021 (6.26%) and 1.32 percentage points higher than December 2020 (5.93%).
- e-learning activity: 3,822 completions were achieved in Q4 2021
- Virtual classroom training: 461 completions (54 sessions).

FINANCE

- The outturn for the year to date (December 2021) is an under-spend of €10.272 million.
- Pay costs are under-spent against budget for the year to date by €7.8 million
- Non-pay costs are over-spent against budget year to date by €7.18 million
- A key area of over-spend is private residential and foster care costs at €7.78 million over budget year to date. Placement of children in private residential and foster care services is strictly controlled through a national placement process.



Number of Referrals

Referrals by Area

- The number of referrals year to date equates to about 45 referrals per 1,000 population under 18 years. The rate of referrals ranges from 26 per 1,000 (Dublin South East/Wicklow) to 78 per 1,000 (Dublin North City). Eight areas reported a rate equal to or higher than the national average of 45/1,000.
- The areas reporting the highest numbers of referrals year to date include Midlands (5,338), Dublin North (5,137), Dublin South West/Kildare/West Wicklow (4,890) and Cork (4,723). The fewest number was reported by Sligo/Leitrim/West Cavan (1,004) followed by Mayo (1,102) and Kerry (1,580). A breakdown of referrals by area and quarter is presented in Table 3 below.

Source of Referrals

• The most common source of referrals in 2021 YTD is members of An Garda Síochána accounting for 38% (20,109) of referrals, followed to a lesser extent by social workers (11%; 5,896) and teachers (7%; 3,811). - 52% (9,696) of referrals for Q3 2021 were closed following screening.
- 44% (8,244) of referrals for Q3 2021 progressed to the next stage of the referral process the preliminary enquiry stage. The remaining 4% (717) of referrals for Q3 2021 were either at the screening stage, awaiting closure following screening, or another process stage, when the data was extracted for reporting (26th Jan 2022).





- The number of open of cases ranged from 2,448 (12%) in Dublin North to 317 (1%) in Sligo/Leitrim/West Cavan. Eight of the 17 areas had between 1,000 and 2,000 cases; seven areas had fewer than 1,000 cases while the remaining two areas (Dublin North and Cork) had in excess of 2,000 cases.
- 8 areas reported a decrease in open cases from Q3 2021. The largest decrease was reported by Dublin South Central (down 199) followed by Galway/Roscommon (down 139), Kerry (down 75) and Louth/Meath (down 66).
- Of the nine areas that reported an increase, the largest increase was reported by Mayo (up 175) followed by Dublin South East/Wicklow (up 153), Dublin North (up 115), Waterford/Wexford (up 83) and Dublin South West/Kildare/West Wicklow (up 80).




Number of open cases by area

2.2.2 Open Cases Allocated / Awaiting Allocation

- 77% (16,441/21,248) of open cases were allocated to a named social worker at the end of Q4 2021; down one percentage points from Q3 2021 (78%).
- 4,807 (23%) cases were awaiting allocation, 212 (5%) more than Q3 2021 (4,595) and 568 (13%) more than Q4 2020 (4,239).
- 62% (2,985) of cases awaiting allocation at the end of Q4 2021 were "active" on a duty system³.

³ A case awaiting allocation may be "active" on a "duty" system. This means that there are actions being undertaken by a dedicated duty team or rotating social workers on a duty roster to progress the protection and welfare of the child. Examples of actions being undertaken include telephone calls relating to the concern, visits to see children, completing initial assessments and child in care reviews or care plans. The actions undertaken must have occurred within the monthly MTP reporting period. There must be evidence of actions


Cases allocated/awaiting allocation



- Waterford/Wexford reported the highest number of cases awaiting allocation (598; 12%) followed by Dublin South West/Kildare/West Wicklow (543; 11%), Louth/Meath (494; 10%), Dublin South Central (493; 10%), Dublin South East/Wicklow (486; 10%) and Cork (471; 10%). These six areas account for 64% (3,085) of cases awaiting allocation.



2.2.3 Cases Awaiting Allocation by Priority Level

- 9% (436) of cases awaiting allocation at the end of Q4 2021 were categorised as high priority, eight fewer than Q3 2021 (444) and 60 (16%) more than Q4 2020 (376).
- 53% (2,546) of cases awaiting allocation were categorised at medium priority while the remaining 38% (1,825) were low priority.



Guidance issued by Tusla on foot of the COVID-19 restrictions in March 2020 advised that following discussion and evaluation of safety plans, review conferences may be deferred for a maximum of 3 months.

- 83% (817) of children were listed as "active for no longer than 12 months. 5% (48) were listed as "active" for > 24 months

- The number listed as "active" equates to about 8.3 children per 10,000 under 18 years and ranges from 3.8/10,000 in Sligo/Leitrim/West Cavan to 18.5/10,000 in Dublin North City, more than double the national average.
- Cork reported the highest number (96) of children "active", followed by Dublin North City (83), Midwest (83), Midlands (81) and Dublin North (80). Sligo/Leitrim/West/Cavan reported the fewest number (9) followed by Mayo (29) and Kerry (29).



Number of children listed as "active" by area, by quarter





- 786 (13%) children in care at the end of Q4 2021 were in placements with private providers¹; four (1%) more than Q3 2021 (782) and 57 (8%) more than Q4 2020 (729).
- 87% (5,128) of children in care at the end of December 2021 had an allocated social worker; down one percentage points from Q3 2021
- 735 children were awaiting allocation of a social worker at the end of Q4 2021; 61 (9%) more than at the end of Q3 2021 (674).

- Across the 17 areas the number of children in care ranged from 751 in Cork to 109 in Sligo/Leitrim/West Cavan.
- Dublin North City reported the highest rate of children in care per 1,000 population under 18 years (10.3/1,000), more than double the national rate, followed by Waterford/Wexford (6.0/1,000), MidWest (5.7/1,000), Cork (5.6/1,000) and Dublin South Central (5.6/1,000) while Dublin South East/Wicklow reported the lowest rate at 2.4/1,000 population followed by Dublin North (3.5/1,000).





3.2 AFTERCARE

KEY FACTS

- 122 referrals in Q4 2021 bringing the number of referrals for 2021 to 523, some 137 (21%) fewer 2020 (660).
- 3,059 young persons/adults in receipt of aftercare services at the end of Q4 2021, 24 more than Q3 2021 (3,035) and 116 (4%) more than Q4 2020 (2,943). Quarter on quarter increase.
- 76% (1,788/2,339) of those 18-22 years inclusive in receipt of an aftercare service were in education/accredited training.
- 82% (2,500) of young persons/adults in receipt of aftercare services at the end of Q4 2021 had an aftercare plan, down one percentage point from Q3 2021. A total of 559 were awaiting a plan, 44 (9%) more than Q3 2021 (515).
- 94% (2,080/2,203) of those assessed as needing an aftercare worker had an aftercare worker at the end of Q4 2021, up three percentage points from Q3 2021. A total of 123 young people were awaiting an aftercare worker at the end of Q4 2021, 75 (38%) fewer than Q3 2021 (198).



3.2.7 Young Persons / Adults in receipt of aftercare services with an Aftercare Worker

















6.2 MEITHEAL

A key component of Tusla's Prevention, Partnership and Family Support (PPFS) programme of work is the roll-out of **Meitheal** - a national practice model (common approach to practice) for all agencies working with children, young people and their families. This model is designed to ensure that the needs and strengths of children and their families are effectively identified and understood and responded to in a timely way so that children and families get the help and support needed to improve children's outcomes and realise their rights. It is an early intervention response tailored to the needs of an individual child or young person and is used where more than one agency involvement is needed. There are three stages of the Meitheal process; preparation, discussion and delivery.

KEY FACTS

- 1,131 Meitheal processes requested in the last six months of 2021 bringing the total number of Meitheal processes requested for 2021 to at least 2,373. The number of requests is up 86 on the 2,287 reported in 2020.
- The most common pathway for requests is "Direct Access" accounting for 67% (759/1,131) of all requests for the last six months of 2021 and 67% (1,584/2,373) of all requests for 2021. "Social Work Diversion" accounted for a further 18% (199) of requests for the last six months of 2021 and 21% (488/2,373) of all requests for 2021. "Social Work Step-Down" accounted for the remaining 15% (173) of all requests for the last six months of 2021 and 13% (301/2,373) of all requests for 2021.
- 82% (932/1,131) of Meitheal requests received in the last six months of 2021 proceeded to Stage 2 (Discussion Stage) while 86% (2,041/2,373) of all requests received in 2021 proceeded to Stage 2 (Discussion Stage).
- 742 Meitheal processes reached completion of Stage 2 in the last six months of 2021, bringing the total number of Meitheal processes reaching completion of Stage 2 in 2021 to 1,596.









7.4 Workforce Learning and Development (WLD)

- Training activity during this period continued to be impacted by COVID19 restrictions

Other Developments in Q4 2021

- Development of online and virtual learning continued albeit with major challenges due to loss of network access.

- An informational video was also developed on Tusla's response to Violence, Harassment and Aggression (VHA) and launched in December 2021, to support the agency's VHA strategy.
