

### **Request Form for Notified Parents or Legal Guardians**

Please complete this form if you are a parent or legal guardian who has received a letter from Tusla about the cyberattack on the HSE in May 2021, and would like to request copies of the personal information that was accessed.

### What you need to do:

- 1) Please complete the attached form (in BLOCK LETTERS).
- 2) Please attach a **photocopy** of your valid, in date photo ID, such as passport, driving licence or public services card.
- 3) Please attach **photocopies** of your legal guardianship documents that establish your relationship to the affected minor.

The legal documents required that apply to your type of guardianship of the minor affected are as follows:

- 1. If you are the Birth Mother, please attach copies of:
- the child's birth certificate

OR

- a court order appointing you as the child's guardian.
- 2. If you are the Birth Father, please attach copies of:
- the child's birth certificate (on which you are named)

#### **AND** any **one** of the following:

- o your certificate of marriage to the child's mother.
- o documentation that proves that you lived with the child's mother for a period of twelve months, with at least three months relating to after the child was born.
- $\circ\quad$  the guardianship declaration you signed with the child's mother.

OR

- a court order appointing you as the child's guardian.
- 3. If you are the Legal Guardian, please attach a copy of:
- a court order appointing you as the child's guardian.
- 4) Please post this form, completed and ensure to attach a photocopy of your ID along with photocopies of your required guardianship verification papers to the following address: **Tusla, PO BOX 13572, Naas, Co Kildare**
